## Minutes of the Sub Committee on Trades House Golf Competition

### 7<sup>th</sup> November 1905

Secretary: Robert Laing 10 Gordon Street

#### Introduction:

At the front of the minute book was found the rules of the competition of the Annual Golf Competition of the Fourteen Incorporated Trades.

The Rules read as follows:

#### Rules

- 1. The competition shall take the form of a foursome and be played on a date arranged by the Committee, and in the order of the draw.
- 2. The game shall be one of a Handicap Stroke Competition, under the local rules of whichever Course the game is played on.
- 3. All entries, with entry money of 6/- each, shall be sent in before 10<sup>th</sup> April, to the Representative of each Incorporation acting on the Committee. The Committee will provide Gold Badges for the Winning Couple and will have the name of the Incorporation inscribed on the Trophy along with the Winner's Names.
- 4. Each Entrant must state the name of the Club or Clubs of which he is a member, with the handicap he has at present therein. The handicap of each couple shall be the average of their handicaps.
- 5. Entrants who are not members or a recognised Golf Club, or are members, but have never played for handicap, shall play from scratch.
- 6. One round of the Course of 18 holes shall constitute the game, and in the event of any ties same shall be decided by playing to a finish. Each Couple must return their cards to the Secretary on the conclusion of the game, and that in the vent of only one of a Couple turning up to play in the Competition, such player must play as drawn and take his opponent's score, his own score not counting.
- 7. The Incorporation represented by the Winning Couple shall hold the Trophy for one year, and shall be responsible for its safe custody, and shall return it to the Secretary at least one week prior to the next Competition, and shall give it over for the decoration of the Annual Dinner of the Trades' House, if so, required by the Clerk of the House.
- 8. All arrangements and disputes shall be settled by the Committee, who shall have the power to alter and amend the Rules from time to time. Any alterations shall be intimated to the Trades' House for approval.

- 9. The players shall meet after the game at a time and place fixed by the Committee, when the Trophy and Badges shall be presented.
- 10. The Committee shall consist of Fourteen Representatives One appointed annually by the Master Court of each Incorporation, not later than 31<sup>st</sup> December. The Committee so appointed shall make all arrangements for the following season.
- 11. The Competition shall be limited to past and present members of the Trades' House along with the present members of the Master Courts of the various Incorporations and their Clerks, and in the event of any Incorporation having only one eligible player, the Court will have the power to draw one player from the craft as his partner, whose name will be required to be submitted to the Committee for approval.

No date has been indicated on the Rule book.

Prior to the first meeting of the Incorporations on the subject of starting a Golf Competition the following article was sent to and printed by a Glasgow Newspaper on 24<sup>th</sup> October 1905 by a member of the Incorporation of Bakers:

#### **Trades House Golf Trophy**

TO THE EDITOR.

As a golfer and a member of the Baker's Incorporation, I think the idea of a Trades' House Golf Trophy for competition among the various Incorporations is an excellent one. It would be an exceedingly good means of bringing the members of the various Incorporations together and also to bring them into contact with the head centre of the Incorporations – viz., the Trades' House. A special advantage would be that it would be bringing them together in the spring, summer, and autumn months when there is nothing else to do.

Besides it might be a means of enabling the Incorporations to recruit among the general ranks of golfers. I hope the correspondence which has taken place on the matter will receive earnest attention from those at the head of affairs.



The Deacon Convener explained that the Representatives had been asked to meet the Platform to confer with them as the practicality of instituting an annual Golf Competition amongst the Guild Brethren similar to the Annual Bowling Game, and of a Golf Trophy in connection therewith.

After some discussion it was agreed that an Annual Golf Competition should be instituted.

It was therefore resolved that for the first year, the competition should be limited to present and past members of the Trades' House, along with the present members of the Master Courts of the various Incorporations.

The following Sub Committee was appointed to draw up rules and regulations for the game and submit same to a future meeting of the Platform and representatives.

- The players shall meet after the game at a time and place fixed by the Committee, when the Trophy shall be presented and a Committee consisting of one Representative from each Incorporation appointed for the following season.

The Sub Committee also took into consideration the question of Gold Badges for the winners the point, to there being handmade or die struck was discussed and after due consideration it was decided to have them made from a die, so that in all time coming, the medals would be exactly the same. Mr Laing, being asked to get up a

design and provide the badges.

The question of scoring cards for the Competition was also brought before the meeting, and it was decided, just to use the cards in use at which ever Course the Game was played over.

#### 9<sup>th</sup> February 1906

Mr Laing called on Deacon Rome on 9<sup>th</sup> February after having seen Mr Lumsden, Clerk to the Trades' House, who had explained that Tuesday being the 1<sup>st</sup> of May was not a suitable date for the Golf Competition as most of the Collectors of the different Incorporations as also the Collector of the Trades' House would be busy on that day paying the Pensioners, after considering the matter Deacon Rome and Mr Laing agreed to alter the date for this year's competition to Tuesday 8<sup>th</sup> May, it being considered unnecessary to call a special meeting for that purpose.

Deacon Rome and Mr Laing also approved of a very neat design for the Gold Badges and ordered two dies for the making thereof. The badges to be made in 15 carat Gold at a cost of 45/- each to be made by Messr J R W Laing, 10 Gordon Street, Glasgow who agreed to pay for and hold the dies, which cost £6.

The Deacon of the Bakers was presented with the Trophy on behalf of the Incorporation by Deacon Convener Kirkwood and Gold Badges presented to Mr Ure and Mr Hamilton.

Ex Convener Goldie proposed a vote of thanks to the Committee. Mr Laing replied.

An interesting day having been spent the company returned to the City about 6.30p.m.

Mr Laing was again appointed Hon. Secretary on the motion of Mr Wm. McLeod Jardine.

On the Motion of Mr John Henderson it was agreed as follows, subject to approval of the Trades' House.

"In the event of any Incorporation only having one player, the Court will have power, to draw one player from the Craft as his partner, whose name will require to be submitted to the Sub Committee for approval. (Approved by the Trades' House 1907)

A letter was read from the Clerk of the Trades' House, suggesting an amendment to the rules as follows.

"Any alterations so made shall be intimated to the Trades' House for approval." This was agreed to.

It was remitted to Mr Younger to make enquiry to our letting the links of the Prestwick Golf Club for this year's Competition.

This being all, a vote of thanks to the Convener concluded the meeting.

The Convener and Secretary arranged the handicaps and made the final arrangements for the Competition.

#### 8th May 1907

The Trades' House Golf Competition took place yesterday 7<sup>th</sup> May at Prestwick (St. Nickolas) for the silver shield presented by the Platform of the Trades' House for annual Competition amongst the 14 Incorporations. On this occasion we had three prizes one of which was kindly presented by Deacon Convener Kirkwood.

On the game being played off the winners were again found to be the Incorporation of Bakers. Messrs W Beattie and G L Hamilton with a score of 97 - 15 - 82.

Second prize Messrs McNair and Paterson (Weavers) 101 – 18 – 83.

Third Prize (after a tie)

Messrs W McLeod Jardine and R Scott (Gardeners) 100 – 16 – 84.

Ex Deacon Hamilton accepted at the hands of the Deacon Convener custody of the trophy, Deacon Hamilton suitably replied.

The Deacon Convener also presented the second and third prizes and on behalf of the prize winners Deacon McLeod Jardine spoke appropriate terms.

Mr McNair moved a vote of thanks for the Deacon Convener for presiding and for his kindness in presenting one of the prizes.

#### 8<sup>th</sup> February 1908

On the 8<sup>th</sup> February I received a letter in reply to my application, granting me the privilege of the course and Club House at Bogside on Tuesday 28<sup>th</sup> April on condition that members of the Club have precedence in starting before our competitors and also an entrance fee of 5/- for the party be paid, also that a full list of names and addresses of the competitors and guests be sent and to come before the Committee of the Irvine Golf Club for admission as temporary members for the day.

The Sub Committee having approved Mr Jardine and Mr Laing met and arranged the draw. The Sub Committee, being of opinion that previous winners of the Trophy, should have their handicaps reduced by 2 and those members who have won a second prize, reduced by 1.

This was accordingly done in the Handicapping for this year, and Secretary instructed to have the necessary arrangements made with the Railway Company and the draw printed as formerly.

#### 29th April 1908
