1. GEORGE BUCHANAN, maltman, Glasgow, son to umqll.
George Buchanan, maltman, late Bailie and Deacon
Convener.

Elder brother of Andrew B. (19), Neil B. (11), and Archibald B. (12). Father of Andrew B. (180), John B. (161), and George B. (183). First Preses of the Society, 1725, and again Preses in 1730, and 1749, 1750. Director, 1726, 1727, 1730, 1731, 1732, 1733, 1734, 1735, 1736, 1737, 1738, 1739, [probably 1740, 1741, 1742, 1743,] 1744, 1745, [1746,] 1747, 1748, 1751, 1752, 1755, [1756,] 1757, 1758, 1759, 1762, 1763. Extraordinary director, 1764. Born, June 3, 1686 ; married, first, June 2, 1720 (*Glasgow Marriages*), Christian Mitchell, daughter of Bailie Patrick Mitchell, maltster (*Services of Heirs*, Jan. 24, 1735), who died in March, 1729, and was buried on the 18th (*Glasgow Rec. of Mortality*) ; married, secondly, April 26, 1733, Margaret Zuill (*Glasgow Marriages*), who died in October, 1733, and was buried on the 29th (*Glasgow Record of Mortality*) ; married, thirdly, Cecil Forbes, August 29, 1736 (*Glasgow Marriages*) ; died, Sept. 12, 1773 (*Scots Mag.* vol. 35, p. 501). Member of the Maltmen Craft, August 22, 1707 ; Visitor of the Maltmen, 1719, 1720 ; Treasurer of the City, 1726 ; Bailie of Gorbals, 1727 ; Bailie, 1732, 1735, 1738. Designated "Senior" in Minute Book, 1751. See Buchanan of Auchmar's *Essay*, 1723, p. 103 ; *The Old Country Houses of the Old Glasgow Gentry*, 1878, p. 186 ; *Glasgow Past and Present*, 1884, vol. i. p. 114, vol. ii. p. 446 ; *Strathendrick*, p. 305 ; and Burke's *Landed Gentry*.

1725. (I. 2.)

2. PATRICK BUCHANAN, merchant, Glasgow, son to umqll.
John Buchanan of Easter Ballat.

Uncle of John B. (10). Second Preses of the Society, 1726. Director, 1725, 1726, 1727, 1728, 1731. Fourth son of John Buchanan of Easter Ballat, merchant in Glasgow, by Agnes Buchanan. Born, probably, April 4, 1677 (see *Drymen Baptisms*); married, November 25, 1700, Beatrix Smith (*Glasgow Marriages*); died, Jan. 21, 1732 (*Glas. Com. Rec. Tests.* vol. 51, fol. 88), and was buried in the New (or Blackfriars') Churchyard on the 25th (*Glasgow Rec. of Mortality*). Had a half share in the "Hatt factory" in Glasgow. Admitted Burgess and Gild Brother, Feb. 17, 1701. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 90.

3. ARCHIBALD BUCHANAN of Drumhead, younger, merchant.

Elder brother of James B. (34); brother-in-law of Robert B. (29), Gilbert B. (53) and William B. (54); father of Archibald B. (164). Preses, 1727. Director, 1725, 1726, 1727, 1728, 1729. Baptized, Oct. 22, 1692; married, April 28, 1720, Janet, daughter of Gilbert Buchanan of Bankell (37); died, Nov. 24, 1744. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 73; and *Strathendrick*, p. 328.

4. WALTER BUCHANAN, maltman, Glasgow, son to umqll.
Walter Buchanan, Deacon of the Baxters.

Brother of Thomas B. (26). Father of Walter B. (124), and grandfather of Walter B. (284) and Andrew B. (276). First Treasurer of the Society, 1725. Preses,

1734. Director, 1727, 1728, 1734, 1735, 1736, 1737, 1738, 1739, [probably 1740-1743,] 1744, 1745, 1746, 1747, 1748. Born about 1683 (see *Trades' House*, p. 254); married, first, April 14, 1704, Janet Buntine (*Glasgow Marriages*), eldest daughter of George Buntine by Grizel Anderson (*Glasgow Burgh Sasines*, July 11, 1719), who died in March, 1725, and was buried on the 5th (*Glasgow Rec. of Mortality*); married, secondly, about 1727, Sara Gilhagie, who died in June, 1734, and was buried on the 15th (*Glasgow Rec. of Mortality*); married, thirdly, January 16, 1735, Margaret Gilhagie (*Glasgow Marriages*), youngest daughter of William Gilhagie of Easter Craigs (*Merchants' House*, pp. 527, 528), who died in September, 1776, at Duntreathhill, Strathblane. Testament dative recorded, October 24, 1776; the executrix dative *qua* nearest in kin being her sister-german, Jean Gilhagie, relict of George Bogle, merchant in Glasgow (*Glasgow Com. Rec. Tests.* vol. 67, p. 303). By his first marriage he had only one surviving son, Walter Buchanan (124), writer in Glasgow (*Glasgow Burgh Sasines*, Aug. 7, 1741). Janet Buchanan, his daughter, who was enrolled a pensioner of the Society, February 24, 1767, was probably also by this marriage. Andrew Buchanan, the father of Walter Buchanan (284) and Andrew Buchanan (276), was probably a son of the second marriage. He died in June, 1758, and was buried on the 12th (*Glasgow Record of Mortality*). His will, dated May 26, 1758, was recorded in the *Glasgow Commissariat*, July 27, 1759 (vol. 60, p. 368), George Buchanan, youngest, merchant in Glasgow, being nominated executor, whom failing, the latter's spouse, Margaret Buchanan. Admitted Burgess and Gild Brother as second lawful son to Walter Buchanan, Burgess and Gild Brother, May 28, 1702. Admitted a member of the Incorporation of Maltmen, May 29, 1702. Subscribed to Auchmar's book, 1723. Was "of Meadow Park" about 1738 (*Merchants' House*, p. 529). See Auchmar, 1723, p. 111; and *Strathendrick*, p. 297. [His age as given in the *Record of Mortality* is 68, but this must be an error for 75.]

5. JOHN BUCHANAN, younger, merchant in Saltmarket, Glasgow, alias Tarbet.

Brother of James B. of Torrie (49). Second Treasurer of the Society, 1726. Preses, 1728. Director, 1725, 1727, 1728, 1729, 1730. Son of William Buchanan of Glens. Married Isobel Miller, March 13, 1706 (*Glasgow Marriages*), who died in June, 1736, and was buried in the N.W. Churchyard on the 12th (*Glasgow Rec. of Mortality*). Subscribed to Auchmar's book, 1723. Died in July, 1731, and was buried in the N.W. Churchyard on the 27th (*Glas. Rec. of Mortality*). His testament dative was recorded, August 26, 1731 (*Glas. Com. Rec. Tests.* vol. 50, p. 647). His third son, George, was apprenticed by the Society to a bookbinder in 1732. See Auchmar, p. 115.

1725. (I. 2.)

6. JOHN BUCHANAN of Auchineven.

Father of John Buchanan (197). Preses, 1729. Treasurer, 1727. Director, 1725, 1726, 1728, 1729, 1730, 1731. Born about 1687; married, January 22, 1723, Catherine Graham (*Killearn Marriages*), daughter of John Graham of Killearn; died in May, 1757, and was buried on the 14th in the N.W. Churchyard (*Glasgow Rec. of Mortality*). Subscribed to Auchmar's book, 1723. A sister, Jean Buchanan, was enrolled a pensioner in 1764. She was born about 1690, and died in November, 1765, being buried in the High Churchyard on the 23rd (*Glasgow Rec. of Mortality*). His daughter, Margaret Buchanan, succeeded her brother, and was the last of the family. She died, January 10, 1792 (*Scots Magazine*, vol. 54, p. 50). See Auchmar, 1723, p. 111; and *Strathendrick*, p. 298.

7. JOHN BUCHANAN, maltman, Glasgow, son to umqll.
John Buchanan of Garnstarry.

Father of John B. (234). - Boxmaster, 1725, 1726. Director, 1727, 1733. Member of the Incorporation of Maltmen, Oct. 9, 1711. Married Agnes Mushett, who died in January, 1738, and was buried on the 21st (*Glas. Rec. of Mortality*). He died between March 9 and Nov. 17, 1749. See Auchmar, 1723, p. 62 ; and *Strathendrick*, p. 367.

8. THOMAS BUCHANAN, maltman, Glasgow, son to umqll.
Alexander Buchanan of Gartaharn.

Father of George B. (148). Uncle of Thomas B. (188). Probably brother of Andrew B. (17). Boxmaster, 1725, 1726, 1731, 1732. Member of the Incorporation of Maltmen, November 12, 1714. His wife was probably Jane Brown. He died in September, 1740, and was buried on the 29th (*Glasgow Rec. of Mortality*). See Auchmar, p. 103 ; *Strathendrick*, p. 304.

1725. (I. 2.)

9. JOHN BUCHANAN of Catter, W.S., Edinburgh.

Eldest son of James B. (95). Brother of Archibald B. (72) and George B. (122). Father of James B. (189), Duncan B. (248), and Robert B. (206). An Extraordinary Director, 1728, 1729, 1730. Commissioned to collect funds for the proposed Buchanans' Hall, 1737. Born, probably, about 1679 ; married, first, January 31, 1722, Anne Paterson, second daughter of Andrew Paterson of Kirktown, who died, November 9, 1722 ; secondly, December 26, 1723, Mary Campbell, second daughter of Ronald Campbell of Balerno, W.S., who died, September 29, 1727 ; thirdly, August 24, 1730, Janet Campbell, only

child of Duncan Campbell, Bailie of Edinburgh, who died, June 1, 1784 (*Glasgow Mercury*, June 17, 1784). Died before December 23, 1761. Admitted notary, July 5, 1701. Member of the Society of Writers to the Signet, December 13, 1723. Solicitor to the Board of Customs. Was of Mollanhead (now Parkhall, part of the lands of Boquhan), 1727-1733 (*Strathendrick*, p. 226). Succeeded his father in Middle Catter in, or before, 1734. Is designated "John Buchanan of Middleton W.S." in 1741 (*Stirlingshire Sasines*, vol. xix. fol. 120). Was probably the John Buchanan, junior, writer in Edinburgh, who subscribed to Auchmar's book in 1723. See *Genealogical Magazine*, vol. ii. pp. 358, 500.

1725. (I. 2.)

10. JOHN BUCHANAN of Easter Ballat, merchant.

Nephew of Patrick B. (2). Treasurer, 1728. Director, 1725, 1726, 1730, 1731. See Auchmar, 1723, p. 90. Was served heir to his father, William Buchanan, of Easter Ballat, June 25, 1708 (*Services of Heirs*). Sold his lands to Andrew Buchanan, elder, merchant tailor in Glasgow (No. 45).

11. NEIL BUCHANAN, merchant, Glasgow.

Afterwards merchant in London. Father of George B. (194). Brother of George B. (1), Andrew B. (19), and Archibald B. (12). He was the third of the four brothers as in "Auchmar," though the pedigrees in Burke and elsewhere make him the youngest. Director, 1728. Baptized, May 3, 1698 (*Glasgow Baptisms*); married (contract dated Nov. 5), 1719, Anna Rae, daughter of George Rae, merchant in Glasgow; died, February 13, 1744 (*Scots Magazine*, vol. vi. p. 98). Anna Rae, his relict, died April 19, 1779 (*Scots Mag.* vol. 41, p. 221). M.P. for the Glasgow Burghs, 1741-1744. Was "of Hillington." Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 103; *Strathendrick*, p. 306.

1725. (I. 2.)

12. ARCHIBALD BUCHANAN, merchant, Glasgow.

Father of Peter B. (238), George B. (203), and Andrew B. (204). Brother of George B. (1), Andrew B. (19), and Neil B. (11). Was the youngest of the four brothers. Treasurer, 1729. Director, 1728, 1730 (described as "Merchant above Cross"). Baptized, July 20, 1701 (*Glasgow Baptisms*); married, Dec. 5, 1728, Martha Murdoch, daughter of Provost Peter Murdoch (born, February 21, 1702; died, October, 1764); died, March 13, 1761 (*Glasgow Journal*, March 19, 1761), [March 12, 1761 (*Merchants' House*, p. 587)]. "An eminent merchant of this place who with a feir character acquired a plentiful estate which he has left to his family" (*Glasgow Journal*). Bailie, 1736, 1739. Was of Auchentorlie and Hillington. See Auchmar, 1723, p. 103; and *Strathendrick*, p. 305.

1725. (I. 2.)

13. JOHN BUCHANAN, elder, merchant, Glasgow.

Father of Robert B. (127). Probably elder brother of Walter B. (4), and Thomas B. (26); and brother-in-law of Robert B. (29), whose sister was his wife. If he was identical with the eldest son of Walter Buchanan, baxter, he was admitted Burgess and Gild Brother, Dec. 11, 1719 (*Act Book, Dean of Guild Court*). Evidently the same as Campsie John, who married, probably, June 5, 1705 (*Glasgow Marriages*), Margaret Buchanan (born about 1691, died in March, 1761, and was buried in the Blackfriars' Churchyard on the 13th); died in November, 1741, and was buried in the Blackfriars' on the 30th (*Glasgow Rec. of Mortality*). His testament dative was recorded, Nov. 28, 1752, Robert Buchanan, merchant in Glasgow, his son, executor dative, given nearest in kin (*Glas. Com. Rec. Tests.* vol. 58, p. 514). Besides Robert Buchanan of Blantyre Park he had another son, William Buchanan, merchant in Glasgow, who succeeded his brother in Blantyre Park, and two daughters, Jane Buchanan and

Margaret Buchanan, wife of Dugald Buchanan of Craigievairn. Merchant in Bell's Wynd. Acquired one-half of the 40s. lands of Blantyre Park in 1724, and one-half the 40s. lands of Little Udston, 1725 (*Lanarkshire Sasines*, vol. xiii. pt. 2, fol. 278, 390). See Auchmar, 1723, pp. 54, 111; *Strathendrick*, p. 297.

1725. (I. 2.)

14. WILLIAM BUCHANAN, maltman, Glasgow.

"Maltman" possibly an error for "merchant." There was a William Buchanan admitted a member of the Incorporation of Maltmen, August 19, 1696, and another, May 28, 1703, but they died in 1717 and 1718, and the above William is described on April 15, 1725—a few days after his admission—and always thereafter as "merchant," and in 1731 as "Elder, merchant." Director, 1725, 1731. Probably brother of Gilbert Buchanan of Bankell (37), and father of Gilbert B. (57), and William B. (89). William Buchanan [merchant in Glasgow], married, June 24, 1686, Janet Allan (*Glasgow Marriages*), who died, July, 1690, her testament dative being recorded, September 10, 1691, her husband executor dative, and Robert Buchanan, maltman in Glasgow, his brother-german, cautioner for him (*Glas. Com. Rec. Tests.* vol. 45). William Buchanan, merchant in Glasgow, married, about 1696, Janet Colquhoun, and their eldest son was Gilbert Buchanan, merchant in Glasgow (*Glas. Com. Rec. Tests.* Feb. 25, 1738). He had also a daughter Elizabeth, by Janet Colquhoun, who married Robert Donaldson; contract dated April 23, 1733 (*Glasgow Com. Rec. Tests.* vol. 53, p. 32). William Buchanan was a calenderer in Blackfriars' Wynd. William Buchanan, merchant, died in May, 1738, and was buried on the 23rd (*Glasgow Rec. of Mortality*). His testament dative was recorded, November 17, 1738, Janet Colquhoun, his relict, being appointed executrix dative (*Glas. Com. Rec. Tests.* vol. 53, p. 179). See Auchmar, 1723, p. 105; *Strathendrick*, p. 306.

1725. (I. 4.)

15. PATRICK BUCHANAN, gunsmith, Glasgow.

Father of John B. (132) and Colin B. (191). Boxmaster, 1726, 1727. Director, 1733, 1736. Was enrolled as a pensioner, August 18, 1758 (see *Minute Book*, vol. i. p. 113). Born about 1685 (*Regality of Glasgow, Act Book*, No. 2, July 6, 1741). Died in June, 1759, and was buried on the 6th (*Glas. Rec. of Mortality*), his age being recorded as 78 (that is, born about 1681). Usually designated "Peter" in the Society's books. Admitted Burgess and Gild Brother by Act, September 25, 1717.

16. GEORGE BUCHANAN, barber.

Boxmaster, 1732, 1733. Enrolled as a pensioner, 1761. Married, June 4, 1716, Margaret Dougald (*Glasgow Marriages*), who died in October, 1744, and was buried in the N.W. Churchyard on the 29th (*Glasgow Rec. of Mortality*). Admitted Burgess and Gild Brother, February 25, 1720. Deacon of the Barbers, 1726, 1727. He had a sister, Catherine, who had a grant from the Society in 1757.

17. ANDREW BUCHANAN, younger, tailor.

Brother of Thomas B. (8). Boxmaster, 1729, 1730. Director, 1733, 1734. Treasurer, 1735. "Andrew Buchanan, junior, merchant taylor in Glasgow," married Liliass Russell, and died in May, 1741 (*Glasgow Com. Rec. Tests*, vol. 53, p. 632, and vol. 55, p. 411). Described as "widow of Andrew Buchanan, junior, tailor, alias Gartocharn." Liliass Russell had grants from the Society, on various occasions, 1754 to 1762. A daughter, Isabell, had a grant in 1762. See Auchmar, 1723, p. 103; *Strathendrick*, p. 304.

1725. (I. 6.)

18. JOHN BUCHANAN, writer, Edinburgh.

Father of William B. Born, probably, 1665-1667; married, February 13, 1726, Jean, daughter of deceased John Cuninghame, W.S. (*Edinburgh Marriages*), who survived her husband, and died at Edinburgh, April 13, 1769 (*Scots Magazine*, vol. 31, p. 279); died, June 15, 1750 (*Glasgow Com. Rec. Tests*, vol. 59, p. 500). Admitted notary, April 11, 1688. Succeeded to Nether Gartincaber, 1719. Bought Craigievairn, 1741. Described as John Buchanan, senior, writer in Edinburgh. He was a subscriber to Auchmar's book in 1723. See Auchmar, 1723, p. 78; *Strathendrick*, p. 318.

1725. (I. 6.)

19. ANDREW BUCHANAN, merchant, Glasgow.

Father of James B. (190), and George B. (170). Brother of George B. (1), Neil B. (11), and Archibald B. (12). Director, 1726, 1728, 1729. Baptized, January 29, 1691 (*Glasgow Baptisms*); married, first, Marion Montgomery, January 30, 1723 (*Glasgow Marriages*), who died in May, 1743, and was buried on the 31st in the N.W. Churchyard (*Glasgow Rec. of Mortality*); married, secondly, Elisabeth Binning, daughter of Charles Binning of Pilmuir, advocate (*Services of Heirs*), who died at Edinburgh, November 6, 1782 (*Scots Magazine*, vol. 44, p. 615); died, December 20, 1759 (*Merchants' House*, p. 586). "One of the most considerable merchants in this place" (*Glasgow Journal*, Dec. 24, 1759). Acquired Drumpellier, 1735. Dean of Guild, 1728, 1729. Provost, 1740, 1741. See Auchmar, 1723, p. 103; *Strathendrick*, p. 305; *Old Country Houses of the Old Glasgow Gentry*, 1878, pp. 83, 187.

1725. (I. 6.)

20. DUNCAN M'ASLAN, gardener, Glasgow.

Gardener at Cow Loan. Father of John M'Aslan (179). Boxmaster, 1726, 1727, 1733, 1734, 1735, 1736, 1737, 1738, 1739, 1740, 1741, [1742]. His widow was enrolled a pensioner, 1758. Married, January 26, 1716 (*Glasgow Marriages*), Mary Monro, daughter of Thomas Monro, gardener; died before Dec. 25, 1742. Admitted Burgess through his wife, September 11, 1718. Was a subscriber to Auchmar's book, 1723.

21. JOHN BUCHANAN of Drumglass.

Father of James B. (116). John Buchanan, wright in Drumglass, married a daughter of James Logan, feuar of Drumglass, and had a son, James, and a daughter, wife of Donald Buchanan, in Legnaline of Leny (see *Dunbartonshire Sasines*, vol. x. fol. 473, June 7, 1773). He married, secondly, Isobel Currie (born about 1685), who died in November, 1767, and was buried on the 24th (*Glasgow Rec. of Mortality*).

1725. (I. 6.)

22. WILLIAM BUCHANAN of Craigievern.

Son of John B. (18). Married, April 30, 1711, Elizabeth Hamilton, daughter of John Hamilton of Bardowie; died before March 14, 1732 (*Glasgow Com. Rec. Tests*. vol. 51, p. 91). Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 70; *Strathendrick*, p. 317.

23. THOMAS BUCHANAN, wright, Greenock.

1725. (I. 6.)

24. ARCHIBALD M'ASLAN, maltman, Gorbals.

1725. (I. 7.)

25. ARCHIBALD BUCHANAN, merchant, Glasgow, son lawful to deceased Mungo Buchanan of Hiltoun.

Brother of Andrew B. (27), and George B. (59). Described as "Junior, Merchant," he was appointed an Extraordinary director for the West Indies, 1729. Baptized, November 29, 1701 (*Edinburgh Baptisms*); died, March 29, 1732 (*Merchants' House*, p. 582); buried on the 31st in the Blackfriars' (*Glasgow Rec. of Mortality*). See Auchmar, 1723, p. 73; *Strathendrick*, p. 332.

1725. (I. 7.)

26. THOMAS BUCHANAN, shipmaster.

Brother of Walter B. (4), and probably of John (B. 13). Only son of Walter Buchanan, baxter, by his marriage to Grizel Wallace (*Glasgow Com. Rec. Tests.* vol. 51, p. 221); the other brothers being by a former marriage. Married, February 9, 1727, Margaret Gibson, daughter of John Gibson of Nether Newton (*Barony Marriages*), with a "tocher" of 2000 marks (*Glasgow Com. Rec. Tests.* vol. 51, p. 221). Besides several sons, who died young, they had a daughter, Isobell, who married James Muir, surgeon in Glasgow (*Services of Heirs*, July 19, 1744), and was the eventual heiress of Nether Newton, which she sold. Margaret Gibson died in March, 1733, and was buried on the 14th; and Thomas Buchanan died in October, 1735, and was buried on the 6th (*Glasgow Rec. of Mortality*). Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 111; *Strathendrick*, p. 297.

27. ANDREW BUCHANAN of Hilton.

Born 1694-5; married Mary Arbuckle, who survived him, and, dying about November 1, 1760, was buried

on the 4th (*Glasgow Rec. of Mortality*). Brother of George B. (59), and Archibald B. (25). See *Strathendrick*, pp. 332, 333. Was also of Auchintorlie. Died before Dec. 14, 1738 (*Services of Heirs*).

1725. (I. 7.)

28. THOMAS BUCHANAN, surgeon.

Uncle of Robert B. (156), and Thomas B. (210). Preses, 1733, 1735, 1736, 1737, 1738, 1739, 1740, [1741, 1742,] 1743. Treasurer, 1730. Director, 1727, 1728, 1732, 1733, 1734, 1735. Extraordinary director, March 31, 1748. Born about 1678; married Elizabeth Napier, daughter of Archibald Napier of Ballacharne; died, January 6, 1755 (*Glasgow Journal*). His relict, who was born about 1792, died in August, 1758, and was buried on the 29th in the N.W. Churchyard (*Glasgow Rec. of Mortality*). Was father of Dr. John Buchanan, baptized December 12, 1723 (*Glasgow Baptisms*), and Christian Buchanan, married Thomas Napier, watchmaker in Glasgow, a donator to the Society. Became "of Gartachorn," 1735. "A gentleman possessed of the truly meek and inoffensive spirit of the Christian; the upright temper of the valuable member of society; the tender and sympathising disposition of the real friend, affectionate husband and parent, all centering in him without the least ostentation" (*Glasgow Journal*, January 13, 1755). Subscribed to Auchmar's book, 1723. See Auchmar, 1723, pp. 52, 54; *Strathendrick*, pp. 186, 189, 369, 370. See also *Register of Tailzies*, vol. xxv. fol. 120.

1725. (I. 7.)

29. ROBERT BUCHANAN, writer, Glasgow, son to umqll.

Robert Buchanan, Deacon of the Baxters.

Uncle of Robert B. (127). Brother-in-law of Archibald B. (3), and of John B. (13). First Secretary to the Society,

1725-1742. Treasurer, 1740-1748. Director, 1749, 1750. Preses, 1751-1758. Born about 1690, he was probably the Robert Buchanan, son of Robert Buchanan and Martha Aikin, who was baptized, October 21, 1690 (*Glasgow Baptisms*); married, first, September 6, 1720 (*Glasgow Marriages*), Jean, eldest daughter of Archibald Buchanan of Drumhead, who was baptized, April 29, 1694, and died in December, 1747, buried in the Blackfriars on the 11th (*Glasgow Rec. of Mortality*); married, secondly, July 24, 1748, Margaret Chapman (*Glasgow Marriages*), who survived him and probably died, January 14, 1802 (see *Edinburgh Magazine*, vol. xix. p. 160); died in August, 1758, and was buried in the Blackfriars on the 1st September (*Glasgow Rec. of Mortality*). His testament is recorded, February 19, 1759 (*Glasgow Com. Rec. Tests.* vol. 60, p. 288). Clerk to the Incorporation of Bakers. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, pp. 54, 73; *Strathendrick*, pp. 328, 369.

1725. (I. 7.)

30. ANDREW BUCHANAN, merchant, Bo'ness.

Probably son of Andrew Buchanan in Shirgarton, 1678 (see Wodrow's *Church History*, Burns' edition, vol. ii. p. 482), and Janet Cunninghame (*Information from Mr. W. M. Hunt*). Andrew Buchanan in the parish of Carriden and Mary Murray in the parish of Borrowstouness were proclaimed in order to marriage, July 18, 1710 (*Carriden Proclamations*). Mary Murray died before December 27, 1728, when her testament dative was recorded in the *Edinburgh Commissariat* (vol. 92). She was probably Andrew Buchanan's second wife, and left no children, as her nephews and nieces were her heirs. By her marriage contract, dated July 26, 1710, £1000 Scots was settled upon her. "Andrew Buchanan, merchant Dyed Decr. 13" [1749], buried Jan. 1st (*Bo'ness Deaths*). Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 63.

1725. (I. 8.)

31. ANDREW BUCHANAN, wright, Gorbals.

Was in Partick in 1754. Father of Andrew Buchanan, apprenticed by the Society in 1754. Was the husband of Jean Bilsland, a pensioner of the Society from 1760 to 1797, described, November 12, 1760, as "Relect of Andrew Buchanan, Miller at Partick," and January 6, 1797, as "Relect of Andrew Buchanan, an old member"? In 1776 her husband is described as "Millwright." Andrew Buchanan, Miller at Buchanan, married, October 27, 1737, Jean Bilsland in Drymen parish (*Buchanan Marriages*), and they had a daughter, Elizabeth, baptized at Drymen, February 5, 1739 (*Buchanan Baptisms*).

32. JOHN BUCHANAN, merchant shopkeeper, Stockwell-gate.

1725. (I. 8.)

33. JOHN BUCHANAN, merchant in Bumpstead, County of Essex, England.

Perhaps brother of George B. (61) of Blairlusk. See Auchmar, p. 91; *Strathendrick*, p. 352.

1725. (I. 9.)

34. JAMES BUCHANAN, merchant, Glasgow, second lawful son to Archibald Buchanan of Drumhead.

Brother of Archibald B. (3). Brother-in-law of Robert B. (29). Extraordinary director, 1728, 1729, 1730. Described in 1729 as "Merchant and factor in London." Baptized, May 31, 1696. See Auchmar, 1723, p. 73; *Strathendrick*, p. 328.

1726. (I. 9.)

35. WILLIAM BUCHANAN, gardener, Calton.

Father of Professor James B. (181). A daughter, Jean, had an allowance from the Society in 1772, and another daughter, Margaret, in 1772, 1782, 1801. Described as "Gardener in Barrowfield," he had a sasine of lands in Calton, recorded July 3, 1723 (*Renfrewshire Sasines*, vol. viii. fol. 30). He married, July 6, 1725, Marion Wilson (born about 1699), who died in December 1764, and was buried on the 12th (*Glasgow Rec. of Mortality*). He was admitted Burgess and Gild Brother October 7, 1735, as married to Marion Wilson, daughter to umqll. Mathew Wilson, gardener. From the testament dative of Professor James Buchanan we find that the latter had three sisters—Jean Buchanan, spouse of William Lindsay, innkeeper, Glasgow; Mary Buchanan, spouse of Allan M'Allan, gardener there; and Margaret Buchanan, spouse of Andrew Harvie, weaver in Calton (*Glasgow Com. Rec. Tests*. vol. 61, p. 289). Mary Buchanan, born about 1730, died in 1764, and was buried on November 2 (*Glasgow Rec. of Mortality*). Her husband was Deacon of the Gardeners, 1735, 1736. See Auchmar, 1723, p. 111; *Strathendrick*, p. 297 n.

1726. (I. 9.)

36. MOSES BUCHANAN, merchant, Glasgow.

Brother of George B. (66). Father of James B. (168). Director, 1726, 1727. Treasurer, 1732. Married, July 26, 1722, Elizabeth Buchanan (*Killearn Marriages*), and had James, Rebecca, and Margaret (*Glasgow Burgh Sasines*, vol. xiv. fol. 13, 1745-1749); died in September, 1742, and was buried in the Blackfriars on the 24th (*Glasgow Rec. of Mortality*). [Dennistoun MS. gives date of death as 1744.] Elizabeth Buchanan, his relict (born about 1690), died in November, 1762, and was buried in the N.W. Churchyard on the 15th (*Glasgow Rec. of Mortality*). Merchant in Bell's Wynd. Succeeded

to Ballochruin in 1738. His daughter Rebecca married, July 16, 1758, Laurence Day, sergeant in General Yorke's Regiment (*Glasgow Marriages*). The other daughter, Margaret Buchanan, born December 30, 1730 (*Glasgow Baptisms*), who eventually succeeded to Ballochruin, married, September 3, 1759, Thomas Buchanan of Ardoch. See Auchmar, 1723, p. 71; *Strathendrick*, p. 326.

1726. (I. 9.)

37. GILBERT BUCHANAN of Bankell, late Dean of Guild.

Father of William B. (54), and Gilbert B. (53). Was probably brother of William B. (14). Born, 1653; married, Feb. 15, 1694, Dorothea Napier (*Glasgow Marriages*), daughter of Provost William Napier; died, December 27, 1730. Dorothea Napier, baptized, August 6, 1674 (*Glasgow Baptisms*), died, February 3, 1723. Dean of Guild, 1721, 1722. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 105; *Strathendrick*, p. 306.

1726. (I. 9.)

38. ARCHIBALD BUCHANAN, tailor.

Boxmaster, 1731, 1732. Died in July, 1737, and was buried on the 6th (*Glasgow Rec. of Mortality*).

1726. (I. 11.)

39. JOHN BUCHANAN, cordiner, Glasgow.

Died in July, 1728, and was buried on the 10th (*Glasgow Rec. of Mortality*). There was, however, another John Buchanan, cordiner, who was admitted Burgess and Gild Brother, September 18, 1729.

1726. (I. II.)

40. JAMES BUCHANAN, tailor, Glasgow, Kirkhouse, his son.

Father of Thomas B. (169). Boxmaster, 1727, 1728. Treasurer, 1731. Director, 1732, 1733, 1735. Treasurer a second time, 1736. Director, 1740, 1741. Preses, 1744, 1745, 1746, 1747, 1748. Director, 1749, 1750, 1751, 1752, 1753, 1754, 1755, [1756,] 1757, 1760, 1761, 1762, 1763, 1764, 1765, 1766, 1767. Baptized, November 7, 1700 (*Strathblane Baptisms*); married, December 16, 1725, Elizabeth Downie (*Glasgow Marriages*), daughter of Robert Downie, merchant (*Services of Heirs*); died in March, 1768, and was buried on the 30th in the High Churchyard (*Glasgow Rec. of Mortality*). Besides Thomas Buchanan, who succeeded him in Kirkhouse, he had a daughter, Agnes, who married Andrew Dunlop, merchant burgess of Glasgow (*Incorporation of Tailors*, p. 71). Merchant in Gallowgate. Deacon of the Tailors, 1746. Deacon-Convener, 1751, 1752. Bailie, 1753, 1762. Walter Buchanan of Connochra married Margaret Buchanan (*Strathendrick*, p. 316), and seems to have had a son, John, who was father of Thomas Buchanan. This John Buchanan in Easter Quilt acquired the pendicle of Edenkill, called the Kirkhouse aiker of Strathblane, in 1660 (*Stirlingshire Sasines*, vol. xii. fol. 287). He married Christian Grahame, and died in November, 1664 (*Glasgow Com. Rec. Tests*. vol. 32, March 22, 1666), leaving a son, Thomas Buchanan (*Stirlingshire Sasines*, vol. ii. fol. 126, July 12, 1665). Thomas Buchanan of Kirkhouse married, before December 4, 1689, Margaret Leckie, eldest daughter of John Leckie of Croy-Leckie (*Ibid.* vol. vii. fol. 408). Their son was James Buchanan (40), merchant tailor in Glasgow (see *Services of Heirs*, Sept. 24, 1731). See Auchmar, 1723, p. 77; *Strathblane*, p. 66.

1726. (I. II.)

41. WILLIAM BUCHANAN, weaver, Glasgow.

Boxmaster, 1728, 1729, 1732. Described as "Elder, weaver in Glasgow." Was a Director, 1750, 1751, 1752,

1753. Born about 1692; died, 1759 (*Trades House*, p. 254). Deacon of the Weavers, 1732.

1726. (I. II.)

42. PATRICK BUCHANAN, gardener, Wyndhead.

Married, first, December 30, 1707, Susanna Cook (*Glasgow Marriages*), who died in November, 1737, and was buried on the 8th (*Glasgow Record of Mortality*); married, secondly, Catherine Brown (born about 1688), who survived him, and died in December, 1765, buried on the 31st (*Ibid.*). Was enrolled as a pensioner in 1750, being described as "an old decayed member." He was probably the Patrick Buchanan who married, before March 16, 1693, Janet Duncan, daughter of William Duncan, and was admitted a member of the Incorporation of Gardeners on that date (*History of the Incorporation*, p. 183). The same Patrick Buchanan, gardener, had been admitted a Burgess in right of his wife, Feb. 18, 1693 (*Index to Reg. of Burgesses*).

1726. (I. II.)

43. WALTER BUCHANAN, weaver, without the West Port of Glasgow.

Walter Buchanan, weaver, was admitted Burgess and Gild Brother, December 27, 1700, as married to Jean Smith, eldest daughter of William Smith, weaver, Burgess and Gild Brother. The date of the marriage was December 24, 1700 (*Glasgow Marriages*).

1726. (I. II.)

44. JAMES BUCHANAN of Carnock, Callander.

James Buchanan, portioner of Carnock in the parish of St. Ninian's, married, first, Jan. 22, 1693, Christian Din (*Campsie Marriages*; *Stirlingshire Sasines*, vol. x.

fol. 463, 464) ; married, secondly (contract dated Dec. 20, 1711), Janet Din (*Stirlingshire Sasines*, vol. xiii. fol. 62). He had a son, Walter, mentioned, March 15, 1716 (*Ibid.* vol. xiii. fol. 325). See Auchmar, 1723, p. 93.

1726. (I. 12.)

45. ANDREW BUCHANAN, merchant tailor, in Saltmarket, Glasgow.

Boxmaster, 1727, 1728. Married Helen Brock, and died before March 7, 1754 (*Glasgow Com. Rec. Tests.* vol. 59, p. 289). Andrew Buchanan, elder, merchant tailor in Glasgow, bought the lands of Easter Ballat from John Buchanan of Easter Ballat, but resold them in 1738 to John Buchanan of Nether Gartincaber (see *Stirlingshire Sasines*, vol. xvii. fol. 331).

1726. (I. 12.)

46. JOHN BUCHANAN, son lawful to deceased John Buchanan, baxter, in Glasgow.

Admitted a member of the Society at the age of 9 years, having been born about 1717. His mother married, as her second husband, John Black.

1726. (I. 12.)

47. JOHN BUCHANAN, currier, in Bridgegate, Glasgow.

Mentioned as "old and poor," March 2, 1734.

1726. (I. 12.)

48. WILLIAM BUCHANAN of Auchmar, the Chief.

Removed from the Roll of the Society, May 29, 1729, having neglected to pay his entry money. Restored, November 21, 1730. See No. 123.

1726. (I. 12.)

49. JAMES BUCHANAN of Torrie, merchant, Tarbett of Kintyre.

Father of Archibald B. (144), William B. (153), and Alexander B. (139). Brother of John B. (5). Son of William Buchanan of Glens. Married Sybilla Buchanan, eldest daughter and heiress of John Buchanan of Torrie (*Register of Tailzies*, vol. v. fol. 378). Died in March, 1742 (*Argyll Com. Rec.* vol. ix. May, 18, 1742). His wife also died in March, 1742 (*Services of Heirs*). See Auchmar, 1723, p. 115.

1726. (I. 13.)

50. ARCHIBALD BUCHANAN of Drumiekilln.

Father of William B. (96), Robert B. (217), and Dr. John B. (162). Extraordinary director, 1727, 1728, 1729, 1730. Born about 1683; married, probably about 1704, Jean Buchanan, heiress of Ross, daughter of James Buchanan of Ross; died at Ross, March 11, 1761, in his 79th year (*Glasgow Journal*). Succeeded his brother, William Buchanan, in Drumiekill, 1699. Subscribed to Auchmar's book in 1723. See Auchmar, 1723, p. 77; *Strathendrick*, p. 321.

51. JOHN M'ASLAN, land labourer, Glasgow, without the West Port.

Removed from the Roll of Members, May 29, 1729.

1726. (I. 13.)

52. MOSES BUCHANAN of Glins.

Father of John B. (143), uncle of William B. (79), and father-in-law of Moses B. (55). Married, July 31, 1712,

Janet Govan, daughter of Mr. Archibald Govan of Boquhaple (*Killearn Marriages; Stirlingshire Sasines*, vol. xiii. fol. 70). Alive in 1749. Subscribed to Auchmar's book in 1723. See Auchmar, 1723, pp. 88, 93; *Strathendrick*, p. 348.

1726. (I. 13.)

53. GILBERT BUCHANAN, writer, Edinburgh, second lawful son to Gilbert Buchanan of Bankell, late Dean of Guild.

Son of Gilbert B. (37), brother of William B. (54), and brother-in-law of Archibald B. (3). Afterwards (before 1734) merchant in London. Baptized, December 26, 1704 (*Glasgow Baptisms*). Succeeded his brother, William, in Bankell in 1733. A Gilbert Buchanan of Bankell died before September 14, 1759, when his son, John, merchant in London, was served heir (*Services of Heirs*). [Was this Gilbert the Dean of Guild or his son, Gilbert the second? The account in *Strathendrick* is evidently not quite correct. If Gilbert the second was succeeded by his brother John, as seems to have been the case, there must be a generation too many, and the latter must be identical with the merchant in America.] See *Strathendrick*, p. 307.

1726. (I. 14.)

54. WILLIAM BUCHANAN, eldest lawful son to Gilbert Buchanan of Bankell.

Son of Gilbert B. (37), brother of Gilbert B. (53), and brother-in-law of Archibald B. (3). Director, 1731. Preses, 1731, 1732. Baptized, May 7, 1702 (*Glasgow Baptisms*); died unmarried in August, 1733. See *Strathendrick*, p. 307.

1726. (I. 14.)

55. MOSES BUCHANAN of Ballochneck, writer, Glasgow.

Son-in-law of Moses B. (52). Director, 1729, 1730, 1732, 1733, 1734, 1736, 1737, 1738, 1739. Secretary, 1742-1744. Only son of John Buchanan of Ballochneck by Janet Buchanan, eldest daughter of John Buchanan of Garnstarry Milne (*Glasgow Com. Rec. Tests.* vol. 50, p. 3). Born about 1706; married, in September, 1737 (*Drymen Marriages*), Anne Buchanan, eldest daughter of Moses Buchanan of Glyns (*Stirlingshire Sasines*, Oct. 25, 1738); died, without surviving issue, September 4, 1744 (*Minute Book*). His testament, dated April 23, 1744, was recorded in the *Glasgow Commissariat*, August 29, 1747, vol. 57, p. 33. He left a legacy to the Society of £20. Admitted notary public, June 13, 1728 (*Reg. of Adm. of Notaries*, vol. xix. fol. 205). Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 62; *Strathendrick*, p. 367.

1726. (I. 14.)

56. JOHN BUCHANAN of Ardoch, writer, Glasgow.

Father of Thomas Buchanan (177), and father-in-law of John B. (184). Director, 1729, 1736. Son of Thomas Buchanan, Sheriff Clerk of Dunbarton, who was only son of William Buchanan, first of Ardoch (see Auchmar, p. 91). Born, December 26, 1706; married, first, January 21, 1731, Mary Crawford, daughter of William Crawford, merchant in Glasgow (baptized, April 22, 1707; died, March 23, 1738); married, secondly, October 13, 1747, Elizabeth Buchanan (born, 1713), daughter of Walter Buchanan, writer in Glasgow, and widow of Alexander Buchanan of Cremannan; died, January 13, 1774. Admitted Burgess and Gild Brother of the Burgh of Glasgow in right of his first wife, February 13, 1754. See *Strathendrick*, p. 355.

1726. (I. 14.)

57. GILBERT BUCHANAN, eldest lawful son to William Buchanan, merchant in Glasgow.

Son of William B. (14). Director, 1730, 1731. Described as "eldest lawful son procreat between William Buchanan, merchant in Glasgow, and Janet Colquhoun." Baptized, November 23, 1701 (*Glasgow Baptisms*); married (contract dated January 20, 1731), Dorothea, daughter of Gilbert Buchanan of Bankell (*Glas. Com. Rec. Tests.* vol. 53, fol. 32); died in October, 1731 (*Ibid.* vol. 51, fol. 259), and was buried on the 26th (*Glasgow Rec. of Mortality*). His wife was baptized, September 2, 1712 (*Glasgow Baptisms*).

1727. (I. 15.)

58. JOHN BUCHANAN of Over Garncaber.

Removed from the Roll of Members, May 21, 1729. Born, April 15, 1691 (*Buchanan Baptisms*); married at Kippen, June 1, 1715, Agnes Forrester (*Buchanan Marriages, Kippen Marriages*). Sold part of his lands of Over or Upper Gartincaber to John Buchanan of Nether Gartincaber about 1731, and the remainder in 1743 to James Buchanan of the Critchael family. Described as Tide Wister in Irvine, September 3, 1743 (*Stirlingshire Sasines*, vol. xviii. fol. 307). See Auchmar, 1723, p. 91; *Strathendrick*, p. 353.

1727. (I. 15.)

59. GEORGE BUCHANAN, physician in Maryland, son to Mungo Buchanan of Hiltoun.

Brother of Andrew B. (27), and Archibald B. (25). Born, July 7, 1696 (*Edinburgh Baptisms*); married Eleanor Rogers (born, 1705; died, 1758), daughter of Nicholas Rogers; died at Baltimore, April 23, 1750.

Went to America in 1723. Succeeded to Hiltoun and Auchentorlie on the death of his brother, Andrew Buchanan. These lands he sold. The disposition by him of the lands of Connalton and others to Andrew Buchanan, present Provost of Glasgow, being dated July 2, 1739 (*Dunbartonshire Sasines*, vol. vii. fol. 323). See Auchmar, 1723, p. 73 ; *Strathendrick*, p. 333.

1727. (I. 16.)

60. WILLIAM M'MILLAN of Barwhinnock, in the parish of Twinnieholm and Stewartry of Galloway.

The same as William M'Millan, No. 109, which see.

1727. (I. 16.)

61. GEORGE BUCHANAN II. of Blairlusk.

Perhaps brother of John B. (33) ; cousin of John B. (118). Born probably about 1682 ; married (contract dated December 8, 1705) Margaret, daughter and heiress of James Bauchope of Easter Balfunning ; died before November 2, 1748. He had five daughters, of whom Grizel was wife of Moses Steven in Easter Finnick, and portioner of Easter Cameron or Cameron Douglas ; Margaret was the wife of George Buchanan (1713-1778) of Finnick Drummond and Blairinnick ; and Rebecca the wife of William Buchanan in Merkins, (1744-1750), Blairanick (1753-1756) and Balantone. Was a subscriber to Auchmar's book, 1723. See Auchmar, 1723, p. 91 ; *Strathendrick*, p. 343 and 352.

1727. (I. 16.)

62. JAMES BUCHANAN of Wester Ballat.

Probably nephew of Capt. Duncan B. (157). Married, March, 1728, Christian Bogle (*Drymen Proclamations*), daughter of John Bogle of Polmadie, surgeon apothecary

in Glasgow (*Renfrewshire Sasines*, viii. fol. 327, March 19, 1729). She died in September, 1736, and was buried on the 17th (*Glasgow Rec. of Mortality*). Patrick Buchanan of Wester Ballat (see Auchmar, p. 75) married (contract dated June 14, 1670) Margaret Grahame, daughter of John Grahame of Duchray (*Gen. Reg. of Deeds, Mackenzie*, vol. 38, November 19, 1675). His eldest son was John Buchanan of Wester Ballat, who married Janet Meason, daughter of James Meason, in Holl of Balagan (*Stirlingshire Sasines*, vol. x. fol. 454). They were probably the parents of James Buchanan of Wester Ballat.

1727. (I. 17.)

63. FRANCIS BUCHANAN of Arnpryor.

Extraordinary director, 1727, 1728, 1729, 1730. Married Elizabeth Buchanan of Leny. Was out in the '45, and was executed at Carlisle, October 18, 1746 (see *Scots Magazine*, vol. 8, p. 498). See Auchmar, 1723, p. 103; *Strathendrick*, p. 301.

1727. (I. 18.)

64. ARCHIBALD M'AUSLAND alias BUCHANAN, gardener, Glasgow.

Removed from the Roll of Members, May 21, 1729. Was admitted Burgess and Gild Brother of the Burgh of Glasgow, May 21, 1734. Died in April, 1737, and was buried on the 28th (*Glasgow Rec. of Mortality*). There was, however, an Archibald M'Causlan, gardener, who married Janet Dougall, daughter of Thomas Dougall, and was admitted a member of the Incorporation of Gardeners, Sept. 25, 1718 (*History*, p. 186), and another Archibald M'Causlan, son of Patrick M'Causlan, admitted, August 4, 1727 (*Ibid.* p. 187).

65. WILLIAM BUCHANAN, labourer, Glasgow.

Removed from the Roll of Members, May 21, 1729.
Perhaps father of Andrew Buchanan, who was appren-
ticed by the Society, 1757.

66. GEORGE BUCHANAN of Ballochruin.

Brother of Moses B. (36), and uncle of John B. (137).
Married (contract dated March 22, 1693) Margaret
Buchanan, daughter of John Buchanan of Balfunning
(*Stirlingshire Sasines*, vol. viii. fol. 275) ; died, *s.p.* 1738.
Subscribed to Auchmar's book, 1723. See Auchmar,
1723, p. 71 ; *Strathendrick*, p. 326.

67. ROBERT BUCHANAN, merchant, Port-Glasgow.

His son, Walter Buchanan, was apprenticed by the
Society in 1750.

68. WILLIAM ZUILL alias BUCHANAN, maltman, Glasgow.

Boxmaster, 1728, 1729. Admitted Burgess and Gild
Brother, May 12, 1727.

69. WILLIAM ZUILL alias BUCHANAN, wright, Glasgow.

Born probably in 1691 (see *Killearn Baptisms*, September 6, 1691); married, 1725, Elizabeth Buchanan (*Bonhill Proclamations*, September 11, 1725), only daughter and heiress of Mungo Buchanan of Middle Tulliechewan; died in December, 1760 (*Glasgow Com. Rec. Tests*. vol. 63, fol. 394, August 23, 1768). His wife, who was baptized, January 1, 1708, died before February 19, 1732 (*Argyll and Dunbartonshire Sasines*, vol. vi. fol. 541), leaving an only son, James Buchanan, who succeeded his mother in Middle Tulliechewan. See *Genealogical Magazine*, vol. ii. pp. 357, 500; iv. p. 529; *Strathendrick*, p. 332.

Born probably about 1702 ; married, June 2, 1732, Elizabeth Donald (*Cardross Marriages*). Irving states (*Book of Dunbartonshire*, vol. ii. p. 309) that he acquired the lands of Geilston by marriage in the beginning of the 18th century, but it is probable that he succeeded to them through his mother. He was also proprietor of half the lands of Little Tulliechewan, which he sold to William Buchanan of Ladrishmore. Geilston he sold to the Donalds. James Buchanan, portioner of Little Tulliechewan (see Auchmar, p. 73), married, 1700, Margaret Bontine (*Cardross Proclamations*, Nov. 10, 1700 ; *Bonhill Proclamations*, Nov. 16, 1700), daughter of John Bontine of Geilston. The marriage contract was dated December 11, 1700. Their son was John Buchanan, afterwards of Geilston. James Buchanan died in February, 1704 (*Glasgow Com. Rec. Tests*. vol. 49, p. 296). James Buchanan and Margaret Bontine had also a daughter, Barbara, baptized, September 8, 1703 (*Bonhill Baptisms*), who married, February 26, 1730, William How, merchant in Port-Glasgow (*Cardross Marriages*).

Father of Alexander M'Millan (92). Extraordinary director, 1728, 1729, 1730. Married Katharine Buchanan, eldest daughter of John Buchanan of Torrie, who was father-in-law of James Buchanan, afterwards of Torrie (*Reg. of Tailzies*, vol. v. fol. 378). See Auchmar, p. 128.

78. JAMES BUCHANAN, stabler, Glasgow.

James Buchanan, "Horse Hyrer," was buried, January 17, 1730 (*Glasgow Rec. of Mortality*).

79. WILLIAM BUCHANAN of Carbeth.

Father of John B. (202). Nephew of Moses B. (52). Born, 1695; married, December 4, 1717, Margaret Kincaid (*Killearn Marriages*), eldest daughter of James Kincaid of Auchinreoch; died, 1737. Subscribed to Auchmar's book in 1723. See Auchmar, 1723, p. 89; *Strathendrick*, p. 348.

80. JAMES BUCHANAN in Drumillan, Campsie.

Perhaps brother of David B. (108). He was probably the James Buchanan who was in Drumillan in 1717, and who seems to have married Anne Anderson, September 8, 1704 (*Campsie Marriages*). James Buchanan in Drumillan was succeeded by James Buchanan before March 19, 1650 (*Glasgow Burgh Services*), who married Margaret Blair, and was probably father of the above.

He had a son, James, baptized, July 29, 1739, probably James, afterwards of Upper Kilwinnet, and a daughter, Helen, born, July 31, 1748, probably the Helen Buchanan, daughter of William Buchanan of Crosshouse, and widow of Alexander Adam, printer in Glasgow, enrolled as a pensioner in 1810.

He is mentioned as "Maltman in Dunbarton," January 12, 1722, cautioner for Walter Williamson of Chappeltoun, writer in Dunbarton, whose grandmother was a Katharine Buchanan (*Glasgow Com. Rec. Married Christian Smith, and had a daughter, Isobell, baptized, January 13, 1698 (*Edinburgh Baptisms*). He seems to have married, secondly, Mary Anne Middleton, who survived him. Son of Duncan M'Millan (77). Extraordinary director, 1729, 1730. Married, first, Margaret Campbell; secondly, Jane Campbell; died, July 26, 1770. W.S. 1726 (*History of the W.S. Society*, p. 137). Subscribed to Auchmar's book, 1723.

93. ALEXANDER BUCHANAN of Cremannan.

Extraordinary director, 1730. Son of James Buchanan of Cremannan (Auchmar, p. 117). Succeeded his father in March, 1724 (*Services of Heirs*). Was in the 4th Class, Glasgow College, in 1724. Born probably about 1707; married (contract dated June 1, 1736) Elizabeth Buchanan, daughter of Walter Buchanan, writer in Glasgow (*Strathendrick*, p. 298); died, 1745. His widow married, secondly, in 1747, as his second wife, John Buchanan of Ardoch (56). She was baptized, May 31, 1713 (*Glasgow Baptisms*), and died

(See also *Killearn Baptisms*, Sept. 6, 1691; and *Kilmaronock Session Records, Baptisms*, Aug. 21, 1713). She must have been his second wife, Archibald and George being her sons, and John being by a former marriage. There was also a son, James, by Anne Campbell, baptized, Aug. 21, 1713 (*Kilmaronock Session Records*). He was alive, June 1, 1728 (*Argyll and Dunbartonshire Sasines*, vol. viii. fol. 69, J. G. S. notes), but died before 1734. He acquired Middle Catter, February 17, 1704. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 92; *Genealogical Magazine*, vol. ii. p. 500.

96. WILLIAM BUCHANAN, younger, of Drumiekiln.

Son of Archibald B. (50). Brother of Robert B. (217), and John B. (162). Extraordinary director, 1729, 1730. Born probably about 1705. Married, 1730, Lillias Murray, eldest daughter of John Murray of Touchadam and Polmaise, who died, June 2, 1776 (*Scots Magazine*, vol. 38, p. 340); died at the Ross, February 4, 1751 (*Ibid.* vol. 13, p. 109). See *Strathendrick*, p. 321.

97. WILLIAM BUCHANAN of Ladrishmore.

Father of John B. (184). Nephew of James B. (95). Born about 1690; married, 1715, Jean M'Farland (*Bonhill Proclamations*, July 9, 1715); died, July 24, 1757 (*Tombstone, Bonhill*). His wife was born about 1697, and died, July 2, 1757 (*Ibid.*). Succeeded his father, George Buchanan of Ladrishmore, in 1715. Subscribed to Auchmar's book, 1723. See Auchmar, 1723, p. 92.

Deacon-Convener, 1723-1732 (*Stirling Records*, 1667-1752, pp. 402, 403). He died before January 25, 1748, when his testament was confirmed, his eldest son, James, being executor dative (*Commissariot of Stirling*, scroll testaments).

104. THE REV. JOHN BUCHANAN, Coventain, Lanarkshire.

Son of the Rev. John Buchanan, minister of Covington, and Catherine Spreul of Abbey Lands (see *Abbey Proclamations*, June 26, 1692). Baptized, Dec. 20, 1694; died, Nov. 12, 1766 (*Scott's Fasti*, vol. i. p. 217). Succeeded his father in 1726. His testament dative was recorded, January 8, 1767, his nieces, Catherine Hunter, spouse of Mr. John M'Caul, minister at Symington, and Helen Hunter, spouse of Mr. John Kingan, minister at Crawford, being decerned executrixes dative as nearest in kin (*Lanark Com. Rec. Tests.* vol. 18). See Auchmar, 1723, p. 90.

105. JOHN BUCHANAN of Torbreck.

106. ALEXANDER BUCHANAN of Dulator.

Brother of Walter B. (107). Granduncle of John B. (240). Married a daughter of Graham of M'Kenston

(MS. Pedigree at Leny). Alexander Buchanan married, September 9, 1742, Margaret Grahame in the parish of Port (*Callander Marriages*), but this seems too late a date to be Alexander of Dulator.

Brother of Alexander B. (106), and granduncle of John B. (240). Walter, third son of Arthur Buchanan of Auchlessy, married, first, Elizabeth Pearson, daughter of James Pearson of Kippenross, who died in 1693 (*Dunblane Com. Rec. Tests.* vol. 18, p. 4, Oct. 1, 1713); secondly, a daughter of Annat (MS. Ped. at Leny). He had a discharge in his favour of the 40s. lands of Wester Spittalton, recorded, September 1, 1699 (*Stirlingshire Sasines*, vol. x. fol. 205). He acquired the lands of Stank and Kernoch in 1708 (*Ibid.* vol. xii. pt. 2, fol. 422, April 29, 1709). See *Strathendrick*, p. 302; Auchmar, 1723, p. 103.

108. DAVID BUCHANAN, merchant traveller in England, now residing at Mains of Bancloch, Campsie.

Died before June 7, 1773 (*Argyll and Dunbartonshire Sasines*, vol. x. fol. 473). James Buchanan, maltman, was admitted Burgess and Gild Brother, Nov. 29, 1732, as married to Marion Stevenson, daughter of John Stevenson, cordiner, Burgess and Gild Brother (*Act Book, Dean of Guild Court*, No. 11). A James Buchanan was Visitor of the Maltmen, 1769, 1770, having become a member of the Incorporation, Nov. 23, 1759. Ann Buchanan, relict of James Buchanan, late Porter to the University, and daughter of the deceased James Buchanan, Visitor of the Maltmen, was enrolled a pensioner of the Society, November 5, 1794. The register of her marriage in 1757 shows that her father was then of Easter Camlachie, which he had purchased in 1750 (*Glasgow Past and Present*, 1884, vol. ii. p. 529). The Visitor of 1769, 1770 was father of James B., writer (225), an only son, and another daughter, Agnes Buchanan (born about 1737), married, about 1754, James Fisher, farmer at Craigend of Campsie, and died, January 26, 1820 (*Scots Magazine*, vol. 85, p. 294; *Maltmen's Craft*, p. 122; *Minute Book of Society*, vol. i. p. 352).

(61); married, 1703, Catherine Black; was great-great-grandfather of Colonel Lewis Mansergh Buchanan of Edenfel (510). See Auchmar, 1723, p. 91; *Strathendrick*, p. 350.

Boxmaster, 1730, 1731. Died in July, 1733, and was buried on the 9th (*Glasgow Rec. of Mortality*).

Described as "Thomas Buchanan, senior, merchant in Glasgow, son of deceased John Buchanan of Cattermill." He compounded for total exemption from dues, December 4, 1759. He was Boxmaster, 1760. Director, 1761. Treasurer, 1762. Director, 1766. Described as "Thomas Buchanan of Cattermill." He was Boxmaster, 1770. Director, 1771. He seems to have succeeded a brother, John, in the lands of Cattermill (see *Argyll and*

Dunbartonshire Sasines, vol. ix. fol. 147, August 10, 1758), which he afterwards sold, and they were eventually acquired by James Buchanan, third of Catter, in 1778. He had also a brother, Mungo Buchanan, merchant in Glasgow, who died before July 27, 1772 (*Glasgow Com. Rec. Tests.* vol. 65, fol. 352), probably the Mungo Buchanan who married, first, July 6, 1746, Mary Neilson (died February, 1748; secondly, June 12, 1750, Jean Buchanan, daughter of Archibald Buchanan of Drumhead, and died, April 28, 1753, in his 45th year (*Scots Magazine*, vol. 15, p. 206). He was enrolled a pensioner of the Society in 1776, and died, September 24, 1780 (*Scots Magazine*, vol. 42, p. 390), and his testament was recorded November 1, 1780. See Auchmar, 1723, p. 74.

122. GEORGE BUCHANAN, merchant traveller to England, son to James Buchanan of Middleton.

Son of James B. (95). Father of John B. (231), and Herbert B. (219). Brother of John B. (9), and Archibald B. (72). Described as "George Buchanan, senior, merchant," he was Director, 1752, 1753, 1754. Box-master, 1758. Director, 1759, 1760, 1761. Preses, 1762, 1763. Director, 1764, 1767, 1768. Married, first, June 20, 1742, Marion Neilson (*Glasgow Marriages*), daughter of Herbert Neilson, merchant in Glasgow; secondly, December 21, 1760, Elizabeth Bogle, daughter of George Bogle, merchant in Glasgow; died at Arden, December 29, 1786 (*Scots Magazine*, vol. 49, p. 50). Acquired the lands which he named Arden about 1770. See *Genealogical Magazine*, vol. iv. p. 529).

Grandfather of William B. (256). Married, June 4, 1696, Jean Buchanan, daughter of John Buchanan of Carbeth; died, 1747. Author of the *Essay upon the*

Son of Walter B. (4). Father-in-law of George B. (178). Baptized, September 22, 1706 (*Glasgow Baptisms*) ; married, before 1738, Grizel Dunlop, daughter of James Dunlop of Househill, who died, January 11, 1813, aged 99 (*Scots Magazine*, vol. 75, p. 159). She was enrolled a pensioner of the Society in 1809. Walter Buchanan was admitted notary, February 24, 1728 (*Reg. of Admissions of Notaries*, vol. xix. fol. 202). See *Strathendrick*, p. 340.

125. WILLIAM BUCHANAN in Mains of Bancloch, Campsie.

Perhaps son of David B. (108).

Baptized, April 29, 1697 (*Old Kilpatrick Baptisms*) ; married, November 18, 1731, Mary Buchanan (*Glasgow Marriages*), daughter of George Buchanan, maltman in Glasgow. Was also "of Auchentoshan." Sold Moss in 1751 to William Finlay. See *Strathendrick*, p. 337.

127. ROBERT BUCHANAN, merchant in Glasgow, eldest lawful son to John Buchanan, elder, merchant there.

Son of John B. (13). Nephew of Robert B. (29). Director, 1735, 1737, 1738, 1739, 1744, 1745, 1747, 1748, 1749. Baptized, probably, April 15, 1706 (*Glasgow Baptisms*), but there was a Robert Buchanan, merchant, aged 60, buried, November 11, 1760, and his sister-german Jane, aged 58, also buried the same day in the College Churchyard, and Jane Semple, spouse of Robert Buchanan, merchant, aged 66, buried, November 5, 1767 (*Glasgow Rec. of Mortality*).

Boxmaster, 1759? Described as "weaver Gorbals." He was Director, 1762? 1763? It is doubtful whether the notices 1754-1763 refer to this John, as there were two other John Buchanans, weavers, one in Calton, 1744 (147), and one in Anderston, 1744 (158). John Buchanan, son of John Buchanan, weaver, was apprenticed by the Society in 1757. Admitted Burgess and Gild Brother by Act, November 8, 1733.

Described as "Excise officer in Calton," he was Box-master, 1755, [1756,] 1757.

131. ALEXANDER BUCHANAN, coppersmith, Glasgow.

Alexander Buchanan, Hammerman, was admitted Burgess and Gild Brother, August 21, 1735.

132. JOHN BUCHANAN, hammerman, Glasgow.

Eldest son of Patrick B. (15). Brother of Colin B. (191). Born about 1710; married Margaret Love in the Burgh of Rutherglen, June 18, 1742 (*Rutherglen Marriages*); died in July, 1767, aged 57 years, and was buried on the 13th (*Glasgow Record of Mortality*). Admitted Burgess and Gild Brother, September 9, 1735 (*Act Book, Dean of Guild Court*, No. 11). Was Deacon of the Hammermen, 1758.

133. JAMES BUCHANAN, sugar refiner, Glasgow.

"Servant in the Wester Sugar House." Died in September, 1739, and was buried on the 5th (*Glasgow Rec. of Mortality*). Admitted Burgess and Gild Brother, November 14, 1737. A daughter, Janet Buchanan (Widow Kirkland), was enrolled a pensioner, April 22, 1803.

135. JOHN BUCHANAN, late Deacon of the Coopers, Glasgow.

Born about 1692; married, first, October 23, 1720, Marion Hamilton (*Glasgow Marriages*), who died in 1730, and was buried on the 1st June (*Glasgow Rec. of Mortality*); married, secondly, Christian Sherriff, who survived him (*Minute Book of the Society*); died in 1772, and was buried in the High Churchyard on the 3rd March (*Glasgow Rec. of Mortality*). Admitted Burgess and Gild Brother, Sept. 24, 1717. Deacon of the Coopers, 1728, 1729, 1738. A grant was made him in 1758. Appointed Officer of the Society in 1764; retired in 1770, being "old and infirm," and was enrolled as a pensioner.

136. ROBERT BUCHANAN, carpenter, Greenock.

1742. (I. 83.)

137. JOHN BUCHANAN, wright, Glasgow, son to Arthur Buchanan, wright in Gorbals.

Nephew of George B. (66). Arthur Buchanan married, April 28, 1713, Margaret Shaw (*Glasgow Marriages*). They had a son, John, baptized, June 21, 1716 (*Govan Baptisms*). Possibly identical with the John Buchanan, cabinetmaker, who married, 1742, Janet Hunter (baptized, July 12, 1713), daughter of John Hunter of Long Calderwood, and sister of the celebrated William and John Hunter. If so, he died before 1752. See Auchmar, 1723, p. 71; *Strathendrick*, p. 326.

138. ANDREW BUCHANAN, clerk to Bailie George Buchanan, maltman, Glasgow.

1743. (I. 84.)

139. ALEXANDER BUCHANAN, calico printer, Pollokshaws, son to deceased James Buchanan of Torrie.

Son of James B. (49). Brother of Archibald B. (144), and William B. (153). Died, July, 1759, his testament dative being recorded, August 30, 1759, William Buchanan of Torry, his brother-german and nearest of kin, being executor dative (*Glasgow Com. Rec. Tests.* vol. 60, p. 380). He had one-seventh share (=£1200) in the Printfield Manufactory at Pollokshaws, along with Andrew Buchanan, Archibald Ingram, Lawrence Colquhoun, Thomas Dunmoor, John Glassford, and John Ingram, merchants in Glasgow; also one-seventh share in the Pollokshaws Linen Manufactory and Bleachfield along with Sir Walter Maxwell of Pollok, Bart., Robert Dreghorn, Andrew Ramsay, and James Connell, merchants in Glasgow, John Wardrop, writer there, and Henry Hook, manufacturer at Pollokshaws.

140. JAMES BUCHANAN, innkeeper, Burgess of Glasgow.

Boxmaster, 1747, 1748, 1749, 1750, 1761. James Buchanan, vintner, became tenant of the "White Hart" in the Gallowgate, about 1755, and was still there in January, 1764 (*Glasgow Past and Present*, 1884, vol. iii. p. 326). A James Buchanan, vintner, born about 1728, died in 1764, and was buried on the 4th June, aged 36 (*Glasgow Rec. of Mortality*). His testament dative was recorded, June 28, 1764, his executive dative being the relict Ann Buchanan, and James Buchanan of Craigendmuir, parish of Barony, cautioner (*Glasgow Com. Rec.*

Tests. vol. 62, fol. 202) ; but, if this refers to the above, the age, 36, cannot be correct.

141. GEORGE BUCHANAN, distiller, Glasgow, son to John Buchanan in Gartincaber of Buchanan.

Died before November 17, 1749, when his son, James Buchanan, was apprenticed by the Society. Mary Buchanan, his widow, received a grant in 1765.

142. JOHN DOVE, servant to the Laird of Brughton, a sept of the clan.

See Auchmar, 1723, p. 132.

1744. (I. 84.)

143. JOHN BUCHANAN, younger, of Glins.

Son of Moses B. (52). Father of Moses B. (229). Baptized, June 4, 1713 (*Killearn Baptisms*) ; married, March 6, 1748, Christian Watson (*Glasgow Marriages*), who survived him ; died in September, 1764 (*Services of Heirs*), testament dative being recorded, January 31, 1765 (*Glasgow Com. Rec. Tests*. vol. 62, fol. 24). See *Strathendrick*, p. 348 n.

144. ARCHIBALD BUCHANAN of Torrie.

Eldest son of James B. (49). Brother of William B. (153), and Alexander B. (139). M.D. (*Services of Heirs*). Died, January, 1745 (*Ibid.*).

145. JOHN BUCHANAN, jun., writer, Glasgow.

Father of Alexander B. (236). Secretary to the Society, 1745-1781. Born about 1715; married, first, August 14, 1743, Agnes Lees (*Glasgow Marriages and Services of Heirs*); secondly, before 1752, Mary Graham (*Glasgow Baptisms*), who died after August 6, 1754, being probably the Mrs. Buchanan who was buried, August 16, 1754 (*City of Glasgow Rec. of Mortality*); thirdly, before January 23, 1755 (*Services of Heirs*), more probably in, or shortly before, September, 1755 (*see MS. Retours*), Jean Wallace, eldest daughter of Alexander Wallace, writer in Paisley and Sheriff Clerk of Renfrew (*Morison's Decisions*, vol. vii. p. 5371); died, July 5, 1781 (*Glasgow Mercury*, July 12, 1781), and was buried in the N.W. Churchyard on the 9th (*Glasgow Burial Registers*). He seems to have had one daughter, Jean, born September 16, 1744, by his first marriage (*Glasgow Baptisms, Services of Heirs*); one daughter, Mary, born July 31, 1754, by his second (*Glasgow Baptisms*), and a son, Alexander, and a daughter, Wallace, by his third marriage.

146. JOHN BUCHANAN, smith and farrier, Glasgow.

Boxmaster, 1754, 1755. Director, 1776, 1777, 1778, 1779. Probably father of Alexander B. (224).

147. JOHN BUCHANAN, weaver, Calton, Glasgow.

Enrolled a pensioner of the Society, 1778.

1744. (I. 85.)

148. GEORGE BUCHANAN, younger, maltman, Glasgow, son of deceased Thomas Buchanan, maltman there.

Son of Thomas B. (8). Father of Thomas B. (254), and George B. (233). Treasurer of the Society, 1748-1759. Director, 1759, 1760, 1761, 1762, 1763. Preses, 1764, 1765. Director, 1766, 1767, 1769. Preses, 1770, 1771. Director, 1774, 1775, 1776, 1777, 1778, 1779, 1781, 1782, 1783, 1784, 1786, 1787, 1788, 1789. Became a member of the Incorporation of Maltmen, August 25, 1738. Bailie, 1765. Deacon-Convener, 1767, 1768. Treasurer of the City, 1783. Described as "Senior merchant and late Brewer," he appears in the Directories of 1787 and 1789 as living on the "south side Argyle Street." Died February 6, 1794 (*Edinburgh Magazine*, vol. iii. p. 162). Thomas Buchanan and Jane Brown had a son, George, baptized, January 25, 1719 (*Glasgow Baptisms*), but George Buchanan, brewer, aged 45, was buried in the Blackfriars, September 9, 1764 (*Glasgow Rec. of Mortality*). Buried in the High Churchyard, Feb. 10, aged 75 (*Burial Reg.*).

149. MR. WALTER BUCHANAN, one of the doctors of the Grammar School.

Probably the Walter Buchanan, schoolmaster at Luss, who received a grant from the Society, September 25, 1729, "to enable him to prosecute his studies at the University of Glasgow in order to qualify him for a minister of ye church." M.A. 1733. Appointed a Doctor or Undermaster of the Grammar School, November 4, 1741 (*Cleland's Historical Account of the Grammar School of Glasgow*, p. 9) [name printed William]. March 24, 1761, "Mr. Walter Buchanan resigned his office from age and infirmities" (*Ibid.*).

150. ROBERT BUCHANAN, weaver, in Bun's Wynd, Glasgow.

Perhaps the Robert Buchanan, son to deceased William Buchanan in Tilliechewan, born about 1716, who was apprenticed by the Society to a weaver in 1729, but his health breaking down, his indentures were cancelled. William and Janet Buchanan were in Middle Tilliechewan (see *Bonhill Register*, 1708-1722). Robert Buchanan, described as "Weaver in Shuttle Street," was enrolled a pensioner, 1790. Admitted Burgess and Gild Brother, October 5, 1739.

151. JOHN BUCHANAN, weaver, Anderston, Glasgow.

Perhaps father of William B. (185). Died before November 2, 1750, when his son Matthew was elected an apprentice of the Society.

152. WALTER BUCHANAN, weaver, Drygate, Glasgow.

Grizel Fisher, spouse of Walter Buchanan, weaver, born about 1727, died in February, 1768, and was buried on the 16th (*Glasgow Rec. of Mortality*). Walter Buchanan, weaver in Glasgow, married, May 6, 1768, Jean Colquhoun (*Glasgow Marriages*). She was born about 1733, and died in June, 1769, being buried in the High Churchyard on the 24th (*Glasgow Rec. of Mortality*). Admitted Burgess and Gild Brother by Act, October 5, 1743.

153. WILLIAM BUCHANAN, merchant, Campbeltown.

Son of James B. (49). Brother of Archibald B. (144), and Alexander B. (139). Born about 1716. Described as "Merchant in Campbeltown," May 18, 1742, in the testament dative of his father (*Argyll Com. Rec. Tests.* vol. 9); as "Merchant, late Provost of Campbeltown," August 31, 1754 (*Argyll and Dunbartonshire Sasines*, vol. viii. fol. 430); succeeded his brother John in Torrie in August, 1758 (*Services of Heirs*); is described as "Collector of Customs at Campbeltown," December 22, 1769 (*Ibid.*). Died at Campbeltown, December 11, 1800, in the 85th year of his age (*Edinburgh Magazine*, vol. xvi. p. 510), leaving a son, Archibald, who succeeded, and several daughters. He was named in the Entail of the lands of Leny by Elizabeth Buchanan of Leny, June 27, 1767, immediately after Colonel Robert Buchanan of Spittal.

154. DAVID BUCHANAN, cowfeeder, Glasgow.

Father of William B. (167). Died before January 24, 1755 (*Services of Heirs*). A daughter, Margaret Buchanan, was enrolled a pensioner in 1775.

155. ALEXANDER BUCHANAN, Easter Muckroft, Campsie.

Married Issobel Young, January 10, 1730 (*Campsie Marriages*). Was in Wester Muckcroft, 1734, 1738, 1741; in Easter Muckcroft, 1743, 1747, where he died before January 12, 1750, when his testamentary was recorded in the *Commissariat of Hamilton and Campsie*. In his disposition, dated February 27, 1747, he appoints Isobell Young, his spouse, his executrix. He mentions his children Agnes, William, John, Margaret, James, and

Janet. William Buchanan in Easter Muckcroft is a witness; John Buchanan, merchant in Glasgow, and William Buchanan, baxter there, are cautioners for Isobell Young.

156. ROBERT BUCHANAN of Spittal, Captain in General Collier's Regiment of Foot in the Service of the States-General of the United Provinces.

Nephew of Thomas B. (28). Brother of Thomas B. (210). Eldest son of John Buchanan of Spittal. Succeeded to Spittal before June 6, 1733; sold the lands to his brother Peter in 1735. His Commission in the Dutch Service was dated February 10, 1745. He rose to the rank of Lieut.-Colonel, and died in 1783 (*Scots Brigade in Holland*, vol. ii. pp. 203, 403 n., 543). He had permission in October, 1746, to go to Scotland to beg for mercy for his brother implicated in the Rebellion (*Ibid.* ii. p. 344).

157. CAPTAIN DUNCAN BUCHANAN, son to deceased Patrick Buchanan of Wester Ballat.

Uncle of James B. (62).

158. CAPTAIN EWAN M'GILVAILE alias BUCHANAN, of Murlagan.

M'Gilvailes, a sept of the M'Millans (Auchmar, 1723, p. 128).

159. LIEUTENANT FINLAY M'GILVAILE alias BUCHANAN, at Urquhart, Inverness-shire.

1745. (I. 86.)

160. DOUGAL M'GILVAILE alias BUCHANAN, Locharkeg, Inverness-shire.

1746. (I. 87.)

161. JOHN BUCHANAN, mariner, son to Bailie George Buchanan, maltman, Glasgow.

Son of George B. (1). Brother of Andrew B. (180), and George B. (183). Son of George Buchanan by his first marriage to Christina Mitchell. Baptized, December 4, 1726 (*Glasgow Baptisms*).

1747. (I. 87.)

162. DR. JOHN BUCHANAN, son to Archibald Buchanan of Drummikill.

Son of Archibald B. (50). Brother of William B. (96), and Robert B. (217). Baptized, Feb. 22, 1710 (*Kilmarnock Session Records*). "Died at Carlisle on his way to Glasgow," February 23, 1767. "Was for many years a physician at Stafford" (*Scots Magazine*, vol. 30, p. 446).

163. JOHN BUCHANAN, merchant, Glasgow, shopkeeper, son to James Buchanan, land labourer, Kilsyth.

Brother of William B. (166). Boxmaster, 1751, 1752. James Buchanan, mason in town of Kilsyth, had a son, John, baptized February 21, 1697 (*Kilsyth Baptisms*).

164. ARCHIBALD BUCHANAN of Drumhead, merchant,
Williamsburgh, Virginia.

Son of Archibald B. (3). Born, August 5, 1723; died, unmarried, May 26, 1789. See *Strathendrick*, p. 329.

165. ALEXANDER M'MILLAN, captain of the ship "Cassandra" of Glasgow.

1748. (I. 91.)

166. WILLIAM BUCHANAN, merchant, Glasgow, son to James Buchanan, land labourer in Kilsyth.

Brother of John B. (163). Perhaps father of John B. (250). "William Buchanan, junior, merchant," was Boxmaster, 1764, 1765, 1766, 1767, 1768. Director, 1769, 1770, 1771, 1772. James Buchanan, mason in town of Kilsyth, had a son, William, baptized, December 2, 1705 (*Kilsyth Baptisms*). William Buchanan, merchant, and agent for the Sun Fire Office in Glasgow, died, March 31, 1789 (*Scots Magazine*, vol. 51, p. 205).

167. WILLIAM BUCHANAN, baxter, Glasgow, son to David Buchanan, cowfeeder.

Son of David B. (154). Enrolled as a pensioner in 1770.

168. JAMES BUCHANAN of Ballochruin, merchant, Glasgow.

Son of Moses B. (36). Boxmaster, 1757. Baptized, Nov. 5, 1724 (*Glasgow Baptisms*); died in September, 1758, and was buried in the N.W. Churchyard on the 29th (*Glasgow Rec. of Mortality*). See *Strathendrick*, p. 326.

1749. (I. 92.)

169. THOMAS BUCHANAN, merchant, Glasgow, son to James Buchanan of Kirkhouse.

Son of James B. (40). Boxmaster, 1753. Director, 1754, 1755, [1756,] 1757, 1758. Born about 1730 [according to *Burial Register*, but *Glasgow Baptisms* gives date of baptism as June 10, 1727]; married, January 21, 1753, Janet Wallace (*Glasgow Marriages*), younger daughter of Alexander Wallace, writer in Paisley (Morrison's *Decisions*, vol. vii. p. 5371), by whom he had an only daughter, Jean. Succeeded to Kirkhouse, and married Richard Allan, junior, merchant in Glasgow. Died in December, 1770, and was buried on the 27th (*Glasgow Rec. of Mortality*). See *Strathendrick*, p. 66.

170. GEORGE BUCHANAN, jun., merchant, Glasgow, son of Andrew Buchanan, merchant, late Provost.

Son of Andrew B. (19). Father of Andrew B. (230), and David B. (267). Director, 1758. Preses, 1759, 1760, 1761. Born, 1728; married, September 23, 1750 (*Glasgow Marriages*), Lillias Dunlop, daughter of James Dunlop of Garnkirk (*Scots Magazine*, vol. 12, p. 454); died, July 20, 1762 (*Ibid.* vol. 24, p. 396). His wife, born about 1729, died, January 24, 1795 (*Ibid.* vol. 57, p. 134), and

was buried in the old N.W. Churchyard on the 29th (*Glasgow Rec. of Mortality*). Bought Windyedge in 1758, and changed the name to Mount Vernon; built the oldest part of the present house; built the Virginia Mansion. "A gentleman of unwearied application and extensive knowledge in business and one of the most considerable traders in North Britain" (*Glasgow Journal*, July 22, 1712). See *Old Country Houses*, 1878, p. 189.

171. WILLIAM BUCHANAN, weaver, Glasgow, son of John Buchanan, weaver, then a Director.

Son of John B. (129).

172. WILLIAM BUCHANAN, younger, weaver, Glasgow, son of William Buchanan, elder, weaver there.

Son of William B. (41).

1754. (I. 108.)

173. WILLIAM RISK, weaver, Calton.

Widow William Risk, a member's widow, was enrolled a pensioner of the Society, Nov. 11, 1784, having previously received assistance.

175. JAMES BUCHANAN, weaver, Glasgow.

A James Buchanan, son of George Buchanan, distiller (141), was elected one of the Society apprentices in 1749,

and bound in 1750 to a weaver. Janet Thomson, relict of James Buchanan, weaver in Glasgow, died before August 4, 1774, when her testament dative was recorded in the *Glasgow Commissariot* (vol. 66, p. 512), Janet Buchanan, their daughter, and only child in life, spouse of Walter Robertson, late weaver in Glasgow, now soldier in the 36th Regiment of Foot, being the executrix dative. William Buchanan, merchant in Glasgow, was one of the Trustees appointed by James Buchanan.

176. WILLIAM BUCHANAN, horse setter, Glasgow.

Margaret Young, relict of William Buchanan, horse setter and change keeper, Glasgow, died before June 1, 1780, when her testament dative was recorded (*Glasgow Com. Rec. Test.* vol. 68, p. 340), William Harvie, her son, being the executor dative.

177. THOMAS BUCHANAN, hatter, Glasgow.

Son of John B. (56). Father of John B. (251), James B. (257), Robert B. (313), and Thomas B. (376). Son-in-law of Moses B. (36). Brother-in-law of James B. (168), and John B. (184). Boxmaster, 1762, 1763, 1764, 1765. Treasurer, 1766, 1767. Director, 1768, 1769, 1779. Preses, 1780, 1781. Director, 1782, 1783, 1784, 1785. Born, November 6, 1733. Married, first, September 3, 1759, Margaret Buchanan, daughter of Moses Buchanan of Ballochruin, born December 30, 1730 (*Glasgow Baptisms*); died February 21, 1761; married, secondly, June 4, 1764, Jean Gray, daughter of John Gray of Dalmarnock, baptized August 1, 1727 (*Barony Baptisms*), died April 29, 1772; married, thirdly, November 24, 1774, Helen Graham, daughter of William Graham of Birdstone, writer in Glasgow, born about 1752, died April 7, 1812; died, December 10, 1789. Known as "Thomas Buchanan, junior," and after 1774, when he succeeded his father, as "of Ardoch." In partnership with

Alexander Speirs of Elderslie. Was of the firm of Thomas Buchanan, junior, & Co. A partner in the Ship Bank from 1775 until his death. Acquired Dalmarnock in 1784. Was one of the 2662 county voters of Scotland in 1788 (Adam's *View of the Political State of Scotland*, p. 95). See *Strathendrick*, p. 355 ; *Old Country Houses*, 1878, p. 79 ; Stewart's *Curiosities of Glasgow Citizenship*, p. 184 ; *Glasgow Past and Present*, 1884, vol. i. pp. 480, 481, 507, 582 ; ii. pp. 58, 64, 232, 450 ; iii. pp. 23, 24, 196, 292.

178. GEORGE BUCHANAN, youngest, merchant, Glasgow, son to Balfunning.

Father of Archibald B. (290). Son-in-law of Walter B. (124). Boxmaster, 1758, 1759, 1760. Second son of Archibald Buchanan of Middle Balfunning. Married, before December 30, 1756 (see *Glasgow Marriages*, March 6, 1757), Margaret Buchanan (baptized September 19, 1738, *Glasgow Baptisms*), daughter of Walter Buchanan, writer in Glasgow, by Grizel Dunlop ; died before April 22, 1766, when his testament dative was recorded, Margaret Buchanan, his relict, being executrix dative (*Glasgow Com. Rec. Tests.* vol. 62, fol. 416). He was a donator of 100 marks Scots to the Society, June 26, 1759, when Margaret Buchanan, his spouse, is mentioned (*Minute Book*, i. fol. 117). See *Strathendrick*, p. 340.

179. JOHN M'AUSLAN, gardener, Glasgow, son of the deceased Duncan M'Auslan, gardener.

Son of Duncan M'Auslan (20). Father of Alexander M'Auslan (288). Boxmaster, 1766, 1767. Treasurer, 1768-1796. Director, 1802. Preses, 1803, 1804. Director, 1805, 1806, 1807, 1808. Son of Duncan M'Auslan and Mary Munro. Baptized, March 12, 1730 (*Glasgow Baptisms*) ; married Margaret Pollock, who died February

10, 1808 ((*Glasgow Herald*, February 19, 1808) ; died, April 11, 1815 (*Scots Magazine*, vol. 77, p. 480). Deacon of the Gardeners, 1763. Bailie, 1782, 1785. Deacon-Convener, 1789, 1790. Treasurer of the City, 1796. Partner of the firm of M'Auslan & Austin.

180. ANDREW BUCHANAN, jun., merchant, Glasgow.

Son of George B. (1) by Christian Mitchell (who died in 1729). Brother of John B. (161), and George B. (183). Father of Robertson B. (309). Described as "Junior, Merchant." Immediately on entry he was appointed a Boxmaster, and the same year, 1758, a Director. Treasurer, 1759, 1760, 1761. Described as "merchant," he was Director, 1762, 1764, 1765, 1766, 1767. Described as "Senior, Merchant," he was Boxmaster, 1770 ; Director, 1771, 1772, 1773. Born, November 9, 1725 ; married, first, July 8, 1755, Agnes Robertson, daughter of Arthur Robertson, who was born about 1737, died August 2, 1769 (*Scots Magazine*, vol. 31, p. 447), and was buried in the N.W. Churchyard on the 5th (*Glasgow Rec. of Mortality*) ; married, secondly, December 3, 1770, Janet Niven, daughter of Hugh Niven, merchant (*Scots Magazine*, vol. 32, p. 683), who died October 22, 1772 (*Glasgow Journal*, Oct. 29, 1772) ; married, thirdly, February 24, 1774 (*Glasgow Marriages*), Frances Innes, daughter of Alexander Innes, surgeon in the Island of St. Christopher's, who died in January, 1785 (*Glas. Com. Rec. Tests.* vol. 75, p. 452). The date of his third marriage is given in the *Glasgow Journal* (March 3, 1774) as February 28, when he is described as "Senior, Merchant in Argyle Street." He died, September 2, 1783, leaving issue by his three marriages. He was probably designated "Senior" after the death of his uncle, Provost Andrew Buchanan, December 20, 1759. In *Glasghu Facies* he is called "Bailie," but the Buchanan Society Minute Book shows that it was Andrew Buchanan, junior, afterwards of Ardenconnal, who was Bailie in 1778. The Buchanan Society made an allowance of

ten guineas a year to his five children from 1785 to 1795, through George Coats, a relative. Four daughters are mentioned in Frances Innes's testament dative (*Glas. Com. Rec. Tests.* vol. 75, p. 452). Frances, born January 3, 1775 (*Glasgow Baptisms*); Janet, Mary, and Ann, born September 1, 1782 (*Ibid.*). The fifth child would probably be John Oswald, born October 24, 1780 (*Ibid.*). He was the original projector of Buchanan Street, Glasgow, which was named after him. Was a partner in the firms of Buchanan, Hastie & Company, and Andrew Buchanan & Company, which failed in 1779 (*Glasghu Facies*, vol. ii. p. 1082). See Burke's *Landed Gentry*; *Old Country Houses*, 1878, p. 187; *Glasghu Facies*, vol. ii. pp. 1076, 1077, 1078, 1080, 1081, 1082, 1083, 1084.

181. MR. JAMES BUCHANAN, Professor of Oriental Languages, College, Glasgow.

Son of William B. (35). Director, 1758, 1759, 1760. Born about 1728; died, June 21, 1761 (*Scots Magazine*, vol. 23, p. 336), and was buried in the Blackfriars on the 24th (*Glasgow Rec. of Mortality*). His testament was recorded, April 17, 1762 (*Glasgow Com. Rec. Tests.* vol. 61, p. 289), his three sisters-german and their husbands being executors dative. The sisters were Jean Buchanan, married W. Lindsay, innkeeper, had a grant from the Society in 1772; Margaret Buchanan, married A. Harvey, weaver, had grants from the Society in 1772, 1782, was enrolled in 1801, described as sister of the Professor and daughter of William Buchanan, gardener in Calton; and Mary Buchanan, born about 1730, buried November 2, 1764, married Allen M'Auley, gardener, afterwards Deacon. James Buchanan became M.A. in 1744; was appointed Professor in October, 1757 (*Scots Magazine*, vol. 19, p. 558).

182. ARCHIBALD BUCHANAN, wright, Glasgow.

Father of William B. (237). Married Margaret Morison (see *Glasgow Baptisms*), daughter of David Morison, wright, and was admitted Burgess and Gild Brother in right of her, May 1, 1740 (*Act Book, Dean of Guild Court*).

183. GEORGE BUCHANAN, youngest, brewer, Glasgow, son of Bailie George Buchanan.

Son of George B. (1). Brother of Andrew B. (180), and John B. (161). Was probably the George Buchanan who became a member of the Maltmen's Craft, November 17, 1786. Eldest son of George Buchanan by his third marriage to Cecil Forbes. Born, October 29, 1738.

1758. (I. 115.)

184. JOHN BUCHANAN of Ladrishmore.

Son of William B. (97). Uncle of John B. (266). Baptized, September 9, 1723 (*Bonhill Baptisms*); married, 1759 (*Bonhill Proclamations of Marriage*, April 15, 1759), Agnes Buchanan (daughter of Thomas Buchanan of Ardoch), born November 12, 1734 (*Ardoch Register*), died August 26, 1812 (*Scots Magazine*, vol. 74, p. 805); died at Tillychewen, Dunbartonshire, December 24, 1784 (*Ibid.* vol. 46, p. 664). "One of the Justices of the Peace for that shire. His amiable and benevolent disposition makes his loss much regretted by his friends and acquaintances" (*Glasgow Mercury*, December 30, 1784).

185. WILLIAM BUCHANAN, weaver, Glasgow, son to John Buchanan, weaver.

Probably son of John B. (151), or perhaps John B. (147).

1758. (I. 115.)

186. GEORGE BUCHANAN, staymaker, Glasgow.

Son of Robert Buchanan in Blarneill and Agnes M'Lellan (*Minute Book*, Nov. 5, 1767). Born about 1726; married, March 4, 1759, Jean Wright, daughter of Alexander Wright of Ponside, in the parish of Kippen (*Glasgow Marriages*); died in June, 1767, aged 41 years, and was buried in the High Churchyard on the 16th (*Glasgow Record of Mortality*). George Buchanan, staymaker from London, advertises stays and riding habits in the *Glasgow Journal*, November 6, 1758.

187. JAMES BUCHANAN of Carston.

Father of John B. (222), James B. (279), George B. (242), and Archibald B. (287). Son of John Buchanan of Carstown and Elizabeth Noble. Baptized, January 11, 1714 (*Killearn Baptisms*); married, April 7, 1741, Margaret Steven (*Killearn Marriages*), daughter of John Steven in Finnick-Tennent; died about 1782. Was infeft in Carstown, April 20, 1745. See *Strathendrick*, p. 339.

1759. (I. 116.)

188. THOMAS BUCHANAN, shopkeeper, Glasgow, son of deceased George Buchanan of Garticharn.

Nephew of Thomas B. (8). Uncle of Thomas B. (275). Boxmaster, 1763.

1759. (I. 119.)

189. JAMES BUCHANAN of Catter.

Eldest son of John B. (9). Brother of Duncan B. (248), and Robert B. (206). Nephew of Archibald B. (72), and George B. (122). Director, 1772, 1773, 1774, 1775. Preses, 1776, 1777. Director, 1778, 1779, 1780, 1792, 1793, 1794, 1795. Preses, 1796, 1797. Director, 1798, 1799, 1800, 1801. Preses, 1802. Born, April 23, 1734; married, before July 1, 1769, Eleanor Briscoe, daughter of deceased John Briscoe of Charles County, Maryland (born about 1743, died January 23, 1802); died, September 1, 1803. Acquired Cattermilne, 1778, which he sold along with Middle and Wester Catter, 1791. Was of the firms of James and Robert Buchanan, and James Buchanan & Co., dissolved 1785 (*Glasgow Mercury*, April 21, 1785). Was at 123 Argyle Street in 1803 (*Directory*), where he died. See *Genealogical Magazine*, vol. ii. pp. 359, 500; iv. p. 529.

1760. (I. 123.)

190. CAPTAIN JAMES BUCHANAN of Drumpellier.

Son of Andrew B. (19). Brother of George B. (170). Director, 1765. Preses, 1766, 1767, 1768, 1769. Director, 1770, 1771. Preses, 1772, 1773. Director, 1774, 1775, 1776, 1780. He ceased to be a Director in 1781, as "now residing at Edinburgh and therefore improper to be a director." Born, April 5, 1724 (*Glasgow Baptisms*); married, June 7, 1753, Margaret Hamilton, daughter of the Hon. John Hamilton, advocate (*Scots Magazine*, vol. 15, p. 261); died at Edinburgh, January 3, 1786 (*Ibid.* vol. 48, p. 51). He had one son and three daughters: (1) Andrew, born about 1759, died at Glasgow, May 26, 1776 (*Ibid.* vol. 38, p. 279); (1) eldest daughter died in Edinburgh in 1825 (*Ibid.* vol. 96, p. 128); (2) daughter, born about 1757, died at Fairlie Lodge near Largs, June 15, 1839 (*Glasgow Herald*); (3) Helen, married, September 13, 1785, Sir George Home, Bart. (*Scots*

Magazine, vol. 47, p. 467). Bailie, 1766. Provost, 1768, 1769. Dean of Guild, 1772, 1773. Provost again, 1774, 1775. Appointed a Commissioner of Customs, December 2, 1780 (*Scots Magazine*, vol. 42, p. 674). He was a partner in Buchanan, Hastie & Co., and consequently Drumpellier had to be sold in 1777 (see *Old Country Houses*, 1878, p. 188).

191. COLIN BUCHANAN, hammerman, Glasgow.

Son of Patrick B. (15). Brother of John B. (132). Married, May 15, 1757, Janet Gordon (*Glasgow Marriages*); died in November, 1766, his testament dative being recorded, August 6, 1767, Janet Gordon, his widow, executrix dative, William Gordon, cowfeeder, and William Buchanan, weaver, cautioners (*Glasgow Com. Rec. Tests.* vol. 63, p. 106). Admitted Burgess and Gild Brother as second lawful son of Patrick Buchanan, gunsmith, Burgess and Gild Brother, September 17, 1750 (*Act Book, Dean of Guild Court*).

192. THE REV. MR. JOHN BUCHANAN, minister of the Gospel at Foulden.

Born about 1708; married, December 16, 1758, Jean Bell, who died February 19, 1823; died, June 9, 1785. Became minister of Foulden, 1755 (*Scott's Fasti*, part ii. p. 439).

193. FRANCIS BUCHANAN, gabbartman, Glasgow.

Francis Buchanan, sailor, married, September 30, 1759, Janet Thomson, daughter of James Thomson, sailor (*Glasgow Marriages*).

1761. (I. 125.)

194. GEORGE BUCHANAN, merchant, late of London, now in Glasgow, son of the deceased Neill Buchanan, merchant in London.

Son of Neil B. (111). Boxmaster, 1761. Baptized, March 16, 1721 (*Glasgow Baptisms*) ; died in June, 1784 (*Glas. Com. Rec. Tests.* vol. 72, p. 361), his testament being recorded February 1, 1790, and August 19, 1793, Marion Buchanan, spouse to Robert Oliphant of Rossie, his sister-german, executrix dative. Described as "merchant lately in London," he was served heir special to his father in the lands of Hillington, Dec. 23, 1755 (*Services of Heirs*). See *Strathendrick*, p. 306.

1761. (I. 126.)

195. ROBERT BUCHANAN, merchant, Paisley.

Father of James B. (270), and John B. (265). Married, 1755, Agnes Corse (*Abbey Proclamations*, March 15, 1755), daughter of Robert Corse of Walneuk, merchant in Paisley (see *Services of Heirs*).

1761. (I. 126.)

196. WILLIAM BUCHANAN, late , now merchant in Paisley.

Printed in error, as the entry does not appear in the *Roll Book*, and is in the *Minute Book* : "formerly entered a member of the Society, paid 21s. for total exemption from quarterly accounts." Perhaps the William Buchanan who married, in 1749, Jean Dunlop (*Paisley Burgh Proc. of Marriage*, April 14, 1749), who survived him, and died, August 7, 1804, aged 88 (*Scots Magazine*, vol. 66, p. 648).

197. JOHN BUCHANAN of Auchineven, merchant, Jamaica, son of deceased John Buchanan of Auchineven.

Son of John B. (6). Died before October 13, 1769, when his sister Margaret was served heir general to him. See *Strathendrick*, p. 298.

1761. (I. 127.)

198. JAMES BUCHANAN, janitor, College, Glasgow.

Son-in-law of James B. (116)? and brother-in-law of James B. (225). Married, June 5, 1757, Ann Buchanan, daughter of James Buchanan of Easter Camlachie (*Glasgow Marriages*), who was Visitor of the Maltmen, 1769, 1770 (see Minute of Buchanan Society, Nov. 5, 1794). James Buchanan, "servant to Blythswood," who became a member of the Maltmen's Incorporation, was married to Ann Buchanan, daughter of James Buchanan, maltman, Nov. 20, 1761 (*Minute Book of the Maltmen*). In 1768, in the register of burial of a child in the *Glasgow Record of Mortality*, he is described as "Vintner, late Porter to the University." He died before January 8, 1779, when his two daughters, Jean (Mrs. Allan) and Mary, are served heirs portioner general to him (*Services of Heirs*). His wife was enrolled a pensioner in 1794.

199. JOHN BUCHANAN, merchant, Greenock.

Born about 1726; married, November 6, 1799, Margaret Haldane Law, youngest daughter of the deceased John Law, writer in Edinburgh (*Edinburgh Magazine*, vol. xiv. p. 399); died at Greenock, in the 89th year of his age, October 28, 1814 (*Scots Magazine*, vol. 76, p. 959); "formerly one of the magistrates of Greenock" (*Ibid.*). His widow married, secondly, the Rev. William Wilson, Antiburgher minister at Greenock (*Old Greenock*, 1st

series, p. 144). He left one son, John Buchanan, born about 1804, died December 4, 1827 (*Glasgow Herald*), and two daughters: Isabella, married, July 14, 1818, Robert Hinshaw, merchant, Glasgow (*Scots Magazine*, vol. 82, p. 199), died November 4, 1835 (*Glasgow Herald*); and Margaret Anne, married, first, November 26, 1827, John Spreull, Chamberlain of Glasgow (*Glasgow Herald*), secondly, William Moon, merchant, Liverpool (*Old Greenock*, 1st series, p. 144). See *Old Greenock*, 1st series, pp. 144, 145; *Old Cartburn*, p. 207.

1763. (I. 130.)

200. JAMES BUCHANAN of Gartincaber, merchant in Glasgow.

Brother of Dr. John B. (226), and Andrew B. (241). Son of George Buchanan in Creitchael. Baptized, February 3, 1722 (*Buchanan Baptisms*); died before April 17, 1779 (*Argyll and Dunbartonshire Sasines*, vol. 11, fol. 422). Acquired the remaining parts of the lands of Over or Wester Gartincaber from John Buchanan of Gartincaber, August 24, 1743 (*Stirlingshire Sasines*, vol. 18, fol. 301). George Buchanan, second son of George Buchanan in Gartincaber (Auchmar, p. 91), is mentioned, November 25, 1634 (*Stirlingshire Sasines*, vol. 6, fol. 192); was in Creitchael in 1647 (*Buchanan Baptisms*); died between December 18, 1677, when he was witness to a marriage (*Buchanan Marriages*), and November 16, 1679, when he is described as deceased (*Ibid.*). He married Margaret Buchanan (*Buchanan Baptisms*), and was father of Thomas Buchanan. Thomas Buchanan in Creitchael, baptized September 30, 1666 (*Buchanan Baptisms*), married, 1688, Margaret Buchanan, daughter of James Buchanan of Ballochruin (*Dennistoun MSS.*), but, according to the *Buchanan Registers*, a Thomas Buchanan married Margaret Buchanan of Killearn parish, October 21, 1689. Thomas Buchanan was still alive, July 23, 1738 (*Buchanan Baptisms*). He was father of George Buchanan. George Buchanan in Creitchael married at New Kilpatrick, November 26, 1713, Mary

Scot (*Buchanan Marriages*), and had James of Gartincaber, Thomas (born 1724), Dr. John, Andrew of Auchmar, William (born 1735, died 1802), and Margaret (born 1730), married Thomas Buchanan in Creitchael of the Little Croy family. See *Strathendrick*, pp. 350, 353, 354.

1763. (I. 130.)

201. JOHN BUCHANAN, hatter, Glasgow.

Born about 1729; married, first, Jean Bryson (see *Glasgow Baptisms*); married, secondly, Ann Buchanan (*Minute Book*); died, June, 1799, and was buried in the High Churchyard on July 1 (*Burial Register*). Ann Buchanan, relict of deceased John Buchanan, late hatter, was enrolled a pensioner of the Society, October 25, 1799. The *Directory* for 1783 gives his address as Trongate, and from the *Minute Book* it appears that he was then a tenant of the Society. In 1787 and 1789 he appears as "hatt-manufacturer, shop head Gallowgate No. 9." John Buchanan & Co., hatters, were sequestrated, January 18, 1794 (*Scots Magazine*, vol. 56, p. 64). His daughter, Agnes, born December 5, 1763 (*Glasgow Baptisms*), died at Bothwell Park, Nov. 6, 1815 (*Scots Magazine*, vol. 77, p. 959). In the *Services of Heirs* she is described as milliner, and a sister, Isabella, born 1765 (*Glasgow Baptisms*), is served heir to her, December 20, 1815. Isabella Buchanan, daughter of John Buchanan, hatter in Glasgow, was enrolled a pensioner of the Society in 1821, and died before Nov. 11, 1839. The Misses Buchanan, milliners, were at 92 Hutcheson Street in 1803; 9 Virginia Street, 1807; and 59 Queen Street, 1813 and 1815.

202. JOHN BUCHANAN of Carbeth.

Son of William B. (79). Father of John B. (292). Born, 1720; married Ann Buchanan, second daughter of James Buchanan of Cremannan; died at Auchinreoch

in 1790, on December 26 according to the *Services of Heirs*, but on November 22 according to the *Glasgow Mercury* of December 28, 1790. His wife was born 1719, and died, November 6, 1794 (*Scots Magazine*, vol. 56, p. 735). See *Strathendrick*, p. 349.

1767. (I. 143.)

203. GEORGE BUCHANAN, junior, merchant, Glasgow, son of deceased Bailie Archibald Buchanan of Silverbanks, merchant in Glasgow.

Son of Archibald B. (12). Brother of Peter B. (238), and Andrew B. (204). Director, 1767, 1768, 1769, 1772, 1773. Preses, 1774, 1775. Director, 1776, 1777, 1782, 1783. Preses, 1784, 1785. Director, 1786, 1787, 1788, 1794, 1795. Elected Director immediately on entry. Baptized, July 20, 1743 (*Old Kilpatrick Baptisms*). [The entry in the *Glasgow Register* is, however, as follows: "1743, August 14, Archd. Buchanan and Martha Murdoch, a l.s. Andrew, born on the 7th of July last at 11 of the day at Silverbank in the parish of Old Kilpatrick, wits. Provost Murdoch and Geo. Buchanan."] Married, first, July 4, 1767, Grizel (or Grace) Campbell, daughter of Alexander Campbell, merchant in Glasgow (*Glasgow Marriages*), who died at Auchentorlie, June 29, 1793 (*Scots Magazine*, vol. 55, p. 361); married, secondly, January, 1796, Jean Houstoun, daughter of Alexander Houstoun of Jordanhill, and widow of Major James Campbell of the Royals (*Edinburgh Magazine*, vol. vii. p. 159; *Glasgow Mercury*, February 2, 1796; *Landed Gentry*); died, s.p. July 13, 1796 (*Scots Magazine*, vol. 58, p. 506). His testament testamentar was recorded, March 23, 1797, his will being dated at Auchentorlie, June 22, 1796 (*Glasgow Com. Rec. Tests*. vol. 73, p. 470). He succeeded his brother Peter in Auchintorlie and Hillington in 1789, which estates he left to his nephew Archibald. He is described in 1782, 1783, 1784 as "Merchant, Jamaica Street," and in 1787 and 1789 as "at Renfield," in his testament as "George Buchanan of Hillington."

204. ANDREW BUCHANAN, junior, merchant, Glasgow, also son of Bailie Archibald Buchanan.

Son of Archibald B. (12). Father of Archibald B. (262), and James B. (280); grandfather of Andrew B. Yuille (361); and great-grandfather of George Y. Strang-Watkins (436). Brother of Peter B. (238), and George B. (203). Described as "Junior, merchant." He was Boxmaster, 1768, 1769; and Director, 1770, 1771, 1772, 1773, 1777; as "Junior, merchant, bailie" he was Preses, 1778, 1779; as "Junior, merchant" he was Director, 1780, 1781, 1782; as "of Ardenconnal, merchant Jamaica Street," Director, 1785, 1786, 1787; as "of Ardenconnal." Director, 1790, 1791, 1792, 1793, 1798, 1799, 1800, 1801, 1802, 1803, 1809, 1810, 1811, 1812, 1813, 1817, 1818. Preses, 1819, 1820. Director, 1821, 1822, 1823, 1824, 1825, 1827, 1828, 1829, 1830. On November 8, 1831, as the oldest member of the Society, he was appointed an Honorary Life Director. Born, July 1, 1745 (*Glasgow Baptisms*); married, July 3, 1769, Jean Dennistoun, eldest daughter of James Dennistoun of Colgrain and Dennistoun; died at Ardenconnal, July 14, 1835 (*Glasgow Herald*, July 20, 1835). His wife was born about 1751, and died, September 15, 1832 (*Ibid.* September 28, 1832). Was of the firm of Dennistoun, Buchanan & Co. Was Bailie, 1778.

1768. (I. 148.)

205. GEORGE BUCHANAN of Auchintoshan.

Son of George B. (126). Brother of Neil B. (216), and John B. (232). Second son of George Buchanan of Auchintoshan by Mary Buchanan. Born, July 2, 1733 (*Old Kilpatrick Baptisms*). Succeeded his brother Walter in Auchintoshan. Died, *s.p.* See *Strathendrick*, p. 337.

1768. (I. 148.)

206. ROBERT BUCHANAN, merchant, Glasgow, brother to James Buchanan of Catter.

Son of John B. (9). Nephew of Archibald B. (72), and George B. (122). Brother of James B. (189), and Duncan B. (248). Director, 1778, 1779, 1780, 1781. Third son of John Buchanan of Catter, W.S., by Janet Campbell. Born, February 4, 1744; died, September 1, 1820. See *Genealogical Magazine*, vols. ii. pp. 359, 500, iv. p. 529.

1768. (I. 150.)

207. ALEXANDER BUCHANAN, tailor, Glasgow.

Director, 1773, 1774, 1775, 1776, 1777, 1778, 1780, 1781. Preses, 1782, 1783. Director, 1784, 1785, 1786. Born about 1740; married, before 1777, Mary Gilmour (see *Glasgow Baptisms* and Testament); died, October 27, 1791 (*Glasgow Mercury*, November 1, 1791), and was buried on the 31st in the High Churchyard, age given as 51 (*Burial Registers*). His testament dative was recorded, July 24, 1792, his relict being executrix, and Walter Buchanan, candlemaker in Greenock, cautioner for her (*Glasgow Com. Rec. Tests.* vol. 72, p. 111). He was owner of certain lands in the village of Pollokshaws (*Ibid.* p. 468). He had a daughter, Isabella Buchanan, who married, August 22, 1796, Thomas Ogilvie, merchant (*Edinburgh Magazine*, vol. viii. p. 164). He was admitted Burgess and Gild Brother, November 19, 1766. Was Bailie of Gorbals, 1777, and Trades Bailie, 1780. In 1783 he is described as "taylor, Gibson's wynd"; 1787, as "taylor, south side Princes-street"; and 1789, as "merchant taylor, Princes-street" (*Directories*). Was he son of Alexander Buchanan of Cremannan? If so, he was baptized, March 25, 1744 (*Balfron Baptisms*), and was in business in London for a time. Alexander Buchanan of the Cremannan family was younger brother of Walter Buchanan, merchant in Greenock, married a Miss Gilmour, and had a daughter, Isabella, who married Thomas Ogilvie.

208. MRS. ELIZABETH BUCHANAN, relict of Francis Buchanan of Arnpryor.

Widow of Francis B. (63). Daughter of Henry Buchanan, twelfth Laird of Leny, by his first wife, Janet Buchanan, younger daughter of John Buchanan, last Laird of that Ilk. Born about 1702; married Francis Buchanan of Arnpryor, *s.p.*; died at Leny, February 11, 1776 (*Scots Magazine*, vol. 38, p. 109). Succeeded her brother, Robert Buchanan in Leny, in September, 1739. See *Strathendrick*, p. 295.

1771. (I. 156.)

209. MRS. MARGARET BUCHANAN, relict of John Buchanan of Torrie.

Sister of Elizabeth B. (208). She married John Buchanan, who succeeded his brother Archibald in Torrie in January, 1745, and died himself without issue in August, 1758 (*Services of Heirs*). Margaret Buchanan succeeded her sister in Leny in 1776. She died probably before 1784.

210. THOMAS BUCHANAN in Brainziet.

Nephew of Thomas B., surgeon (28). Brother of Robert B. (156). Father of John B. (211), Robert B. (212), Francis B. (213), and Peter B. (214). Third son of John Buchanan of Spittal and Margaret Muirhead. Born before 1723; married, first, Katherine Buchanan, youngest daughter of Henry Buchanan of Leny, without surviving issue (probably Henry, who died unmarried, was by this marriage); married, secondly, October 21, 1757, Elizabeth Hamilton, daughter of the deceased John Hamilton of Bardowie (*Baldernock Marriages*), by whom he had four sons and two daughters;

died before September 13, 1790 (*Services of Heirs*). Was apprehended in 1746 along with his uterine brother, Francis Buchanan of Arnpryor, and his own brother-german Patrick (or Peter) Buchanan; was tried at Carlisle, but acquitted (*Scots Magazine*, vol. 8, p. 439), September 12 to 26, 1746. He was in the Dutch Service, and was possibly the Ensign Buchanan of General Colyear's regiment who was ordered to Scotland for enlisting recruits, October 24, 1744 (*Scots Brigade in Holland*, vol. ii. p. 246), and the "Pensioned Ensign Thomas Buchanan to be ensign by replacement," April 24, 1757 (*Ibid.* vol. ii. p. 424). See *Strathendrick*, p. 370.

1771. (I. 156.)

211. JOHN BUCHANAN, son of the said Thomas Buchanan.

Son of Thomas B. (210). Brother of Robert B. (212), Francis B. (213), and Peter B. (214). Nephew of Elizabeth B. (208), and Margaret B. (209). Appointed an extra Director, 1815, becoming an ordinary one at the annual meeting of that year. "John Hamilton" was born May 22, 1758 (*Baldernock Baptisms*); married, at Chelsea, June 21, 1795, Mary Crawford (Mrs. Fletcher), eldest daughter of Sir Hew Crawford, Bart., of Jordanhill, who was born about 1761, and died at Cheltenham, December, 1841, aged 80 (*Scots Magazine*, vol. 57, p. 410; *Glasgow Herald*, Dec. 27, 1841); died at Tours, January 16, 1818 (*Scots Magazine*, vol. 81, p. 195), without issue. Colonel in the Army. Was of Bardowie, Spittal, and Leny. Assumed the name of Hamilton in lieu of that of Buchanan on succeeding to Bardowie. See *Strathendrick*, p. 371.

1771. (I. 156.)

212. ROBERT BUCHANAN, son of the said Thomas Buchanan.

Son of Thomas B. (210). "Robert Hamilton," born April 25, 1760 (*Baldernock Baptisms*); married, May 29,

1784 (*Scots Magazine*, vol. 46, p. 280), Cornelia Tinker, daughter of Commodore Tinker, by whom he had a son, Robert Hamilton, who died unmarried before his uncle (*Anderson's House of Hamilton*, p. 215). Lieutenant, Royal North British Fusiliers (*Ibid.*). See *Strathendrick*, p. 371.

1771. (I. 156.)

213. FRANCIS BUCHANAN, son of the said Thomas Buchanan.

Son of Thomas B. (210). Father of John Buchanan-Hamilton (410). "Francis-Hamilton," born at Branziet in the parish of Baldernock, February 19, 1762 (*Baldernock Baptisms*) [the *Scottish Nation* gives the date as February 15]; married Anne Brock; died at Leny, June 15, 1829. M.D. Edinburgh, 1783; H.E.I.C.S., 1794-1815. Author and man of science. "Knew more about India than any European of his time." Succeeded in 1818 his brother, Colonel Hamilton, in Leny, Spittal, and Bardowie, and assumed the additional name of Hamilton. See *The Scottish Nation*, 1866, vol. i. p. 481; and *Strathendrick*, p. 371.

1771. (I. 156.)

214. PETER BUCHANAN, son of the said Thomas Buchanan.

Born at Branziet, August 23, 1767 (*Baldernock Baptisms*); died at Bristol, March 22, 1797 (*Scots Magazine*, vol. 59, p. 288); unmarried. Captain, 22nd Regiment (*Ibid.*); 23rd Regiment of Fusiliers (*House of Hamilton*, p. 215). See *Strathendrick*, p. 371.

1772. (I. 160.)

215. THOMAS BUCHANAN, merchant in Glasgow, son of William Buchanan of Croy.

Brother of John B. (227), James B. (245), and George B. (268). Father of James Lapsly B. (260). Director, 1774, 1775, 1776, 1777, 1778, 1784, 1785, 1786, 1787. Preses, 1788, 1789. Director, 1790, 1791, 1792, 1793, 1794, 1795, 1796. Treasurer, 1797-1802. Son of William Buchanan of Croy by Margaret Wright. Born, September, 1745 (*Killearn Baptisms*); married, October 18, 1771, Mary Hutton (died, 1786), daughter of John Hutton, dyer (*Glasgow Marriages*); died, May 12, 1802 (*Scots Magazine*, vol. 64, p. 527). Succeeded his father in Croy-Buchanan. Described in the *Minute Book* as "Merchant, stocking shop" in 1784, and as "Merchant, Trongate" in 1788. No Thomas Buchanan, stocking shop, appears in the *Directories* of 1783, 1787, or 1789, the entries being "Buchanan & Leckie, stocking shop, Trongate," 1783, "William Buchanan & Leckie, stocking shop, head King's-street, south side, Trongate, No. 34," 1787, and "Buchanan & Leckies, stocking shop, Trongate, No. 34," 1789; but Thomas Buchanan, hosier, is one of the obligants for Buchanan & Leckie to the Ship Bank in 1789 (*Glasgow Past and Present*, 1884, vol. i. p. 510). See *Strathendrick*, p. 342.

1772. (I. 163.)

216. NEIL BUCHANAN of Auchintoshan.

Son of George B. (126). Brother of George B. (205), and John B. (232). Grandfather of John Cross B. (360). Director, 1773, 1774, 1775. Fourth son of George Buchanan of Auchintoshan by Mary Buchanan. Baptized, January 8, 1737 (*Old Kilpatrick Baptisms*); married Anne Bolleyn Murray, daughter of Thomas Murray; died at Glasgow, April 6, 1777. "This gentleman saw his wife, a child and two servants interred not many days before his death" (*Scots Magazine*, vol. 39, p. 223).

He had succeeded his brother George in Auchintoshan. He left two daughters: (1) Mary, married, August 8, 1787, James Davidson, W.S. (*Scots Magazine*, vol. 49, p. 412); died at Kilpatrick, May 28, 1788 (*Ibid.* vol. 50, p. 259); (2) Ann Bolleyn Buchanan of Auchintoshan; born, 1774; married, October 21, 1793, William Cross (*Glasgow Mercury*; *Edinburgh Magazine*, vol. ii. p. 423; *Scots Magazine*, vol. 55, p. 567); died, 1810. Mother of John Cross Buchanan of Auchintoshan. See *Strathendrick*, p. 338.

1773. (I. 166.)

217. ROBERT BUCHANAN of Drumiekiln.

Son of Archibald B. (50). Brother of William B. (96), and Dr. John B. (162). Born probably about 1707; died, unmarried, July 26, 1780 (*Scots Magazine*, vol. 42, p. 390). His testament testamantar was recorded, September 4, 1780 (*Glas. Com. Rec. Tests.* vol. 68, p. 397). Succeeded his nephew Archibald in Ross and Drummikill in 1768. See *Strathendrick*, p. 321.

1773. (I. 166.)

218. THOMAS BUCHANAN of Boquhan, writer in Glasgow.

Director, 1779, 1780. Became joint Clerk to the Society, October 24, 1780, and sole Clerk, November 9, 1781. Son of Hugh Buchanan of Boquhan and Janet Dalgliesh. Baptized, November 28, 1748 (*Killearn Baptisms*); died, July 28, 1803 (*Scots Magazine*, vol. 65, p. 588). Succeeded his father in Boquhan in 1761. See *Strathendrick*, p. 362. (See 493.)

1774. (I. 170.)

219. HERBERT BUCHANAN, merchant in Glasgow, son of George Buchanan of Arden.

Son of George B. (122). Brother of John B. (231). Father of George B. (341), John B. (342), and Herbert B.

(362). Second son of George Buchanan of Arden by Marion Neilson. Born, December 26, 1749 (*Glasgow Baptisms*); married, 1788 (*Abbey Proclamations*, Nov. 13, 1788), Anne Fulton, daughter of Robert Fulton of Hartfield (Crawford's *History of Renfrewshire*, Robertson's edition, p. 331), who died at Paisley, January 3, 1817 (*Scots Magazine*, vol. 79, p. 80); died, April 18, 1825 (*Ibid.* vol. 95, p. 640). Succeeded his brother John in Arden in 1790. See *Genealogical Magazine*, vol. iv. p. 530.

1774. (I. 170.)

220. WILLIAM BUCHANAN, brewer, Glasgow.

Director, 1797, 1798. Died between January 25, 1799, and November 8, 1799. A William Buchanan, *wright*, born about 1749, was buried in the High Churchyard, May 23, 1799 (*Burial Registers*); but the "Burial place of William Buchanan, Maltman in Grahamston, and Marion Young his spouse, 1775" is No. 20 in Anderston Churchyard. William Buchanan, brewer, was admitted Burgess and Gild Brother, by purchase, October 16, 1786. Described in the *Directory* of 1789 as "Maltman and brewer at Grahamston." A daughter, Helen, was enrolled a pensioner of the Society in 1815.

1775. (I. 175.)

221. THE REV. ROBERT BUCHANAN, minister of the Gospel at Lesmahagow.

Born about 1725; died, April 16, 1796 (*Scots Magazine*, vol. 58, p. 361). He was licensed by the Presbytery of Hamilton in 1759, and became minister of the Second Charge, Lesmahagow, in 1775 (*Fasti*, vol. iii. p. 330). Was he the Robert Buchanan, younger son of John Buchanan in Clackmannan, who matriculated at Glasgow University in 1757, and was M.A. 1759?

1776. (I. 178.)

222. JOHN BUCHANAN, merchant, Glasgow, son to James Buchanan of Carstoun.

Eldest son of James B. (187). Brother of James B. (279), George B. (242), and Archibald B. (287). Baptized, November 27, 1744 (*Killlearn Baptisms*). Was infeft in Carstoun in 1782, and sold the lands to William Finlay of the Moss in 1794. Described as "Merchant Oswald's land, Stockwell, 1789," his name also appearing in the 1787 *Directory*. See *Strathendrick*, p. 339.

1776. (I. 178.)

223. WILLIAM RISK alias Buchanan, merchant, Glasgow.

Probably father of William Risk (312). "Thread manufacturer and bleacher, Greenhead," 1783 (*Directory*). Risk Street was named after him (Stewart's *Curiosities of Glasgow Citizenship*, p. 235). Was probably the William Risk who married Lilius Murdoch, and was dead before January 3, 1785, when his testament was recorded (*Glasgow Com. Records*). His relict was dead before December 25, 1797 (*Ibid.*).

1776. (I. 178.)

224. ALEXANDER BUCHANAN, Glasgow, son of John Buchanan, farrier.

Probably son of John B. (146). Father of James B. (327). Director, 1799, 1800. Married, first, Jean Robertson, probably daughter of James Robertson; married, secondly, September 28, 1788, Marion M'Kechnie, Stirling (*Glasgow Marriages*), who died at Helensburgh, August 21, 1826 (*Glasgow Herald*, September 1, 1826); died between January 23, 1801, and November 6, 1801. Deacon of the Hammermen, 1785. "He purchased a small piece of ground and some old houses lying on the east side of

Stockwell Street, nearly opposite Jackson and there carried on his trade " (*Trades' House*, p. 268). Described as " Smith and ferrier, east side Stock-well " in 1787.

1777. (I. 182.)

225. JAMES BUCHANAN, writer, Glasgow.

Probably son of James B. (116). Director, 1781, 1782, 1783, 1784, 1785. Preses, 1786, 1787. Director, 1788, 1789, 1790. Only son of James Buchanan, member of the Maltmen Craft, November 23, 1759, who was of Easter Camlachie, 1750, and was Visitor of the Maltmen, 1769, 1770. Born about 1749; married, April 29, 1777, Jean Leckie (*Glasgow Marriages*), widow of James Graham of the " Saracen's Head "; died, January 21, 1793, aged 44 (*Scots Magazine*, vol. 55, p. 51; *Burials, High Churchyard*). His wife died, October 16, 1792 (*Scots Magazine*, vol. 54, p. 519). They carried on the " Saracen's Head " until their failure in 1791 (see *Glasgow Past and Present*, 1884, vol. i. p. 344, etc.). He is described as " Vintner " in 1781, as " now of Polmadie " in 1785, and as " of Polmadie, maltman," in 1789. He became a member of the Maltmen Craft, August 7, 1777 (*Maltmen Craft*, p. 104), when he is described as " writer " (*Minute Book of the Maltmen*). Was Visitor of the Maltmen, 1783, 1784. The Society made a grant to him January 18, 1793, three days before his death. Agnes Buchanan, wife of James Fisher in Campsie, and described as sister to James Buchanan, " Saracen's Head," was enrolled a pensioner in 1801.

1777. (I. 183.)

226. JOHN BUCHANAN, Doctor of Medicine in Buchanan, son to Gartincaber.

Brother of James B. (200), and Andrew B. (241). Third son of George Buchanan in Creitchael by Mary Scot. Baptized, November 14, 1727 (*Buchanan Baptisms*). Described as brother of the late James Buchanan

of Gartincaber, he is mentioned as a witness, April 17, 1779 (*Argyll and Dunbartonshire Sasines*, vol. ii. fol. 422). Acquired Provanhill. Died, Dec. 6, 1809.

1777. (I. 183.)

227. JOHN BUCHANAN of Croy.

Brother of Thomas B. (215), James B. (245), and George B. (268). Eldest son of William Buchanan of Little Croy and Margaret Wright. Baptized, January 18, 1744 (*Killearn Baptisms*); died in 1800. He had a son, John, who had a grant from the Society in 1823. See *Strathendrick*, p. 342.

1777. (I. 183.)

228. ISAAC BUCHANAN in Gartfairn.

Father of William B. (334). Father-in-law of Andrew B. (241), and Peter B. (258). Second son of John Buchanan in Gartfairn by Elizabeth MacFarlane, daughter of George MacFarlane, which John Buchanan in Gartfairn was second son of John Buchanan, first of Little Croy (or Croy-Buchanan). Baptized, October 9, 1737 (*Buchanan Baptisms*); married, first, before 1764, Catherine Foster (*Ibid.*), who died before 1767; married, secondly, 1767, Margaret Miller (*Buchanan Proc. of Marriages*, July 26, 1767), who died, November 6, 1775, aged 31 (*Buchanan Tombstones*); married, thirdly, about July, 1782, Jean Risk, daughter of William Risk in Drumbeg (*Drymen Proc. of Marriages*, June 27, 1782). He acquired a portion of the lands of Aucheneck in 1784 (*Strathendrick*, p. 215). In 1785 he is mentioned as having a tack of the lands of Auchmar for 19 years from Martinmas, 1782, at a rent of £80. He was still in Wester Gartfairn in 1790.

1778. (I. 188.)

229. MOSES BUCHANAN of Glins.

Son of John B. (143). Son of John Buchanan of Glins by Christian Watson. Born, August 13, 1755 (*Balfron Baptisms*). Succeeded his father in 1764. The lands of Colquhoun-Glins with the superiorities of Easter Glins and Wester Culmore as lately belonging to Mr. Buchanan of Glins were advertised to be sold on the 2nd October, 1782 (*Glasgow Mercury*, September 26, 1782). See *Strathendrick*, p. 348 n.

1779. (I. 190.)

230. ANDREW BUCHANAN of Mount Vernon, son of deceased George Buchanan of Mount Vernon, merchant in Glasgow.

Son of George B. (170). Brother of David B. (267). Director, 1783, 1784, 1785, 1786, 1788, 1789. Preses, 1790, 1791. Director, 1792, 1793, 1794. Born, July 11, 1751 (*Glasgow Baptisms*); died, s.p. May 31, 1795 (*Scots Magazine*, vol. 57, p. 411). Succeeded his father in Mount Vernon. See *Old Country Houses*, 1878, p. 189.

1780. (I. 195.)

231. JOHN BUCHANAN, merchant, Glasgow, eldest son of George Buchanan of Arden, merchant there.

Son of George B. (122). Director, 1781, 1782, 1783. Brother of Herbert B. (219). Born, February 28, 1748 (*Glasgow Baptisms*); died, s.p. abroad in 1790, his testament dative being recorded, September 17, 1791 (*Edinburgh Com. Rec. Tests*, vol. 128). Succeeded his father in Arden in 1786. See *Genealogical Magazine*, vol. iv. p. 529).

1781. (I. 199.)

232. JOHN BUCHANAN, merchant, Glasgow, youngest son of deceased George Buchanan of Auchintoshan.

Son of George B. (126). Brother of George B. (205), and Neil B. (216). Baptized, November 1, 1744 (*Old Kilpatrick Baptisms*). Described in *Directory* of 1783 as "John, of Auchintoshan, Trongate." Is not in *Directories* of 1787 or 1789.

1782. (I. 206.)

233. GEORGE BUCHANAN, youngest, merchant, Glasgow, youngest son of Bailie George Buchanan, brewer in Glasgow.

Son of George B. (148). Brother of Thomas B. (254). Father of George B. (302). Director, 1787, 1788, 1789, 1790, 1791. Preses, 1792, 1793. Director, 1794, 1795, 1796, 1797, 1799, 1800, 1801. Married, February 20, 1784, Helen Gilzian, daughter of the deceased Thomas Gilzian (*Glasgow Marriages*); died at Woodside, May 24, 1802 (*Scots Magazine*, vol. 64, p. 616). His widow died at 24 Stafford Street, Edinburgh, May 6, 1837 (*Glasgow Herald*, May 15, 1837). He was brother-in-law of Allan Scott, merchant in Glasgow, 1795, who married Margaret Buchanan, and was father of Jean Scott, wife of James Farie, younger, of Farne (see Patrick Robertson's *Scroll Disposition Book*). Was member of the Merchants' House, 1788, and Bailie, 1797. Address, "Argyle Street," 1787; "West Stair, Robertson's Court, Argyle Street," 1789. Was probably the George Buchanan, junior, whose share in the Tontine, 1781, was on the life of George Buchanan, son of Thomas Buchanan, merchant, New York.

1783. (I. 217.)

234. JOHN BUCHANAN, manufacturer in Paisley.

A John Buchanan, manufacturer in Paisley, is described in June, 1800, as "deceased" (see *Edinburgh Magazine*, vol. xv. p. 476). [This John Buchanan was the only son of John Buchanan (7), maltman, Glasgow, married Jean Brown, and was the father of John Buchanan (319), wood merchant.]

1783. (I. 218.)

235. JAMES BUCHANAN, merchant in Glasgow, youngest son of the deceased George Buchanan, farmer in Finnick.

Father of George B. (347), Thomas B. (344), James B. (357), John B. (368). Uncle of George B. (300), John B. (310), George B. (301), Benjamin B. (329). John B. (311), James B. (333). Director, 1787, 1788, 1789, 1790, 1791, 1796, 1797, 1798, 1799. Preses, 1800, 1801. Director, 1802, 1803, 1804, 1805, 1806. Described as "of Craikston," he was Preses, 1807, 1808; as "of Dowanhill," he was Director, 1809, 1810, 1811, 1812, 1813, 1814; Preses, 1815, 1816; Director, 1817, 1818, 1819, 1820; Preses, 1821, 1822; Director, 1823, 1824, 1825, 1826, 1827, 1828; Preses, 1829, 1830; Director, 1831, 1832, 1833, 1834, 1835; Honorary Director, November 4, 1836. Sixth son of George Buchanan in Finnick-Drummond. Born, March 14, 1756; married, February 9, 1801, Ellison M'Callum (born about 1770), daughter of Daniel M'Callum, merchant (*Scots Magazine*, vol. 63, p. 151; *Glasgow Marriages*), who died, October 15, 1842 (*Glasgow Herald*); died, April 13, 1844. Was of the firms of Buchanan, Steven & Co., and Dennistoun, Buchanan & Co., West India Merchants. Member of the Merchants' House, 1790. "Of Finnick, merchant, north side, Trongate, opposite the church," 1787; "counting room, 3rd flat above No. 111 Trongate,"

1789. " Buchanan, Steven & Co., wholesale linen warehouse, Buchanan's back land, Trongate, by No. 120," 1789. See *Strathendrick*, p. 344; and *Trades' House*, pp. 268, 269, 270.

1784. (I. 224.)

236. ALEXANDER BUCHANAN, Capt. in His Majesty's Ninth Regiment of Foot, son of the deceast John Buchanan, junr., writer in Glasgow, who was late Clerk to the Society.

Son of John B. (145). In February, 1795, he was promoted to be Lieutenant-Colonel in the 116th Foot (*Scots Magazine*, vol. 57, p. 136). He was probably the General Buchanan who died before December 16, 1806, having succeeded his sister-german, Wallace Buchanan, in some property in Trongate. He left this by will to his half-sister, Mary Buchanan, wife of George Graham, writer in Edinburgh, but, as the result of a lawsuit, she had to denude in favour of Neil and William Snodgrass, relations of the mother of Miss Wallace Buchanan and the General (see Morrison's *Decisions*, vol. xvii. App. I. p. 1; *Services of Heirs*, Snodgrass against Buchanan).

1785. (I. 227.)

237. WILLIAM BUCHANAN, wright in Glasgow, only son of Archibald Buchanan, wright in Glasgow.

Probably son of Archibald B. (182). Baptized, June 3, 1750 (*Glasgow Baptisms*).

1785. (I. 231.)

238. PETER BUCHANAN of Silverbanks.

Son of Archibald B. (12). Father of Peter B. (244). Brother of George B. (203), and Andrew B. (204). Born,

January 30, 1735 (*Glasgow Baptisms*) ; married Catherine Macpherson (*Commoners*, vol. iii. p. 656) ; died, November 1, 1789 (*Glasgow Mercury*) [but, according to *Scots Magazine* (vol. 51, p. 571) November 2]. His testament was recorded, October 19, 1790 (*Glasgow Com. Rec. Tests.*). Succeeded his father in 1761 in Hillington and Auchentorlie (including Silverbanks).

1785. (I. 231.)

239. GEORGE BUCHANAN, saddler in Glasgow, second son of John Buchanan, ferrier in Glasgow.

Probably son of John B. (146), and brother of Alexander B. (224). "Trongate, No. 77," in 1787.

1786. (I. 233.)

240. JOHN BUCHANAN of Auchlechy.

Grand-nephew of Alexander B. (106). Father of Alexander B. (331), and grandfather of John B. (435). Married, 1764 (*Kilmadock Proclamations*, November 3, 1764), Murray Kynymound Edmondstoune, daughter of Patrick Edmondstoune of Newton, who died, May 16, 1808 (*Scots Magazine*, vol. 70, p. 479) ; died, February 5, 1817 (*Ibid.* vol. 79, p. 239). Succeeded as heir-male to Francis Buchanan of Arnpryor's estate of Strathyre when the latter's forfeited estates were restored to the family in 1785. Acquired the lands of Cambusmore and others. See *Strathendrick*, p. 302 ; and *Landed Gentry*.

1786. (I. 233.)

241. ANDREW BUCHANAN from Jamaica, son of George Buchanan, late of Gartincaber.

Brother of James B. (200), and Dr. John B. (226). Son of George Buchanan in Creitchael and Mary Scot. I cannot find that his father was ever "of Gartincaber,"

but his elder brother James was. Baptized, April 21, 1733 (*Buchanan Baptisms*); married Jean Buchanan (baptized, May 26, 1773), daughter of Isaac Buchanan in Gartfairn by his wife, Margaret Miller (*Ibid.*); died, March 20, 1815 (*Scots Magazine*, vol. 77, p. 399). In 1789 he acquired the lands of Auchmar, subject to redemption, his title being made absolute in 1803, when he re-sold them to his wife's brother-in-law, Peter Buchanan. Moses Buchanan, farmer in Laigh Park, his nephew, was second heir general to him, February 28, 1821. Moses Buchanan was son of his sister Margaret Buchanan, who had married Thomas Buchanan in Creitchael of the Little Croy family. See *Strathendrick*, pp. 342 n., 375, 376.

1786. (I. 237.)

242. GEORGE BUCHANAN, merchant in Glasgow, fourth son of James Buchanan of Carston.

Son of James B. (187). Brother of John B. (222), James B. (279) and Archibald B. (287). Father of James B. (316), and George B. (317). Director, 1802, 1803, 1804, 1805, 1806, 1807, 1808. Preses, 1809, 1810. Director, 1811, 1812, 1813, 1814, 1815, 1816, 1818, 1819, 1820, 1821, 1822. Fifth son of James Buchanan of Carstoun. Baptized, May 20, 1755 (*Killearn Baptisms*); married, January 6, 1783, Jean Miller, daughter of the deceased John Miller, merchant (*Glasgow Mercury*, January 9, 1783); died, February 10, 1840. Married, first, Elizabeth Lapsley (born about 1733), who died in December, 1770, aged 37, and was buried on the 31st in the High Churchyard (*Burial Registers*); married, secondly, October 11, 1771, Agnes Templeton, daughter of William Templeton, maltman (*Glasgow Marriages*). A James Buchanan, upholsterer, was admitted Burgess and Gild Brother, September 15, 1769.

244. PETER BUCHANAN, of the 74th Regt. of Foot, son of Peter Buchanan of Silverbanks.

Son of Peter B. (238). Probably died before November, 1789.

245. JAMES BUCHANAN, farmer in Croy, brother-german of John Buchanan of Croy.

Brother of John B. (227), Thomas B. (215), and George B. (268). Son of William Buchanan of Little Croy. Born, 1756; married, December, 1778, Jean Buchanan, daughter of George Buchanan in Finnick Drummond (*Drymen Proclamations*); died, 1806. His widow, who was born in 1751, died at Killearn, September 13, 1836 (*Glasgow Herald*, September 16, 1836). See *Strathendrick*, p. 342.

246. DANIEL M'MILLAN, shoemaker, Glasgow.

In King's Street in 1783, 1787, and 1789. "Shop, west side King's-street, opposite Prince's-street" (*Directory*, 1787).

1788. (I. 251.)

247. JOHN BUCHANAN, merchant in Glasgow, son of deceast William Buchanan, horse setter there.

Son of William B. (176). If he was the Treasurer of 1802-1811, he was born about 1738, and died in Dunlop Street, July 5, 1811, in the 74th year of his age (*Scots Magazine*, vol. 73, p. 638). 34 Dunlop Street, 1807 (*Directory*). Described as manufacturer, the Treasurer was a Director, 1793, 1794, 1795, 1796, 1797. Preses, 1798, 1799. Director, 1800, 1801. Treasurer, 1802-1811.

1789. (I. 253.)

248. DUNCAN BUCHANAN, late of India, brother-german of James Buchanan of Catter.

Son of John B. (9). Father of John B. (284), and James B. (263). Director, 1789, 1790, 1791, 1792, 1795. Second son of John Buchanan, second of Catter. Born, June 2, 1738; married Jane de Morgan, widow of — Maitland (born about 1743; died, February 9, 1818); died, February 18, 1809 (*Scots Magazine*, vol. 71, p. 239). Surgeon, H.E.I.C.S., Madras. See *Genealogical Magazine*, vol. ii. pp. 359, 500.

1789. (I. 253.)

249. JOHN LECKIE, writer in Glasgow, eldest son of William Leckie of Broich (Honorary Member).

Grandson of John B. (9). Secretary to the Society, 1803-1814. His mother was Janet Buchanan, daughter of John Buchanan, first of Catter. "Head Ingram's closs, Gallowgate" (*Directory*, 1789). Died at Largs, July 10, 1814 (*Scots Magazine*, vol. 76, p. 718).

250. JOHN BUCHANAN, [Agent Sun Fire Office, Glasgow,] lawful son of William Buchanan, merchant in Glasgow.

Probably son of William B. (166). Father of John Gabriel B. (320). Married, October 21, 1787, Catherine Gordon, daughter of William Gordon of the Academy, Edinburgh (*Glasgow Marriages*); died, September 29, 1806 (*Scots Magazine*, vol. 68, p. 808). Besides John Gabriel, they had another son, William Gordon, born, January 18, 1789, when John Buchanan is described as "junr. mercht." (*Glasgow Baptisms*). His widow, Catherine Gordon, seems to have carried on the agency of the Sun Fire Insurance until her death, May 22, 1821 (*Scots Magazine*, vol. 87, p. 592). She was at 48 Trongate in 1807, and in Melville Place in 1818.

251. JOHN BUCHANAN of Ardoch, hatter in Glasgow, eldest son of the deceased Thomas Buchanan, Esq., of Ardoch, hatter in Glasgow.

Son of Thomas B. (177). Father of John B. (340). Brother of James B. (257), Robert B. (313), and Thomas Grahame B. (376). Director, 1791, 1792, 1793. Preses, 1794, 1795. Director, 1796, 1797, 1798, 1816. Preses, 1817, 1818. Director, 1819, 1820, 1821, 1822, 1823, 1824. Preses, 1825, 1826. Director, 1827, 1828, 1829, 1830. Preses, 1831, 1832. Director, 1833, 1834, 1835, 1836, 1837. Honorary Director for life, 1838. Son of Thomas Buchanan of Ardoch by his first wife, Margaret Buchanan. Born, January 8, 1761; married, November 1, 1785, Elizabeth Parkes, third daughter of John Parkes of Netherton, Co. Worcester (born, March 13, 1765; died, September 4, 1807); died, June 26, 1839. Succeeded his father in Ardoch, Ballochruin, and Dalmarnock in 1789. Bailie, 1793. Treasurer of the City

of Glasgow, 1799. M.P. for Dunbartonshire, 1821-1825.

252. JOHN BUCHANAN, staymaker in Glasgow.

Married, September 12, 1790, Henrietta Martin (*Glasgow Marriages*). Christian Alexander, widow of John Buchanan, staymaker, was a pensioner of the Society, 1810 to about 1823. "John Buchanan, staymaker, Saltmarket," 1783; "Moodie's Wynd, facing Black-bull, Argyle-street," 1789 (*Directories*). John Buchanan, staymaker, was admitted Burgess and Gild Brother, July 15, 1789, but there was another John Buchanan, staymaker, who had been admitted, September 19, 1770. Grizel Buchanan, daughter of John Buchanan, staymaker, had grants from the Society from 1803. Probably she was daughter of the earlier John Buchanan.

253. ROBERT BUCHANAN, cotton spinner, Doune.

254. THOMAS BUCHANAN, merchant, New York, eldest son of Convener George Buchanan, maltman.

Son of George B. (148). Brother of George B. (233). He had a son, George, who was one of the lives in the Tontine (*Regality Club*, Series ii. p. 80).

1793. (I. 289.)

255. JAMES BUCHANAN, shoemaker, Glasgow, eldest son of Andrew Buchanan, shoemaker there.

"Shoe shop, south side Prince's-street" (*Directory*, 1789). Married, probably, Janet Buchanan, who as

“ relict of James Buchanan a member ” received a grant from the Society, Nov. 8, 1797.

1794. (I. 291.)

256. WILLIAM BUCHANAN of Auchmar, son of deceased Alexander Buchanan of Auchmar.

Grandson of William B. (48 and 123). Son of Alexander Buchanan of Auchmar by Christian Campbell. Baptized, February 3, 1749 (*Buchanan Baptisms*) ; married, July 5, 1796, Sarah Bartlet, second daughter of Benjamin Bartlet, storekeeper, Edinburgh Castle (*Scots Magazine*, vol. 58, p. 505). Was drowned in the River Delaware, North America, in May, 1799, his testamentative being recorded, July 2, 1800 (*Edinburgh Com. Rec. Tests.* vol. 131, pt. 2). He was a partner in Archd. Ewing & Co., muslin manufacturers and merchants, and William Buchanan & Co., commission merchants (*Testament*). Sold Auchmar to Andrew Buchanan in 1789. See *Strathendrick*, p. 375.

257. JAMES BUCHANAN, hatter in Glasgow, second son of the deceased Thomas Buchanan, Esq., of Ardoch, hatter in Glasgow.

Son of Thomas B. (177). Father of Thomas B. (366). Brother of John B. (251), Robert B. (313), and Thomas Grahame B. (376). Director, 1796, 1797, 1798, 1799, 1803, 1804. Preses, 1805, 1806. Director, 1807, 1808, 1809, 1810, 1811. Son of Thomas Buchanan of Ardoch by his second wife, Jean Gray. Born, June 17, 1766 ; married, July 9, 1798, Anne Parkes, youngest daughter of John Parkes of Netherton, Co. Worcester (born, October 10, 1770 ; died, September 27, 1844) ; died, August 12, 1855. Assumed the additional surname of “ Gray ” on succeeding to his cousin, John Gray of

Eastfield and Scotstoun. Acquired Ardoch from his half-brother, Robert Buchanan, in 1847. See *Strathendrick*, p. 357.

258. PETER BUCHANAN, manufacturer in Glasgow, lawful son of the deceased John Buchanan, farmer in Ardewie, parish of Buchanan.

Father of Peter B. (355), and Isaac B. (384). Son-in-law of Isaac B. (228). Brother of John B. (271). Director, 1816, 1817, 1818, 1819, 1820, 1821. Son of John Buchanan in Arduil and Margaret Ferguson. Baptized, May 23, 1760 (*Buchanan Baptisms*); married, September 8, 1800, Margaret Buchanan (*Glasgow Marriages*), daughter of Isaac Buchanan in Gartfairn and Margaret Miller, his wife, who was baptized, November 22, 1775 (*Buchanan Baptisms*); died at 13 North Hanover Street, Glasgow, April 17, 1826 (*Scots Magazine*, vol. 97, p. 768). Acquired Auchmar in 1803. Described as "manufacturer, 71 Hutcheson Street," in 1807 (*Directory*). See *Strathendrick*, pp. 342 n., 376.

259. GEORGE BUCHANAN, cloathlapper in Glasgow, son of William Buchanan in Ballanton.

Father of William B. (325), Allan B. (326), Moses Steven B. (339), and John B. (356). Director, 1800, 1801, 1802, 1803, 1804, 1805, 1810. Treasurer, 1811-1821. Baptized, September 4, 1756 (*Kilmaronock Baptisms*); married, first, January 18, 1789, Isabella Stevenson, daughter of Allan Stevenson (*Glasgow Marriages*); secondly, September 20, 1808, Helen Taylor of Dunse (*Ibid.*); died at West George Street, Glasgow, May 24, 1821 (*Scots Magazine*, vol. 88, p. 94). Became a member of the Merchants' House, 1803. Was of the firm of George Buchanan & Sons, calenderers—as George

Buchanan & Co. at 31 Candleriggs, 1803—38 Candleriggs, 1807; as George Buchanan & Sons at 36 Candleriggs in 1818; Buchanan, Brown & Co., are at 36 Candleriggs in 1813, 1815, and 1818. Walter Buchanan in Cameron, eldest son of William Buchanan in Cameron, 1723 (Auchmar, p. 76), had three sons, the youngest of whom was William Buchanan in Merkins, 1750 (John Buchanan, *Dougalston's Papers*). He was in Merkins, 1744-1750 (*Kilmaronock Session Records*), and in Blairanich, 1753, 1756 (*Ibid.*). He married, before 1744, Rebecca Buchanan (mentioned as widow of William Buchanan in Balantone in 1787), and was father of George Buchanan, the Treasurer (259). Rebecca Buchanan is probably identical with Rebecca, daughter of George Buchanan of Blairlusk (61), who was baptized, April 29, 1719 (*Kilmaronock Session Records*), and is mentioned in Mr. John Buchanan's papers as married before June 6, 1747. See *Strathendrick*, pp. 323, 343, which is, however, in error in making William Buchanan in Merriland, 1729, identical with William Buchanan in Merkins, 1750, and also in making George Buchanan, the Treasurer, son of John Buchanan of Blairennich.

260. JAMES LAPSLIE BUCHANAN, merchant in Glasgow, eldest lawful son of Thomas Buchanan of Croy, merchant in Glasgow.

Son of Thomas B. (215). Born, April 9, 1774 (*Glasgow Baptisms*); died at Croy, July 24, 1801 (*Scots Magazine*, vol. 63, p. 588). See *Strathendrick*, p. 342.

1796. (I. 312.)

261. DUNCAN BUCHANAN, manufacturer in Glasgow, lawful son of Archibald Buchanan, manufacturer and feuar in Callander of Menteith.

Perhaps father of Alexander James B. (318).

1796. (I. 312.)

262. ARCHIBALD BUCHANAN, now of Auchintorlie, nephew of the late George Buchanan of Auchintorlie, and eldest son of Andrew Buchanan of Ardenconnal.

Son of Andrew B. (204). Father of Andrew B. (382), Richard Dennistoun B. (413). Brother of James B. (280). Director, 1807, 1808, 1809, 1810. Preses, 1811, 1812. Director, 1813, 1814, 1815, 1816, 1817, 1818, 1820, 1821, 1822. Preses, 1823, 1824. Honorary Director, 1828. Director, 1829, 1830, 1831, 1832. Born, 177—; married, June 3, 1816, Mary Dennistoun, second daughter of Richard Dennistoun of Kelvingrove; died, December 16, 1832. Succeeded his uncle George in Auchintorlie and Hillington. See Burke's *Landed Gentry*. One of the original members of the Western Club.

263. JAMES BUCHANAN, merchant in Glasgow, second lawful son of Dr. Duncan Buchanan, late of India.

Son of Duncan B. (248). Brother of John B. (264). Director, 1805, 1806. Born about 1773; died, unmarried, at 68 West Regent Street, Glasgow, February 7, 1838 (*Glasgow Herald*, Feb. 9, 1838). "James Buchanan, tertius, cotton yarn merchant"; "62 Hutcheson Street, lodging, St. Enoch Square," 1803; "11 Cochrane Street," 1807; "Madeira Court," 1813, 1815, 1818. Nicknamed "The Breeze." See *Genealogical Magazine*, vol. ii. p. 359.

1797. (I. 317.)

264. JOHN BUCHANAN, merchant in Glasgow, eldest son of said Dr. Duncan Buchanan.

Son of Duncan B. (248). Brother of James B. (263). Father-in-law of Andrew B. Yuille (361). Grandfather

of John B. (458), Andrew Yuille B. (459), and Patrick Robertson B. (478). Director, 1801, 1802, 1803, 1804. Described in 1803 and thereafter as "late manufacturer now Captain Renfrewshire Militia," and also so in the record of his second marriage. Born about 1768; married, first, Anna Maria Rose, who died, March 17, 1797 (*Edinburgh Magazine*, vol. ix. p. 321); secondly, August 27, 1804, Helen Yuille (*Bonhill Marriages*), daughter of George Yuille of Darleith (born about 1776; died, December 17, 1865); died, October 21, 1836, probably at 45 Melville Street, Edinburgh. Succeeded his uncle, James Buchanan, in Catter, which he sold to the Duke of Montrose. Described as "junior, merchant, St. Enoch Square," in 1797. See *Genealogical Magazine*, vol. ii. pp. 359, 500.

1797. (I. 324.)

265. JOHN BUCHANAN, merchant in Paisley, second lawful son of Robert Buchanan, late merchant in Paisley.

Son of Robert B. (195). Brother of James B. (270). Born, December 27, 1763 (*Abbey Baptisms*); died before October 8, 1835. His youngest son, William, was the Society's Bursar in 1835, and took his B.A. at Glasgow, 1840. He married Jean Buchanan, who was enrolled a pensioner in November, 1835, and died before August, 1848.

266. JOHN BUCHANAN of Ladrishmore, eldest son of John Buchanan, farmer in Ladrishmore, and nephew of John Buchanan of Ladrishmore.

Nephew of John B. (184). Eldest son of John Buchanan by Jean Buchanan, his wife, sister of John Buchanan of Ladrishmore. His parents were in Meikle Tillichewn at the time of his birth, but had removed to Ladrishmore

before 1770. Baptized, July 6, 1767 (*Bonhill Baptisms*) ; married Mary Ann Snodgrass, and had at least one child, Ann Graham Buchanan, born, August 2, 1797 (*Glasgow Baptisms*), who died, February 17, 1804 (*Scots Magazine*, vol. 66, p. 159) ; died at Hutchesontown, Glasgow, May 31, 1821 (*Ibid.* vol. 88, p. 94). His widow married, secondly, October 4, 1824, Thomas Galbraith Logan, M.D., Surgeon, 5th Dragoon Guards (*Ibid.* vol. 94, p. 639). He was served heir-of-line and provision general to his uncle, John Buchanan of Ladrishmore, August 29, 1794. In 1796 he had a charter of the lands of Little Tilliechewan, which he sold in 1806 (*Chiefs of Colquhoun*, vol. ii. p. 171). He sold the lands of Ladrishmore to John Buchanan of Ardoch, March 27, 1815 (Mr. J. Guthrie Smith's notes).

267. DAVID BUCHANAN of Mount Vernon, brother of the late Andrew Buchanan of Mount Vernon, and lawful son of the deceased George Buchanan of Mount Vernon.

Second son of George B. (170). Brother of Andrew B. (230). Father of Robert Carrick B. (337), and Andrew B. (338). Director, 1808, 1809, 1810, 1811, 1812. Preses, 1813, 1814. Director, 1815, 1816, 1817, 1818, 1819. Born, December 3, 1760 (*Glasgow Baptisms*) ; married, May 29, 1788, Marion Gilliam, daughter of James Gilliam of Mount Alta, Virginia, who died at Brighton, July 23, 1800 (*Edinburgh Magazine*, vol. xvi. p. 167) ; died at Drumpellier, May 20, 1827 (*Services of Heirs*). Virginia merchant. Bought back Mount Vernon about 1800, and Drumpellier in 1808. Assumed the additional surname of " Carrick " in 1821, on succeeding to the bulk of Robert Carrick's fortune. See Burke's *Landed Gentry* ; and *The Old Country Houses of the Old Glasgow Gentry*, 1878, p. 179.

1797. (I. 324.)

268. GEORGE BUCHANAN, merchant, Glasgow, youngest son of deceased William Buchanan of Croy.

Brother of Thomas B. (215), John B. (227) and James B. (245). Son of William Buchanan of Little Croy by Margaret Wright. Baptized, July 20, 1762 (*Killearn Baptisms*). Was probably the George Buchanan, late of Glasgow, who died at Easterton, Killearn, January 16, 1833 (*Glasgow Herald*, January 18, 1833). Enrolled as a pensioner in 1813, and died between Nov. 1832 and Feb. 1833. See *Strathendrick*, p. 342.

1798. (I. 325.)

269. ALEXANDER BUCHANAN of Campbeltown, ship-master.

Son-in-law of William B. (153). Died at Campbeltown, September 19, 1818 (*Scots Magazine*, vol. 82, p. 391). He seems to have married Mary Buchanan, a daughter of William Buchanan of Torrie (see *Services of Heirs*, December 1, 1819).

1798. (I. 332.)

270. JAMES BUCHANAN of Northbar, eldest lawful son of Robert Buchanan, late merchant in Paisley.

Son of Robert B. (195). Brother of John B. (265). "Merchant in London, now at Paisley," June 14, 1797 (*Glas. Com. Rec. Tests*, vol. 73, p. 569). Was served heir portioner general to his grandfather, Robert Corse of Walneuk, and to his uncle, Robert Corse of Greenlaw, December 22, 1798 (*Services of Heirs*). Born, August 11, 1758 (*Abbey Baptisms*); married, September 28, 1795, Margaret Orr, daughter of deceased Robert Orr, merchant in Paisley (*Edinburgh Magazine*, vol. vi. 321); died,

March 24, 1832 (*Glasgow Herald*, April 6, 1832). He had an only son, Robert Corse, born about 1796; died, July 21, 1809 (*Scots Magazine*, vol. 71, p. 640), also three daughters: (1) Frances, born, November 21, 1797 (*Abbey Baptisms*), Mrs. Gibson; died, s.p. (2) Agnes, born, Oct. 17, 1799 (*Ibid.*); married, August 14, 1826, Capt. R. M. Kirk (*Glasgow Herald*, August 18, 1826), and had issue. And (3) Janet (Jessie), married, August 16, 1841, the Rev. John Macnaughton of the High Church, Paisley (*Services of Heirs*; *Glasgow Herald*, August 23, 1841); died, s.p. His relict (born about 1774) died at Duncairn House, Belfast, January 16, 1858, in her 85th year (*Glasgow Herald*, January 22, 1858). Acquired Northbar in 1798, which he sold about 1812. Was of Brabloch in 1818 (Crawford's *Renfrewshire*, Robertson's edition, pp. 314, 382).

271. JOHN BUCHANAN, shopkeeper, Glasgow, lawful son of deceased John Buchanan, farmer in Ardowie, parish of Buchanan.

Brother of Peter B. (258). Son of John Buchanan in Arduil and Margaret Ferguson. Baptized, July, 1762 (*Buchanan Baptisms*).

1799. (I. 342.)

272. JOSEPH M'AUSLAND, farmer, Tomavoulin, Luss.

1799. (I. 342.)

273. HECTOR M'DONALD BUCHANAN of Drumiekilln, W.S.

Great grandfather of Sir A. W. Leith-B. (553). Third son of Coll. Macdonald of Boisdale. Married, July 13, 1793, Jean Buchanan of Drumikill and Ross (*Scots Magazine*, vol. 55, p. 359); died, September 14, 1828 (*History*

of the W.S. Society, p. 28). Assumed the name of Buchanan on his marriage. His wife was baptized, September 15, 1770 (*Kilmaronock Baptisms*); and died, February 8, 1852 (*Glasgow Courier*, Feb. 10, 1852). Besides daughters, they had five sons: (1) Colin, died at Avignon, April 23, 1818 (*Scots Magazine*, vol. 81, p. 597); (2) Hector, Cornet in the Madras Cavalry, died at Bombay, October 22, 1819 (*Ibid.* vol. 85, p. 486); (3) John, died at Gibraltar, May 11, 1823 (*Ibid.* vol. 92, p. 128); (4) James Graham, died at Floriana, Malta, May 20, 1828 (*Glasgow Herald*, June 23, 1828); (5) another son died young. The sons all died unmarried.

274. JOHN BUCHANAN, manager of the Kincaid Print-field, Campsay.

Born about 1748; married Margaret M'Donald; died, Nov. 7, 1818 (*Campsie Registers*). The *Scots Magazine* (vol. 83, p. 96) gives the date of death as December 7.

275. THOMAS BUCHANAN, farmer, Gartocharn, second son of deceased Alexander Buchanan of Gartocharn.

Nephew of Thomas B. (188). Half-brother of Walter B. (324). Son of Alexander Buchanan of Gartocharn by Elizabeth M'Allister. Baptized, February 3, 1756 (*Drymen Baptisms*). Enrolled as a pensioner in 1815. Pension increased in 1820, when he is described as "late in Gartocharn now in Woodside." He died in 1830 (between February and May). Not mentioned by Mr. Guthrie Smith; but see *Strathendrick*, p. 305.

276. ANDREW BUCHANAN, jun., manufacturer, Glasgow, second son of Andrew Buchanan, yarn merchant in Glasgow.

Grandson of Walter B. (4). Father of Walter B. (351), and Andrew B. (352). Brother of Walter B. (284). Director, 1804, 1805, 1806, 1807, 1808, 1809. Married, September 22, 1794, Margaret Cockburn, daughter of James Cockburn, merchant in Edinburgh (*Glasgow Marriages*). She died at Morningside House, Edinburgh, October 21, 1815 (*Scots Magazine*, vol. 77, p. 880). Of Buchanan, Falconer & Co., Baltic Merchants. See *Strathendrick*, p. 298; *One Hundred Glasgow Men*, vol. i. p. 57.

1800. (I. 349.)

277. WILLIAM BUCHANAN, son of William Buchanan, farmer, Drumbeg, Killearn.

1801. (I. 357.)

278. ARCHIBALD BUCHANAN, manufacturer, lately from Callander, now in Glasgow.

Director, 1806, 1807. Disqualified in 1808 from being a Director for not residing in Glasgow. He seems, however, afterwards to have been of service to the Society in looking after the pensioners resident in the neighbourhood of Callander. An Archibald Buchanan died at Mansfield, Callander, February 9, 1827 (*Glasgow Herald*, Feb. 26, 1827).

279. JAMES BUCHANAN, merchant, Glasgow, second son of James Buchanan of Carston.

Born about 1775; married, at Edinburgh, May 10, 1805, Lady Janet Sinclair, eldest daughter of James, twelfth Earl of Caithness (*Scots Magazine*, vol. 67, p. 563); died, at 31 Charlotte Square, Edinburgh, December 21, 1860 (*Glasgow Herald*, Dec. 25, 1860). Lady Janet died, February 24, 1867. Acquired Ardenconnal from his father in 1811, which he sold in 1827. See Burke's *Commoners* and *Landed Gentry*.

284. THE REV. WALTER BUCHANAN, one of the ministers of the Canongate, Edinburgh, son of Andrew Buchanan, merchant in Glasgow.

Brother of Andrew B. (276). Uncle of Walter B. (351), and Andrew B. (352). Born about 1756; married, February 22, 1785, Margaret Scobie (who died, July 27, 1847); died, December 6, 1832. Minister of Second Charge, Stirling, 1780; Canongate, 1789; D.D. Edinburgh, 1805. See Scott's *Fasti*, Part i. p. 90; iv. p. 679; Kay's *Original Portraits*, 1877, vol. ii. p. 152.

285. WILLIAM BUCHANAN, painter, Glasgow, son of Robert Buchanan, mason there.

Born, December 8, 1765 (*Glasgow Baptisms*); married, September 23, 1787 (*Glasgow Marriages*), Elizabeth M'Farlane, daughter of Parlane M'Farlane, painter, Glasgow (see also *Services of Heirs*, June 26, 1829); died, August 27, 1828 (*Glasgow Herald*, Sept. 5, 1828). He seems to have been married a second time, as Mrs. Ann Trueman, relict of Mr. Buchanan, painter, died at 105 Montrose Street, February 25, 1835 (*Glasgow Herald*). William Buchanan, painter, 70 Hutcheson Street, 1803, 1807, house, 72 Brunswick Street,

1807, 1813; painter, 70 Hutcheson Street, house, head of Montrose, 1815, 1818 (*Directories*).

286. ARCHIBALD BUCHANAN, Callander, son of John Buchanan, elder of Corrochrombie, parish of Callander.

287. ARCHIBALD BUCHANAN of the cotton-spinning works at Catrine, seventh son of the late James Buchanan of Carston.

Son of James B. (187). Brother of John B. (222), James B. (279), and George B. (242). Father of James B. (363), John B. (364), and Archibald B. (387). Baptized, March 4, 1769 (*Killearn Baptisms*); married, first, November 20, 1797, Helen Robertson, daughter of the Rev. John Robertson, minister of Dunblane (*Edinburgh Magazine*, vol. x. p. 473; *Glasgow Marriages*), who died, September 13, 1807 (*Scots Magazine*, vol. 69, p. 799); married, secondly, December 4, 1809, Hannah Struthers (*Glasgow Marriages*), daughter of Robert Struthers of Greenhead, who was born about 1778, and died, October 5, 1856 (*Glasgow Herald*, Oct. 8, 1856); died, February 6, 1841 (*Ibid.* Feb. 8, 1841). Of the firm of James Finlay & Co.; was manager of Ballindalloch Cotton Mills for several years; was afterwards (by 1809) "of Catrine Bank." See *Strathendrick*, p. 339.

289. JOHN BUCHANAN, spirit-dealer, Gallowgate, son of William Buchanan, victualler, Glasgow.

Father of John B. (358), and Alexander B. (359). Married, January 6, 1800, Catherine Miller, daughter of William Miller of Slatefield (*Scots Magazine*, vol. 62, p. 71 ; *Glasgow Marriages*), who died in 1841 ; died at Slatefield, March 13, 1814 (*Glasgow Herald*, March 25, 1814).

290. ARCHIBALD BUCHANAN, manufacturer in Glasgow, second son of George Buchanan, merchant in Glasgow, who was brother of Mr. Buchanan of Balfunning.

291. THOMAS BUCHANAN, dyer in Glasgow, youngest son of Bernard Buchanan, drysalter in Glasgow.

Brother of William B. (297). Married, before 1806, Ann M'Gilvra (see *Glasgow Baptisms*). Was present at the meeting of the Society in 1831. "Of Dalmarnock Dyeworks."

292. JOHN BUCHANAN of Carbeth.

Son of John B. (202). Father of John B. (411). Born, 1755 ; married at Edinburgh, June 15, 1802, Margaret

Loch, second daughter of James Loch, late of the Exchequer (*Scots Magazine*, vol. 64, p. 614); died at Woodburn, near Kirkintilloch, January 31, 1825 (*Ibid.* vol. 95, p. 640). See *Strathendrick*, p. 349.

293. ALEXANDER BUCHANAN, manufacturer in Glasgow, son of James Buchanan in Kiershill, Balfron.

Son of James Buchanan and Elizabeth Fairly in Keirhill. Baptized, May 1, 1763 (*Balfron Baptisms*); died, November 8, 1827 (*Glasgow Herald*, November 16, 1827). Collector of Poor Rate. "Manufacturer 29 Brunswick street," 1807; "120 Argyle street," 1813, 1815, 1818 (*Directories*).

295. ALEXANDER BUCHANAN, manufacturer in Glasgow, son of Duncan Buchanan in Kilmahog.

Brother of Duncan (296). A. & D. Buchanan, manufacturers, 8 St. Andrew Square, 1807, 1813, 1815 (*Directories*). Alexander Buchanan of the Ballafuil Buchanans was father of Duncan Buchanan, whose son was Alexander, who died at Kilmahog in 1846, aged 78. Was the latter this Alexander?

296. DUNCAN BUCHANAN, manufacturer in Glasgow, brother of the preceding member.

Brother of Alexander B. (295). Probably father of Alexander James B. (318). Duncan Buchanan and

297. WILLIAM BUCHANAN, manufacturer of sugar of lead, Airdrie, eldest son of Bernard Buchanan, drysalter in Glasgow.

Brother of Thomas B. (291). His descent seems to be as follows: (I) Andrew Buchanan, married, February 2, 1673, Mary M'Adame (*Buchanan Marriages*). Was in Auchingyle in 1678 and 1682; was probably identical with Andrew Buchanan who was in Gartskey, 1716, and Auchingyle, 1717; and is described as father of John Buchanan, wright, in Auchingyle, 1720, when he was witness to a baptism; also father of James Buchanan in Reinaber, described as brother to John (see *Buchanan Baptisms*). (II) John Buchanan, married, August 27, 1713, Ann Ker (*Buchanan Marriages*), otherwise Keir or Kergioch (see *Buchanan Baptisms*). They had a son, Bernard. John is described as wright in Gartskey, 1716; in Bolimahae, 1717; wright in Auchingyle, 1720; in Tighcladdich of Auchingyle, 1723; in Auchingyle, 1725, 1728, 1731, 1734; in Bravaill in Auchingyle, 1738; and in Auchingyle, 1748. (III) Bernard Buchanan, baptized, September 22, 1717 (*Buchanan Baptisms*); married, before 1761, Ann M'Lean (see *Glasgow Baptisms*). Was still at Buchanan, September 22, 1748. Described as "drysalter, High Street," 1783. Does not appear in the *Directory* of 1787. Was dead before 1795. (IV) William Buchanan, married, April 30, 1804, Catherine Brown, Airdrie (*Scots Magazine*, vol. 66, p. 399; *New Monkland Proclamations*); died before July 7, 1819, when his son William was second heir.

Preses, 1839, 1840. Director, 1841, 1842. Son of John Buchanan and Isobel Miller. Baptized, May 27, 1772 (*St. Ninians Baptisms*); married, before 1804, Sarah Wingate; died at 111 St. Vincent Street, Glasgow, March 18, 1843 (*Glasgow Herald*, March 20, 1843). He had a daughter, Jessie, who married, June 3, 1834, William Wingate (*Ibid.* June 6, 1834). Of the firm of John and James Buchanan, Wine and Spirit Merchants, Spirit Cellars, 10 Princes Street, 1807 and 1818. By 1828 they had moved to 63 Stockwell Street, with their cellars at 25 Princes Street. John Buchanan's private address is given as 29 St. Vincent Street in 1828, and in 1832 as 111 St. Vincent Street.

300. GEORGE BUCHANAN, merchant, Glasgow, eldest son of deceased John Buchanan of Blairennich.

Nephew of James B. (235). Brother of John B. (310). Son of John Buchanan and Agnes Steven, daughter of Thomas Steven of Mid Cameron, who were married in April or May, 1772 (*Drymen Proclamations*). Baptized, March 9, 1780 (*Kilmaronock Baptisms*); died, June 5, 1827 (*Balfron Tombstones*). George Buchanan of Blair-ennich was residing in Calton, Glasgow, in 1796 (*Kilmaronock Heritors' Records*). In 1783 there was a John Buchanan, lawn and cambric manufacturer, in Calton. Was this John Buchanan of Blairennich father of George? See *Strathendrick*, p. 343, where, however, he is in error identified with George Buchanan, the Treasurer (259), who was of the Cameron family. [See 61.]

Baptized, June 15, 1782 (*Drymen Baptisms*); died, September 6, 1832 (*Glasgow Herald*, Sept. 10, 1832). His eldest daughter, Eliza Buchanan, married, January 20, 1846, Archibald Sands, surveyor, Glasgow (*Ibid.* January 23, 1846). Merchant, Demerara. Acquired, in 1829, Finnick-Malice and Crofton M'Culloch. See *Strathendrick*, pp. 213, 344.

302. GEORGE BUCHANAN, merchant, Glasgow, eldest son of the late Bailie George Buchanan, merchant in Glasgow.

Son of George B. (233). Son of George Buchanan, youngest, merchant, and Helen Gilzian. Born, January 15, 1785 (*Glasgow Baptisms*).

303. THE REV. DR. CLAUD BUCHANAN, late of Calcutta, second son of James Buchanan of Callander, born in the parish of Cambuslang.

The Rev. Claudius Buchanan, D.D., was son of Alexander Buchanan, who died Rector of the Grammar School of Falkirk, and Somers, daughter of Claudius Somers. Born at Cambuslang, March 12, 1766; married, first, April 3, 1799, Mary Whish, third daughter of the Rev. Richard Whish, Rector of Northwold, Co. Norfolk, who died, June 18, 1805, leaving issue, two

daughters ; married, secondly, February, 1810, a daughter of Henry Thompson of Kirby Hall, who died in March, 1813, having had two sons, who died in infancy ; died at Broxbourne, Herefordshire, February 9, 1815. His youngest daughter, Augusta, married, February 23, 1819, Robert Dow Kerr of Greenock (*Scots Magazine*, vol. 83, p. 285). Descended from a family of Buchanans long settled in the Braes of Bochastle (*Information from J. Buchanan-Hamilton of Leny*). James Buchanan in Ballentoun married, January 30, 1729, Marion Ferguson in the Clash (*Callander Marriages*). Their younger son was Alexander, born, June 6, 1736 (*Callander Baptisms*), who, there is little doubt, was identical with the Rector of the Grammar School, Falkirk, who died in 1788, aged 51 (*Falkirk Tombstones*). Alexander Buchanan had besides Claudius another son, Robert, Captain of the Brig "Hawke" of Maryport, who died at Belfast in 1811 (*Scots Magazine*, vol. 73, p. 720). See *Scottish Nation*, 1866, vol. i. p. 475.

304. ARCHIBALD BUCHANAN of Croftjohn, second son of James Buchanan of Kilwinnet in Campsey parish.

Cousin of William B. (394). Director, 1812, 1813, 1814, 1815. Son of James Buchanan and Margaret Buchanan. Baptized, November 10, 1778 (*Campsie Baptisms*) ; married, first, September 30, 1805, Margaret Brown, daughter of Robert Brown of Kilwinnet (*Scots Magazine*, vol. 67, p. 804) ; married, secondly, at Edinburgh, June 8, 1812, Isabella Anderson Park, youngest daughter of Mungo Park of Fowlshiels, Selkirkshire (*Scots Magazine*, vol. 74, p. 565) ; married, thirdly, a French lady, who returned to France after his death ; died at Glasgow, September 5, 1816, in the 38th year of his age, "deeply regretted by all who had the pleasure of his acquaintance" (*Ibid.* vol. 78, p. 720). His 2nd wife was a sister of Mungo Park the traveller. Described at his 1st marriage as "of the Hon. East India Coy.'s Service," and at his 2nd as "merchant in Glasgow."

The Director of 1812-1815 is described as of the Atlas Office, and he was deceased before November 6, 1816. He was Agent for the Atlas Insurance Company in 1809, office at Hutcheson's Hospital. There was also a firm, A. Buchanan & Co., at the same address. They appear in 1807 as "agents and Commission Merchants Hutcheson steeple."

305. NEIL BUCHANAN, engraver, Fernize, son of John Buchanan, horse-setter in Glasgow.

Probably brother of John B. (322). Enrolled as a pensioner, February 3, 1823. Died probably after November, 1836, as his name does not appear.

306. ROBERT BUCHANAN, plumber, Glasgow, son of Archibald Buchanan, farmer in Duntreath.

Father of William B. (307). Son of Archibald Buchanan and Isobel Binnie in Mains of Duntreath. Baptized, July 8, 1749 (*Strathblane Baptisms*); married, December 9, 1768, Janet Adam (*Glasgow Marriages*).

307. WILLIAM BUCHANAN, hairdresser, Glasgow, youngest son of said Robert Buchanan, plumber.

Son of Robert B. (306). Born, May 26, 1777 (*Glasgow Baptisms*); married, first, before 1808, Janet Black (*Ibid.*); married, secondly, Mary Drysdale, who survived him; died between November 8, 1827, and February 6, 1828, when his widow received a grant from the Society.

308. WILLIAM BUCHANAN, farmer, Kierhill, Balfron, eldest son of Moses Buchanan in Kierhill.

Son of Moses Buchanan and Margaret Adam. Born, November 10, 1743 (*Balfron Baptisms*).

309. ROBERTSON BUCHANAN, civil engineer, Glasgow, son of Andrew Buchanan, merchant in Glasgow.

Son of Andrew B. (180). Son of Andrew Buchanan, senior, by his first wife, Agnes Robertson. Born, July 14, 1769 (*Glasgow Baptisms*); died, July 22, 1816, at the house of his uncle, Dr. Innes of Creech, St. Michael, at Taunton. [Dr. Innes must have been his stepmother's brother.] His brother, George Buchanan, at Sherborne, was served heir to him, March 3, 1820 (*Services of Heirs*). See *Dictionary of National Biography*, vol. vii. p. 197.

310. JOHN BUCHANAN, second son of the deceased John Buchanan of Blairennick.

Nephew of James B. (225). Brother of George B. (300). Baptized, July 31, 1782 (*Kilmaronock Baptisms*); died at Glasgow, March 13, 1838 (*Glasgow Herald*, March 19, 1838). Described as "Mr. John Buchanan, Blaranich, late merchant in Liverpool." See *Strathendrick*, p. 343.

Nephew of James B. (235). Father of George B. (470), and Robert B. (434). Brother of George B.

(301), Benjamin B. (329), and James B. (333). Director, 1847, 1848, 1849, 1850, 1851. Son of George Buchanan and Annabella Downie. Born, September 5, 1790 (*Drymen Baptisms*); married, at Smallburn, January 5, 1830, Helen Bow, daughter of the late William Bow of Kernoch (*Glasgow Herald*, Jan. 8, 1830), who was born about 1796, and died, December 11, 1885 (*Drymen Tombstones*); died at Finnich, November 22, 1855 (*Ibid.*). See *Strathendrick*, p. 344.

312. WILLIAM RISK, merchant, Glasgow, only son of the deceased William Risk, merchant there.

Probably son of William Risk (223).

313. ROBERT BUCHANAN, Glasgow, sixth son of the deceased Thomas Buchanan of Ardoch.

Son of Thomas B. (177). Father of Robert B. (395). Brother of John B. (251), James B. (257), and Thomas B. (376). Director, 1819, 1820, 1821, 1822, 1823, 1826. Preses, 1827, 1828. Director, 1829, 1830, 1831, 1832. Preses, 1833, 1834. Director, 1835, 1836, 1837, 1838, 1840, 1841, 1842, 1843, 1844. Son of Thomas Buchanan of Ardoch by his third wife, Helen Grahame, daughter of William Grahame of Birdstone. Born, February 24, 1786; married, first, September 8, 1817, Margaret Dunlop, only daughter of the late William Dunlop of Annanhill (*Scots Magazine*, vol. 80, p. 194), who was born, 1794 (*Tombstone*), died, October 25, 1826 (*Glasgow Courier*, Nov. 2, 1826); married, secondly, January 17, 1832, Margaret Dickson, second daughter of James Dickson, Edinburgh (*Glasgow Herald*, Jan. 20, 1832), who was born, 1804 (*Tombstone*), and died, July 6, 1838 (); died, January 30, 1870. See *Strathendrick*, pp. 355, 357. He was a well-known merchant in Glasgow (*The Ardoch Register*).

Brother of John B. (299). A James Buchanan, son of John Buchanan at Sauchie and Isobel Miller, was baptized, April 9, 1769 (*St. Ninians Baptisms*). Died at Glasgow, August 28, 1831 (*Glasgow Courier*, August 30, 1831). Of the firm of J. & J. Buchanan, wine and spirit merchants.

Director, 1839, 1840, 1841, 1842, 1843, 1848, 1849, 1850, 1851. Preses, 1852, 1853. Director, 1854, 1855, 1856, 1857. Born, January 18, 1785 (*Glasgow Baptisms*); died, unmarried, December 5, 1857. Of the firm of James Finlay & Co. See *Strathendrick*, p. 339.

317. GEORGE BUCHANAN, third son of George Buchanan, merchant, Glasgow, late Preses.

Son of George B. (242). Brother of James B. (316). Born, May 7, 1789 (*Glasgow Baptisms*); died at Woodlands, October 2, 1829 (*Glasgow Herald*, Oct. 16, 1829). Cotton Broker, Glasgow. Described as "Junior."

318. ALEXANDER JAMES BUCHANAN, surgeon, Glasgow, son of Duncan Buchanan, merchant, Glasgow.

Probably son of Duncan B. (261). Married Ann Booth (*Memoirs of F. P. S. Glas.* p. 272) ; died, 1837. M.D. 1810.

319. JOHN BUCHANAN, wood merchant, Glasgow, only son of John Buchanan, manufacturer in Paisley.

Son of John B. (234). Father of John B. (388), and Francis Brown B. (403). His only daughter, Jane Brown Buchanan, married, 1854, James Connell, merchant, Glasgow (*Glasgow Herald*). Jean Cook, relict of John Buchanan, wood merchant, died at Glasgow, April 18, 1865, aged 75 (*Glasgow Herald*, April 21, 1865).

320. JOHN GABRIEL BUCHANAN, writer, Glasgow, eldest son in life of the deceased John Buchanan of the Sun Fire Office.

Son of John B. (250). Born, April 11, 1793 (*Glasgow Baptisms*) ; married, April 17, 1820, Catherine Carsewell, second daughter of James Carsewell (*Scots Magazine*, vol. 85, p. 485) ; died, November 20, 1830 (*Glasgow Herald*, December 3, 1830). His wife received a grant from the Society in 1828, and was enrolled a pensioner in 1829, on account of his weak health and poor circumstances. He appears in the *Directory* of 1818 as "J. G. Buchanan, writer, Melville Place, house Horn's Court." He was the "son" of "C. Buchanan & Son, Melville Place," 1818. His youngest daughter, Margaret Lindsay Buchanan, died at 52 Belmont Gardens, Hillhead, February 7, 1901.

Born, April 23, 1791 (*Glasgow Baptisms*); married Margaret Johnston Marshall, who died, April 5, 1828 (*Glasgow Herald*, April 11, 1828); died at 7 Brandon Place, Glasgow, January 6, 1863 (*Glasgow Herald*, Jan. 7, 1863). His daughter, Isabella Stevenson Buchanan, died at Rothesay, May 25, 1898 (*Glasgow Herald*).

Director, 1823, 1824, 1825, 1826, 1827. Born, June 3, 1793 (*Glasgow Baptisms*); married, March 31, 1818, Grace Crombie, third daughter of John Crombie, dyer (*Blackwood's Edinburgh Magazine*, vol. iii. p. 118); died at Chapelfield, Helensburgh, May 21, 1861 (*Glasgow Herald*, May 22, 1861). His eldest daughter, Grace, married James Howe M'Clure, writer, July 28, 1841 (*Glasgow Herald*, July 30, 1841), and died at Saltcoats, July 8, 1852, in her 34th year (*Tombstone, New High Churchyard*). Of the firm of George Buchanan & Sons, 95 Candleriggs.

Founder of the Buchanan Institution. Of the firm of Dennistoun, Buchanan & Co. See Crawford's *Trades' House*, pp. 265-271.

328. ROBERT BUCHANAN, carter, Grahamston, Glasgow, second son of Robert Buchanan, farmer, St. Ninians.

Robert Buchanan and Jean Muirhead, Northird, had a son, Robert, baptized, April 12, 1778 (*St. Ninians Baptisms*). Robert Buchanan, carter in Barony, married, April 10 1807, Jean Fairley (*Glasgow Marriages*).

329. BENJAMIN BUCHANAN, merchant, Kingston, Jamaica, second son of George Buchanan in Finnich.

Great-grandson of George B. of Blairlusk (61). Nephew of James B. (235). Brother of George B. (301), John B. (311), and James B. (333). Baptized, May 6, 1784 (*Drymen Baptisms*); married May Cameron, who died at New Brighton, July 25, 1857 (*Glasgow Herald*); died at Liverpool about 1863. See *Strathendrick*, p. 344.

330. THE REV. ROBERT BUCHANAN, minister, Peebles, eldest son of John Buchanan in Trean.

Son of John B. (335). Nephew of William B. (283). Born, February 16, 1786 (*Callander Baptisms*); died at Dunoon, March 2, 1873. Minister of Peebles, 1813. Resigned, 1824, on being appointed assistant to Professor Jardine, whom he succeeded in 1827. Professor of Logic, University of Glasgow, 1827-1864; LL.D. 1869. See *One Hundred Glasgow Men*, p. 51.

333. JAMES BUCHANAN, merchant, Demerara, fourth son of George Buchanan in Finnich.

Great-grandson of George B. of Blairlusk (61). Nephew of James B. (235). Brother of George B. (301), Benjamin B. (329), and John B. (311). Was afterwards merchant in Liverpool. Born, February 9, 1797 (*Drymen Baptisms*); died, 1867. See *Strathendrick*, p. 344.

334. WILLIAM BUCHANAN, manufacturer, Glasgow, second son of Isaac Buchanan, late in Gartfairn.

Son of Isaac B. (228) by his third wife, Jean Risk. Baptized, November 7, 1786 (*Buchanan Baptisms*); married, before 1817, Elizabeth Provan (see *Glasgow Baptisms*). William Buchanan, "manufacturer 78 Stirling Street," 1813; "79 Stirling Street," 1815; William Buchanan & Co., manufacturers, 7 South Frederick Street, 1818. In 1827 and 1831 William Buchanan, "Shawl manufacturer," is mentioned as present at the Society's Dinner.

335. JOHN BUCHANAN, farmer at Trian, Callander, eldest son of Robert Buchanan, late of Trian.

Father of Robert B. (330). Brother of William B. (283). Born about 1755; married, January 28, 1785, a Mary M'Nee (*Callander Marriages*); died, April 25, 1834 (*Glasgow Herald*). Gaelic poet and astronomer. Had nine sons and three daughters. Of the seven sons who came to maturity, five were ministers of the Church of Scotland. The eldest son, Robert B. (330), succeeded George Jardine as Professor of Logic and Rhetoric in the University of Glasgow in 1827. His son, Thomas, afterwards minister of Logierate and Methven, was the Society's Bursar in 1815. Born, 1799; married, March 27, 1826, Bethia Hamilton Ramsay, daughter of William Ramsay of Gogar, who died, 1877; died, August 12, 1879 (*Services of Heirs*). Born, March 16, 1796 (*Glasgow Baptisms*); married, October 12, 1824, Agnes Leechman, youngest daughter of William Leechman, merchant, Glasgow (*Scots Magazine*, vol. 94, p. 639), who died, November 3, 1867 (*Services of Heirs*); died at 14 Lynedoch Crescent, Glasgow, June 4, 1860 (*Glasgow Herald*, June 6, 1860). M.D. Edinburgh, 1816. Professor of Anatomy, Anderson's College, 1841.

Born, September 29, 1791 (*Abbey Parish Baptisms*) ; married, at Annan, June 8, 1830, Elizabeth Grace Bogle Smellie, youngest daughter of John Smellie of Torbanehill (*Glasgow Herald*, June 18, 1830) ; died at Birkenhead, October 9, 1854 (*Ibid.* October 20, 1854). Born, May 1, 1795 (*Abbey Baptisms*) ; married, at Maxwellton House, near Paisley, November 15, 1836, Jane Fulton, daughter of Robert Fulton of Hartfield (*Glasgow Herald*, Nov. 18, 1836), who died, August 2, 1852 (*Ibid.* August 6, 1852) ; died, September 27, 1880 (*Tombstone, Glasgow Necropolis*). Born, 1803; died, unmarried, April 5, 1864. Dean of Guild, 1859, 1860. Of Buchanan, Watson & Co. Left a bequest to the Merchants' House, and £100 to the Buchanan Society. 345. DAVID BUCHANAN, teacher of English, eldest son of William Buchanan in Crawford John.

Son of William Buchanan and Agnes Paton. Born, October 31, 1775 (*Crawfordjohn Baptisms*); married, June 10, 1808, Agnes Lean (*Glasgow Marriages*). His widow, Agnes Lean, was enrolled a pensioner of the Society, November 3, 1852. She died at 45 Rose Street, Garnethill, May 13, 1861, aged 78 (*Glasgow Herald*, May 14, 1861). Neil Snodgrass, writer in Paisley, born about 1661, married, about 1690, Jean Buchanan, daughter of Robert Buchanan, fourth cadet of the family of Spittal, and died in 1718. Their only son was John Snodgrass of Cuninghamehead, writer in Edinburgh, who married, in 1737, Anne Nisbet, daughter of William Nisbet of the Dirleton family. The oldest son was Neil Snodgrass of Cuninghamehead, who married, in 1773, Marion Macneil, eldest daughter of James Macneil of Kilmorie, and had with other issue the above David (Paterson's *History of Ayr and Wigton*, vol. iii. pp. 209, 210).

Born, June 3, 1804 (*Glasgow Baptisms*); married, at 7 Blythswood Place, Glasgow, June 4, 1834, Margaret Miller Wingate, daughter of Andrew Wingate (*Glasgow Herald*, June 6, 1834), who was born about 1817, and died at 13 Park Circus, Glasgow, February 8, 1899 (*Ibid.* Feb. 9, 1899);

died, June 25, 1869 (*Services of Heirs*). Born, January 30, 1797 (*Glasgow Baptisms*); married, first, April 20, 1824, Mary Hamilton, eldest daughter of John Hamilton of Mavisbank (*Scots Magazine*, vol. 93, p. 638), who died in 1842; married, secondly, 1852, Christina Laura Smith, daughter of James Smith of Jordanhill, who died, April 30, 1852; died, 1883. Born, December 10, 1798; married Jeanie Smith Bogle, born, June, 1805; died, December 25, 1904 (*Glasgow Herald*, December 26, 27, 1904); died, July 9, 1882. His only son, Dr. Andrew Buchanan, died at 4 Athole Place, Glasgow, April 4, 1865 (*Glasgow Herald*). His daughter married Charles King of Antermoney. M.D. 1822. Director, 1866, 1867, 1868, 1869, 1871, 1872, 1873, 1874. Thomas Buchanan, Junior, afterwards Thomas Gray-Buchanan of Scotstoun, son of James Buchanan, afterwards James Gray-Buchanan of Scotstoun and Eastfield, by Anne Parkes, his wife. Born at St. Andrew Square, Glasgow, November 8, 1804; married, October 15, 1835, Mary Rowand, second daughter of Michael Rowand of Lint-house, who was born, August 12, 1813, and died, May 10, 1888; died at Wellshot, June 19, 1875.
