FOREWORD

THE Parish of Tibbermore has reason to be proud of the part it played in the Great War, either in the way of sending representatives to the Colours; of performing patriotic work at home, or of contributing to the many schemes which were organised for the help of the Service men. The local Roll of Honour contains 327 names, and an inspiring feature is the representation of sons of the parish who rallied to the Colours from outposts of the Empire. It is interesting to note that several families contributed amongst the largest quotas to the Colours in the county. Worthy of notice, too, is the gallantry displayed by the young men and women from the parish, and the honours list contains no fewer than 14 names. Indeed, the parish can lay claim to the distinction of possessing the county's first recipient of the D.C.M. in the war.

That the parish bore their share of casualties, however, is only too evident from the list of men who fell. Inscribed on this honoured scroll are the names of 4 officers and 45 men. To the

parents and friends of the fallen the sympathy of the whole community goes out. Their grief is great, but it is tempered by the knowledge that their dear ones have fallen in defending their King and country, and in a righteous cause.

Much valuable work was also performed in the parish, and the generous spirit in which the call for subscriptions was responded to at the outbreak of war, and which was nobly maintained throughout, cannot but be a source of great gratification to all concerned.

The object of this publication is to place on permanent record the service which the parish gave to the nation in its hour of need. In convenient form the roll will no doubt find an honoured place in every home, and thereby serve the purpose for which it is intended—that each family might show to future generations the part played by its members.

*Letter by REV. JAMES C. CAMPBELL, M.A., Minister
of the Parish of Tibbermore.*

The war is over, the soldiers have returned, and the people count their slain. Only those who have themselves lost friends in the war can realise the bitterness of that loss. Those who fell were not the aged and infirm, but the young manhood of the country, with all the hope and promise of life before them.

We, who by their self-sacrifice have been delivered from the dread menace of invasion and defeat, are under a deep sense of their loss and filled with grateful remembrance. Theirs was the hard road—they died to preserve their country, and all that was dear to their hearts—to us are left the fruits of their labours—they sowed in pain and in death, the freedom and the victory we are reaping to-day. May the memory of their devotion live for ever in our hearts. From this parish 49 went forth to die.

Our hearts are deeply moved as we recall their

youth, their willingness and their cheerful courage. To those of our generation the world can never be quite the same again. We extend our sympathy to those, who, having lost those whom they loved, yet with stout hearts carried on the business of their lives, remembering those who were gone, not only with sorrow, but with pride.

Among those who served, let us not forget those at home who shouldered their share of the burden of war. At no time in the history of our race have the women of our country done more for the good of the state, and this was true in our parish as elsewhere.

They like their husbands and their sons performed their duties, and endured their hardships with loyalty and with courage—to this end that we should conquer, and in the end the victory was ours.

Promoter and Convener, until his translation to Old Kilpatrick, of Tibbermore Parish War Comforts Committee, and who at all times manifested the liveliest practical interest in all schemes promoted for the comfort of our Sailors and Soldiers.

held in the lovely grounds of Huntingtowerfield, on 6th August, 1917, which realised the sum of £245. A pleasing system of entertainments to convalescent wounded soldiers from Perth War Hospitals was maintained at Huntingtowerfield House throughout the course of the war.

As giving some indication of the activities of the Committee, and the scope of its work, it may be mentioned that the sum of £321 15s 10d was collected throughout the Parish during the period of war, which made possible the distribution of 2840 articles of comfort, along with other gifts, in a regular Parcel System to our Sailors and Soldiers, and on its dissolution the residue of £15 was equally apportioned to Perth Station Barrow Fund and Perth City and County Royal Infirmary; 114 articles of clothing being sent to Sir Edward Ward's Depot, Perth.
