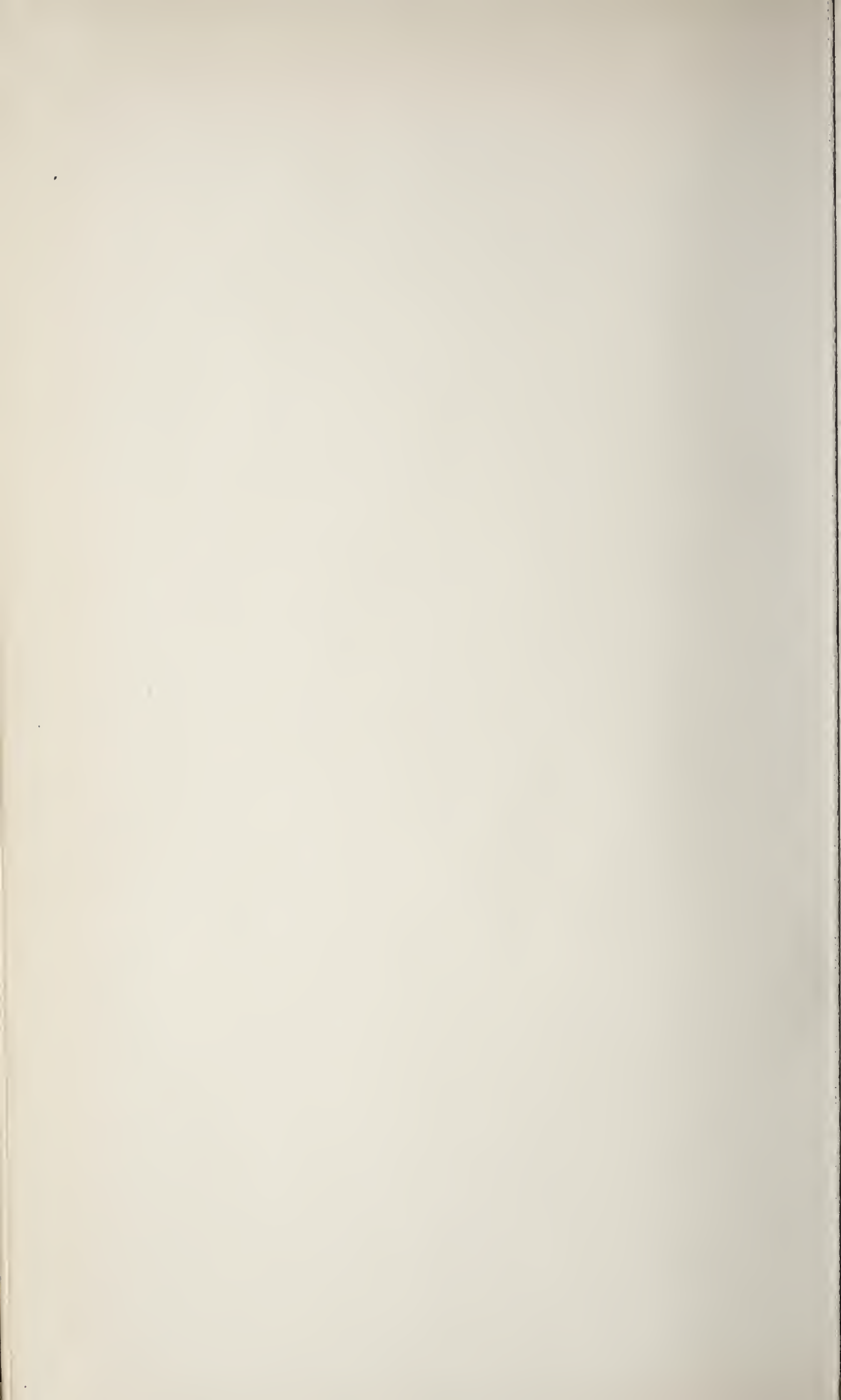

AN ACCOUNT OF THE BUCHANAN SOCIETY

THE BUCHANAN SOCIETY, as the name denotes, is composed of individuals of the Name and Clan of Buchanan and is the oldest Clan Society in Scotland.

The Society was instituted in Glasgow on 5th March, 1725, under the name of "THE BUCHANANS CHARITY SOCIETY, kept at Glasgow."

The object of the Founders was to provide for the support of poor individuals of the Name and Clan, to assist boys of the Name and Clan in their education at school, and those of promising genius at the University or otherwise, and to have some bound apprentices to respectable trades, so as to put them in the way of advancing themselves in life.

At first the contributions of members were so small that a considerable period elapsed before the Society could be said to be in a flourishing condition. In 1728 its total capital amounted to about £75, and it was then deemed advisable "to print and publish, for the information, encouragement, and invitation of all concerned to join and contribute, a Scheme of the Society." This interesting document is reprinted in the Appendix.

In 1733 a piece of ground in Glasgow on the south side of the Trongate, and on the west side of King Street, was purchased at the price of 2110 merks Scots, or about £117 sterling. Betwixt King Street and this piece of ground, on which stood an old thatched tenement, there was a piece of "voyd ground"

belonging to the Town. On 14th June, 1733, the Magistrates and Town Council were pleased "to grant a right to the Society of the said piece of ground, that in the rebuilding of their tenement they may take in the said ground to be a part thereof." In this way the new tenement which was erected at that time became the corner building, with a frontage both to the Trongate and King Street. The property was again rebuilt by the Society in 1849, and extended by the purchase of an adjoining flat in 1864, the total expense being between £3,000 and £4,000. These properties remained in the possession of the Society till 1868, when they were sold at the price of £8,000.

In 1752 the Society applied for, and obtained from the Magistrates of the City of Glasgow, a Seal of Cause or Charter, dated 5th September, 1753, erecting the Society into a legal corporation by the name of THE BUCHANAN SOCIETY. This document is also reprinted in the Appendix.

Another transaction which added materially to the Society's funds was the purchase of properties in five separate lots, which together formed the east corner of Stockwell Street and the Trongate. The first lot was bought in 1766 and the fifth in 1839, and the total cost as shown in the Minutes was £5851. These properties were retained as an investment until March, 1859, when it was resolved to demolish the old tenement and develop the site by erecting a modern warehouse in its place. The building now known as the Granite House was accordingly erected at an approximate outlay of £6,200. The Society retained this property until 1878 in which year it was sold at the price of £23,500.

While the funds have been devoted to the support of the poor and the education of those of the Name and Clan, the Society has regularly contributed to local charities in Glasgow, and has from time to time voted sums of money towards certain other objects, some of which are here mentioned.

In 1778 a sum of £50 was subscribed by the Society towards raising a battalion of men for the service of His Majesty King George III.

In 1788 a Monument in the form of an Obelisk was erected at Killearn in memory of George Buchanan, the historian. The cost was subscribed in the district, the Rev. Jas. Graham, Minister of the Parish, having taken a prominent part in the matter. In the year 1836, under the auspices of the Society, subscriptions were invited in Glasgow and neighbourhood to meet the cost of restoring the Monument, which had fallen into a bad state of repair. This work was accordingly carried out, being completed in 1850, when a Marble Tablet, bearing an inscription by Professor Ramsay of Glasgow University, was affixed to the Monument. The cost of restoration amounted to £273 14s. 6d., which exceeded the sum subscribed, and in the same year the Society was asked to make up the deficiency, amounting to £51 5s. 2d., which they did. Again, in the year 1881, the Monument was found to be in a bad state of repair, and the Society took in hand the restoration, expending the sum of £736 9s. 4d. in this, and enclosing the ground. At the same time the Trustees of the late Peter Blackburn, Esquire, of Killearn, granted to the Society a title to the plot of ground on which the Monument stands. The Society thus became permanent custodiers of the Monument and adjoining ground.

In 1798 the Society voted unanimously "the sum of Fifty pounds Sterling in aid of Government at this critical period."

In 1799 a sum of £300 was voted to assist the Magistrates in bringing meal and other grain into the City for the relief of distress, and in 1801 a further sum of £300 was given for a similar purpose.

In 1814 the Society requested Mr. Henry Raeburn, the portrait painter, to execute for them a copy of a portrait said to be of George Buchanan, the historian, then in the possession of the Earl of Buchan, the original being then believed to have been painted by Titian. Mr. Raeburn delivered the portrait to the Society in December, 1814, and was paid his fee of 25 guineas for the work in the same month.

In 1925 the Directors arranged for the Corporation of Glasgow to accept the custody of the Raeburn portrait and

relative correspondence for exhibition in the Raeburn Collection in Kelvingrove Art Galleries on the terms that these would remain the property of the Society and be available at any time for the purposes of the Society.

In 1832 a sum of £50 was voted to the Board of Health in consequence of the alarming spread of fever in the city, and the threatened plague of cholera, and on the ground "that although the funds of the Society were intended previously for the relief of poor of the name of Buchanan alone, yet there was by the Constitution a discretionary power vested in the Managers whereby they might contribute towards other measures for the public good."

In 1904 the Society resolved at the General Meeting to contribute a sum of £500 towards the Building Fund of the Technical College in Glasgow, the members considering that this portion of the funds could be worthily disposed of in this way. The meeting, however, did not consider they would be justified in giving away the funds without some return, and it was accordingly arranged that the College should admit one day student or two evening students nominated by the Society to any college classes each session without payment of fees.

In 1906 the Universities of St. Andrews and Glasgow held celebrations of the Quatercentenary of the birth of George Buchanan, the historian. The Society contributed to the cost of these celebrations, and the Preses and certain of the Board took part in the proceedings.

At the General Meeting held on 22nd February, 1906, it was suggested that a Medal and Chain should be procured, to be worn by the Preses at the General Meetings of the Society, and also at Directors' Meetings, and on such other occasions as he should think proper. The sum of £93 3s. 6d. was contributed by private subscription among the members and a gold badge and chain procured. These are worn by the Preses as occasion requires.

In 1908, and again in 1914, the Society voted £50 towards the Building Fund of The Buchanan Institution.

During the Great War 1914-18 the Society made frequent and substantial contributions to various agencies working for the amelioration of conditions created by the War.

In 1917 a Petition was lodged in the Lyon Court, Edinburgh, for a grant of Arms. The Arms were granted, and together with the text description are printed as a frontispiece to the present edition of the handbook.

Various donations and legacies have from time to time been received by the Society, and a list of these appears in the Appendix. The Society by careful management, aided by those generous donations and legacies, has progressed with almost uninterrupted success, and has occupied a position of practical usefulness in the community for over two hundred years. Its capital now amounts to £70,000.

MANAGEMENT OF THE SOCIETY.

By the Seal of Cause or Charter, the Management of the Society was entrusted to a Preses, Treasurer, four Directors, two Boxmasters and a Clerk, all of whom, with the exception of the latter, who was chosen by the Managers alone, were appointed by the whole members of the Society, at their General Meeting. The office of Boxmaster, however, was abolished in the year 1771, and the business is now regulated by the existing Constitution under which the management is now vested in a Board, consisting of the Preses and ten Directors. These latter include the Treasurer and Secretary *ex-officiis* and five form a quorum.

OBJECTS OF THE SOCIETY.

The main objects of the Society are (1) to assist the Poor of the Clan and Septs, and (2) to further the education of members of the Clan and Septs shewing promise.

(I) PENSIONS AND CHARITABLE GRANTS.

These are carefully distributed. Formerly such Grants were made only at the Annual General Meeting of the Society, but they are now made by the Board, at such times, of such amounts, for such periods, and subject to such conditions as the Board may in each case determine.

At 1st January, 1926, the number of Pensioners on the Roll was 233. The Pensions allocated to these are graduated, according to the applicants' circumstances, from £5 to £24 annually. During the year 1925 Grants to the total amount of £306 were made to poor persons, the total paid during that period in Grants and Pensions being £2237.

The following are the Rules and Conditions adopted at the General Meeting on 27th February, 1908, under which Pensions and Grants are given. The Board has right, under the Rules, to suspend these Pensions and Grants for such period as they may see fit.

First. Applicants must be lawful children and bear the name of BUCHANAN, or the name of one of the Septs or Branches of the Clan, viz. MacMillan, MacWattie, MacAuslan and Risk, or be the widows of such.

Second. Applicants must be of good character and in straitened circumstances requiring some supplementary bounty for their more comfortable support.

Third. Applicants must lodge their applications in the form given, duly filled up and certified, with the Treasurer or Secretary, and their tickets must be presented to the Treasurer each year thereafter, according to the instructions thereon.

Fourth. All applications must be certified by a member of the Society, and be accompanied by Certificates as to the circumstances and character of the applicants from Clergymen or other persons on whose recommendation the Board can place reliance.

Fifth. The Board for the time being have the sole right of selecting recipients, and are the sole judges of the mode of administering the aid, the amount thereof, and the terms of payment or distribution. The aid may be supplied either in money or goods.

Sixth. The Board shall have power at any time to increase, lessen, or entirely to withdraw the aid given to any recipient.

Seventh. The Board have power from time to time to add to or alter the foregoing Rules and Regulations.

(2) EDUCATIONAL GRANTS.

The Society has never lost sight of the importance of giving judicious assistance in education, and of late years has inclined to extend its activities in that direction with a view especially to encouraging capable and deserving scholars towards a University education.

To encourage promising boys and girls to take their Leaving Certificate the Society grants each year three or four scholarships, each of £15 a year, tenable for two or three years as the case may be. These are granted as the result of an examination held annually in June by an examiner appointed by the Society.

The scholarships are keenly competed for, and have proved successful in many cases in bridging the gap between compulsory and University education.

Formerly the Society held its own examination for bursaries, but this has been departed from for a considerable number of years, and now bursaries are granted to qualified applicants, the main qualification being that they shall have passed the University Preliminary Examination or an equivalent examination.

To students in Arts bursaries are granted of £25 a year for three years, the bursary being continued for a fourth year if the student is aiming at an honours degree. To students in Medicine bursaries of £35 a year for five years are granted.

In addition, grants are made for educational purposes in cases in which such appear to the Directors to be justified.

In 1925 there was expended in scholarships £125; in bursaries £390; and in other educational grants £172; a total amount of £687.

CONSTITUTION,
RULES AND BYE-LAWS
OF
THE BUCHANAN SOCIETY

As amended and adopted 27th February, 1908.

NAME.

I.—The Name of the Society is “THE BUCHANAN SOCIETY.”

CONSTITUTION.

II.—The Constitution of the Society is embodied in the Seal of Cause, or Charter from The Honourable the Magistrates and Town Council of Glasgow, erecting the Society into a legal Corporation, dated 5th September, 1753.

OBJECTS.

III.—The Objects for which the Society was constituted, in terms of the Seal of Cause, are—(1) To assist the Poor of the Clan and Septs, and (2) to further the Education of Members of the Clan and Septs showing promise.

MEMBERSHIP.

IV.—The Membership of the Society is confined to persons bearing the name of Buchanan, or of one of the reputed septs or branches of the Clan, owning themselves to be such,

recorded in an historical and genealogical account of the Clan by the late William Buchanan of Auchmar. The septs or branches at present recognised are the MacMillans, MacAulsans, MacWatties, and Risks.

V.—Applications for Membership shall be in the form supplied by the Society. These shall be lodged with the Secretary, and at the first Meeting thereafter of the Society they shall be considered, and the applicants balloted for by the Members personally present.

VI.—The entry-money payable by applicants (male or female) for Membership is a sum of not less than Five Guineas excepting as after mentioned. This constitutes Life Membership. The entry-money for wives, daughters or sisters of Members, who are otherwise qualified, is a sum of not less than Three Guineas. This also constitutes Life Membership.

VII.—The Society has power to vary the amount of the above sums of entry-money as and when it sees fit.

MANAGEMENT.

VIII.—The Management of the Society is vested in a Board, which shall consist of a Preses and Ten Directors. These latter include the Treasurer and Secretary, in virtue of their office. Five shall be a quorum.

I.—PRESES.

IX.—No one shall be eligible for the office of Preses who is not, or has not been, a Director. The Preses shall be elected annually, on the nomination of the Board, by the Members personally present at the Annual Meeting of the Society, and may be continued in office for two years in succession, but no longer. Except as above, a Preses retiring shall not be eligible for re-election as Preses or Director until one year shall have elapsed from the date of his retiral. The Preses shall preside at all Meetings of the Society and of the

Board, and shall have on all questions a deliberative vote and a casting vote as well. In his absence the Senior Director present shall act as Preses, with the like powers. Should the Preses die or resign during his term of office the Directors may elect a duly qualified Member to fill his place and act as Preses until the next Annual Meeting.

2.—DIRECTORS.

X.—All Members of the Society are eligible for the office of Director, provided they are of full age, and are not in receipt of a grant or pension from the Society. They are elected by the Members personally present at the Annual Meeting. At that Meeting the two Directors at the top of the list shall retire from office, and two other Directors be elected in their place by the Members personally present, after being duly proposed and seconded. The two Directors so appointed shall be added at the bottom of the list in the order of their election. A Director retiring shall not be eligible for re-election until one year shall have elapsed from the date of his retiral.

XI.—In the event of a vacancy occurring among the Directors from any cause, the same may be filled up temporarily by the Board, and the Director so appointed shall hold office until the next Annual Meeting. At that Meeting a Director shall be appointed, who may or may not be the Director so appointed temporarily. Such Director shall retire from office when the Director whose place he has taken would, in the ordinary course, have retired.

XII.—In the event of a present Member of the Board being elected Preses, the Meeting at which he is appointed shall forthwith proceed to elect a Director to fill his place. A Director so elected shall retire from office when the Director whose place he has taken would, in the ordinary case, have retired.

XIII.—The Board shall conduct the whole business in conformity with the Constitution, Rules and Practice of the Society, and shall have control of the whole property and funds, and determine the manner in which the same may be applied and utilised.

3.—TREASURER.

XIV.—The Treasurer shall be elected annually, on the nomination of the Board, by the Members personally present at the Annual Meeting of the Society, and shall hold office for one year. He shall be eligible for re-election.

XV.—Before entering on his duties the Treasurer shall find security for his intromissions to the satisfaction of the Board.

XVI.—The Treasurer shall keep or cause to be kept all usual and necessary books showing in detail his intromissions with the Funds, and these shall be open at all reasonable times to the inspection of the Board or any one whom they may appoint. The Board have power from time to time to determine in what manner the Bank Account shall be operated upon and the receipts and payments of the Society dealt with.

XVII.—The Treasurer shall make up annually an account of the Funds and of his intromissions with same as at 31st December in each year. Said account shall be audited as after provided for and shall be submitted to the Annual Meeting for approval. The remuneration of the Treasurer shall be fixed by the Board.

4.—SECRETARY.

XVIII.—The Secretary shall be elected annually on the nomination of the Board by the Members personally present at the Annual Meeting of the Society. He shall hold office for one year, but shall be eligible for re-election. His remuneration shall be fixed by the Board.

5.—AUDITOR.

XIX.—The Auditor of the Society shall be appointed annually by the Members, and shall be a Member of any recognised firm of Chartered Accountants of standing in Glasgow.

FUNDS.

XX.—The Funds shall be invested at the discretion of the Board in such of the Investments authorised by the Trusts (Scotland) Acts, 1861-1898, as they may select, and in such Investments only. Conveyances, transfers, discharges, and other deeds shall be signed by the Preses, Treasurer, and Secretary, in whose names also shall be placed the Investments of the Society.

MEETINGS.

XXI.—The Annual Meeting shall be held in the month of February in each year, when the Annual Report shall be submitted and all other competent business transacted. The Society shall also hold, in addition to the Annual Meeting, a Meeting in the month of October in each year, which Meeting shall be known as the Autumn Meeting of the Society. At this Meeting all business current at the time shall be reported to the Members by the Board and any other competent business transacted. Notice of any motion to be made at either of those Meetings shall be given in writing to the Secretary not less than Fourteen days before such Meeting. The Annual Dinner of the Society shall be held in the evening of the day of the Annual Meeting.

XXII.—Any three Members of the Board or any six Members may present a requisition to the Secretary to call a Special General Meeting at the time and place, and for the transaction of the business specified in such requisition. Such requisition shall be lodged with the Secretary at least Fourteen days before the date proposed for the Meeting. Should the Secretary fail or decline to call such Meeting

within Seven days after receipt of such requisition, then the parties presenting such requisition may themselves call it.

XXIII.—Fifteen Members of the Society personally present shall constitute a quorum at all General Meetings. If a quorum be not present at the Annual or Autumn Meeting within fifteen minutes of the hour of meeting, the Meeting shall stand adjourned for one week, and the Members then present may proceed with the business.

VOTING.

XXIV.—At all Meetings of the Society and of the Board the Voting, except for the election of Members, shall be in such manner as the Meeting may determine.

(1) GRANTS TO THE POOR.

(2) BURSARIES, SCHOLARSHIPS AND OTHER EDUCATIONAL GRANTS.

XXV.—These shall be granted by the Board at such times, of such amounts, for such periods and subject to such conditions as the Board may from time to time determine. The Board reserve right at any time to suspend for such period as they think proper the issue of such Grants, Bursaries and Scholarships, or any of them.

GENERAL.

XXVI.—The Society has been in receipt from time to time of various Donations and Legacies from individuals. A list of these, with the names of the donors and the amounts, will be found in the publication known as the History and Constitution of the Society. The total amount of these sums is £5298 13s. 4d.¹ Certain of them, and these the largest in amount, were given for Educational purposes alone and have

been so dealt with in the past. For the future the same course will be followed by the Board.

XXVII.—The Society shall be entitled to sue or defend any action at law, or to take part in any reference, arbitration or other legal proceedings or enquiry in the names of the Preses, Treasurer and Secretary for the time being as representing the Society.

XXVIII.—The Society in General Meeting shall have power to add to, alter or vary any of the foregoing Rules, provided that two-thirds of the Members present agree to do so.

APPENDIX

I.

A Scheme

of the

Buchanans Charity Society

Kept at Glasgow.

IT is Evident from the very Frame and Make of Humane Nature, and the Circumstances in which we are Placed in the World : That each single Man is not Formed for himself alone, but is made for Society, and is Naturally a Member of a Community, every Part whereof Derives its preservation and Welfare from mutual Aids and Supports : And therefore besides the Consideration of the Obligations of Religion, the Common Tyes of Humanity, and Regard to the General Interest of Mankind, in which the Welfare of each Particular Man is Involved ; oblige each of us to do Good to our fellow Creatures, according to our several Abilities and Opportunities : And as the Case of such as are left Early Destitute of help, from those to whose Care they are most Immediately and Naturally Committed, has a special Claim to the Compassion of Humane and tender Hearts, so there is hardly any kind Office to which Nature itself does more Prompt us, and which affords a more inviting Prospect to Allure us, than the Training up of Poor Youths to a Capacity of not only Subsisting themselves Comfortably, but also of being usefull Members of Society. These Considerations did Ingage some Charitable

disposed Persons of the Name of Buchanan, to Propose and Agree at Glasgow in the Month of March 1725 Years, to the Erecting of a Society in this Place of that Name, and of these Names who own themselves and are Reputed Septs and Branches thereof ; whereby a Fund might be raised and Carried on, the Interest whereof to be Employed in putting Poor Boys of the foresaids Names to Trades, and Assisting these of promising Geniuses at their Studies in the University, or the like Pious Uses. Which Society being then Erected, the Fund thereof is now so far Advanced that even of these already Inrolled, Eighty Pound Sterling is Collected ; the method of Managing Stipulated and followed is thus :—

1st. A Praeses is Chosen at Whitsunday Yearly who Continues in that Office one year only at once ; (he with the Clerk, Signs all their Acts and Sederunts,) and has the First Vote, and also a Casting Vote in Case of Parity : He is Chosen out of a Leet of Two of the Four Directors aftermentioned, which Leet is made up by the Managers present in Office, and the whole Members present whether Managers or not, have a Vote after Leeting ; and in Absence of the present Praeses, the Immediate former Praeses preceds in his Room.

2nd. The Four Directors are Chosen by the whole Society present. Each out of a Leet of Two presented and made up by the Managers present in Office ; and for preventing a Total Change of the Directors at once, a Director is Chosen every Quarter, and serves in Office a Year : They are Numbered 1, 2, 3, 4, Respective, and are Removed in Order, after Serving a Year, and succeeded accordingly.

3rd. The Tresaurer is also Chosen at Whitsunday Yearly, by the whole Members present, out of a Leet of Three Persons, made up and presented by the Managers in Office : He Keeps the Accompts and clears with the Managers, he Registrates his Accompts in the Societys Register at his Demission, viz., at the Years End : And with Consent of the Rest of the

Managers, Lends out the Societys Money upon Bond bearing Interest, with sufficient Bale, Payable to the Praeses and Tresaurer, and to their Successors in Office for the Societys Use.

4th. The Two Box Masters (who likewise continue one Year in Office) are Elected at Whitsunday Yearly, by the whole Members present out of Two Leets made up by the present Managers, each Leet Consisting of Two Men, their Office is to keep a Key of the Societys Box, wherein are Reposed their Bonds, Papers, and Books, and they with the Praeses, (who has a third Key), open the Box as Occasion requires: The Box Lyes in the Praeses House, and cannot be opened without all the Three Keys.

5th. For preventing Factions in the foresaids Elections, no Leets are made up nor published, till the whole Society Expected, be actually present; then the Managers Retire and make up the Leets, and Return to Vote with the rest of the Members: These that are Leeted being Removed in Time of Voting, after they have first given their own Votes.

6th. The Society have a Clerk Continuing at the Managers Pleasure, who keeps the Large Register-Book, the Book of Entries, and Quarter-Payments, and the Book where the Treasurers Accounts are Registrated; he gives Advice and Assistance in all Emergencies.

7th. The above Eight Managers, and the Extraordinary Directors, are Intrusted with the whole Affairs of the Society, make Acts and Regulations for the good thereof; and five of them are Declared a Quorum, the Majority of the Whole, or of the Quorum, Deciding in all Cases; they all at their Election give their Solemn Promise De Fideli, and meet every Thursday immediately after each Quarterly Term, with the rest of the Members, for Electing a Director, Receiving Quarterly Payments, and other necessary Ends; And meet oftner by themselves as the Praeses shall warn them by the Societys Officer: But if Complaint shall be offered against

the Managers, or any of them, for Injustice, Maladministration, or otherways in the Societys Affairs ; the Magistrates of Glasgow in Office at the Time, Dean of Guild, Deacon-Convener and Town Clerk of Glasgow, or any Three of them with the Town Clerk, who are declared a Quorum, the majority of the Whole, or of the Quorum Deciding one Way, shall be the Sole and ultimate Judges, to Determine thereanent, and from whom there shall be no Appeal.

8th. Each Member pays at his Entrie, Ten Shillings Sterling, at least, and these of Fashion what more they please ; (some have Payed Five Pounds Sterling a Piece), besides a Shilling Sterling Yearly of Quarterly-Payments, and Sixpence at Entry to the Officer.

9th. For further Augmentation of the Fund, the Praeses Pays half a Guinea, each Director and Tresaurer a Crown, and each Box-master half a Crown, which they pay only once in their life ; tho' they happen to be oftner in any of these Stations formerly payed for.

10th. For the better managing and Extending the Societys Concerns, Archibald Buchanan of Drummikill, Francis Buchanan of Arnpryer in Stirling Shire, John Buchanan of Catter, Writer to the Signet, Living in Edinburgh, Duncan M'Millan of Dunmore in Knapdale of Argyle Shire, and William M'Millan of Barwhinnok in the Stewartry of Galloway, are Appointed Extraordinary Directors ; for uplifting the Entry moneys and Quarter-payments of these of their Respective Neighbourhoods, who are Disposed to Contribute to so Charitable an Undertaking. These Directors continue a Year, have the same Power, and Pay the same Dues of a Crown each, as other Directors do, and because of their Absence from Glasgow the Sate of the Society, May Vote by Proxy, and new ones are Chosen by the Managers, every Fifth of March Yearly, or the old are continued as shall seem best for the benefit of the Concern.

It is Hoped this Fund will Increase to a Considerable Pitch, not only by the several Branches thereof, such as the Entry-

monies, Quarterly-Payments, the Dues of Dignified Members, and Interest of the Bonded Money, but also by Legacies, Donations and Mortifications, which it's Expected will be made by Charitable and well Disposed Persons, who Incline to Promote the Design, whose Names shall be Honourably Recorded in the Societys Books and otherways; Especially if the Stock were so far Advanced as to bear the Expenses of Building an Hall; and all other Generous and Charitable Persons, Chiefly, those who are Descended off or Allied to the Name, are invited to Contribute to, and promote the Pious Enterprise; whose Names shall be Respectfully Inrolled as Donators, in the Societys Books, and otherways as above.

The Managers resolve to begin setting out of Apprentices, as soon as the Fund arrives at One Hundred Pound Sterling; nor is there any Room to Doubt of its Extending to that sum, very soon, and as the Sum Increases, More Apprentices will be set out, and Advertisements duely made, that Boys may be Intitured to Prentice Fies, and others assisted in their Studies, according to the Direction of the Managers.

THE said Day being Conveened, Archibald Buchanan of Drumhead Merchant in Glasgow Praeses, John Buchanan of Aucheneven Tresaurer, Patrick, Neil and John Buchanan's Merchants, and Walter Buchanan Maltman, Directors, Andrew and James Buchanan's Taylors Box-Masters, all Living in Glasgow; These as Eight of the Managers of the Buchanans Charity Society kept at Glasgow, having already caused Record the above Scheme in the Societys Books, as a short Detail of their Constitution, taken from their Acts and Sederunts: They hereby Ordain, the samen Scheme to be Printed and Published for Information, Encouragement and Invitation of all Concerned, to join with, and Contribute to,

THE which day, the Magistrates and Town Council convened anent the representation and petition given in and subscribed by the persons afternamed, Managers of the Charity Society in Glasgow erected by the name of THE BUCHANAN SOCIETY, for themselves and in behalf of the other Members of the said Society—MENTIONING That, in the year one thousand seven hundred and twenty-five, some charitable disposed persons, of the name of *Buchanan*, taking into their consideration that, as the people of that name and septs of it, were very numerous and the poor thereof were many, whose necessities called aloud for supply and relief, THEREFORE, they proposed and agreed to erect a Society in this City, of the said name, the reputed septs, and branches thereof,

owning themselves to be such, recorded in an historical and genealogical account of the same, by the late William Buchanan of Achmar, and by voluntary contributions to raise a Charitable Fund or Stock to afford an annual income to be employed in putting Poor Boys of the aforesaid name to reputable apprenticeships, and assisting those of promising geniuses at their studies in the University or otherwise, and thereby introduce them to be useful and industrious members of Society—ALSO for supporting Poor Old People of the name who were unable to do for themselves. That, in prosecution of this benevolent undertaking, Managers were appointed, Regulations were made for the orderly conducting the affairs of the Society, and sundry Contributions and Donations were cheerfully given in whereby, in a few years, their Funds arose to above one hundred pounds sterling. But the Members concerned finding that the laudable purposes abovementioned could not, in any considerable degree, by far answer, unless some method was concerted as well for augmenting their Stock as for the more safely securing and fixing the same in this City, so they came to a resolution of purchasing ground and building a Tenement in Glasgow, that the Rents thereof, as a lasting Fund, might be employed to the charitable uses as is abovementioned, not doubting that every person of the name would readily contribute according to their several abilities for carrying on so good a work. That, accordingly, a piece of ground and some old houses were purchased and thereon a corner Tenement, opposite to the Flesh Market, was built, wherein there is a Hall appointed for meeting of the Society ; but as the sums collected were no means equal to the expense of this building (which came to be far greater than could be expected) the Managers, for the time, were obliged to borrow considerable sums on the Stock and Credit of the Society ; yet, by liberal benefactions, a constant attention to, and frugal management of their Fund, the Society is now almost free of incumbrances. That, though they have been labouring under difficulties for many years, by reason of the burden of debt, the Society hath not been wanting in a due relief of the

poor, as far as they could possibly extend ; they have bound a great number of Apprentices to useful and honest trades, all in the City of Glasgow, giving with each of them at least one hundred merks of apprentice-fee, and have assisted some of hopeful capacities in obtaining a liberal education, besides bestowing considerable charities on poor decayed people of the name, and thereby lessening the burden of such upon the place in general, where all or most of their Funds are expended ; and, with great pleasure, the Society observed, that their pious endeavours had produced very happy and desirable effects.

The following is a short ABSTRACT of the ARTICLES and REGULATIONS by which the Society and their affairs have been and are governed, viz.—The MANAGERS of the Society are a Preses, a Treasurer, four Directors, two Box-Masters and a Clerk, all residing in or near Glasgow, chosen in the month of November annually, and who have the power of preferring and naming of all Apprentices on the Society's bounty, and fit Masters to them, and of bestowing charity to other persons ; *also*, they are entrusted with the whole Funds, affairs and business of the Society, and of the managing and directing the same—any five of them being a quorum. The Preses is elected from a leet of two of the Directors, and he calls and presides in all meetings of the Society, has the first vote and also the casting vote in case of a parity. In absence of the Preses in office, the late Preses, or one of the Directors chosen by majority of the Managers present, presides in his room for the time. The Directors are chosen from four several leets, containing two persons in each leet ; the Box-Masters are chosen from two leets also, of two persons in each leet ; and the Treasurer is elected from a leet of three persons—all which leets are made up and presented by the Managers ; and the elections are all by the whole Society, at their general meeting, but the Clerk is chosen by the Managers only, who have likewise the power of naming their Officer and of appointing salaries to the Clerk and Officer. The said nine Managers continue in office for one year, but re-elected and further continued as the Society thinks fit, and according as the

Managers present leets. The Society's Apprentices are named in the Month of November, yearly ; and each of them must not be under twelve nor above sixteen years of age, which, with their being poor Boys of the name, and well deserving, must be duly certified : and all acts made by the Society, or Managers, are signed by the Preses and Clerk, in name of the whole. Every apprentice, by the indentures, is bound, if ever he shall be able in his wordly circumstances, either to refund the apprentice-fee, or to teach and maintain, *gratis*, any Apprentice to be named to him by the managers, for the usual time of apprenticeships. The entry of a Member was at first ten shillings sterling, as the *minimum*, besides he was to pay at the rate of one shilling sterling yearly of quarter accounts from the time of his admission ; but lately, the *minimum* of entry was fixed at twenty-one shillings sterling, and all Members admitted before the

of November, seventeen hundred and forty-eight, are excluded from bearing office, or voting in the Society, until they pay down their whole by-gone quarter accounts, or twenty-one shillings sterling for a total exemption thereof, past and to come, excepting such Members who had contributed to the extent of a guinea for the Society's Tenement, and who, on that account, are freed of all quarter accounts. All Members entered from

November, seventeen hundred and forty-eight, are to pay quarter accounts, or ten shillings and sixpence sterling for a total exemption thereof ; but now, as no quarter accounts have been paid these sixteen years past, and as the collecting thereof would be troublesome, it is agreed, that every Member admitted preceding November, seventeen hundred and forty-eight, who has not formerly contributed to the Society's Tenement to the extent of a guinea, unless or until he shall first pay into the Treasurer twenty-one shillings sterling in lieu of quarter accounts past and come, and that every Member entered since the

of November, seventeen hundred and forty-eight, who hath not paid of entry money and for a discharge of quarter accounts to the extent of one pound eleven shillings

and sixpence sterling, shall be disqualified from bearing office, or voting in the Society, until he pay to the Treasurer ten shillings and sixpence sterling in place of all quarter accounts ; and each Member to be hereafter admitted, shall pay to the Treasurer one pound eleven shillings and sixpence sterling as the *minimum* of entry-money, besides one shilling and sixpence to the Clerk, and one shilling sterling to the Officer ; and all quarter accounts by-gone and to come are discharged. That this Society having always considered themselves as under the protection of the Honourable Magistrates of Glasgow, so, by the fundamental constitution thereof it is ENACTED, that if any complaint shall be offered against the Managers, or either of them, for mal-administration or negligence in their office, the Magistrates, Dean of Guild and Deacon Convener of Glasgow for the time, or any three of them, with the Town Clerk, shall be the judges to decide and determine in all such complaints ; and the Society do gratefully acknowledge, that they have, in many instances, received the favourable assistance of the Honourable Magistrates and Council. In particular in the year seventeen hundred and ———, they, by an Act of Council, were pleased to grant to the then Managers and their successors in office, for the use of the Society, a considerable piece of the Town's empty ground adjacent to the said Society's purchase, which greatly encouraged them in building their aforesaid Tenement. That the Society still hopes that their charitable design to promote virtue and industry, and to supply the necessities of the poor of their name, according to the plan abovementioned, will be favourably regarded by the Honourable Magistrates and Town Council, and meet with their approbation. But, as the Society has no legal authority constituting them into a Body Corporate, whereby they may be enabled to receive subscriptions, mortifications, donations and legacies, and levy quarter accounts and entries, and to lend out and gather in the Funds of the Society, for answering the apprentice-fees and other demands, with powers in carrying on and managing the affairs of the Society to the effect foresaid : And, as the Honourable the

Magistrates and Council, in cases of the like nature, have been in use to grant such privileges to other Societies in the place, THEREFORE, BESEECHING the Magistrates and Council to ratify and approve of the Society's scheme of erection, and proceedings thereupon, and to erect, constitute, and appoint them, and their successors in office, and those of the aforesaid name and septs thereof, who have acceded, or shall accede to the said charitable scheme, into a legal Society and Corporation by the name of THE BUCHANAN SOCIETY, and to interpose their authority to the above Articles, Rules and Regulations, with power to the Society to make such other acts which may be judged necessary and advantageous in the further carrying on and managing of the Society, and to lay out the Funds upon interest, recover and levy the same, and to take the rights and securities of lands and other subjects, heritable and moveable, already or hereafter to be mortified, contributed, purchased, or acquired, and of the money to be lent out by the Society in the name of the Preses and Treasurer of the Society for the time being, and their successors in office, for behoof of the Society, and to pursue and defend in all Courts, all actions, causes, processes, and pleas where the Society may have any interest, and otherwise manage the Society's affairs in the same way as any other Society or Incorporation are empowered to do. (*Sic subscribitur*). Robert Buchanan, George Buchanan, Geo. Buchanan, James Buchanan, William Buchanan, Andrew Buchanan, John Buchanan, John Buchanan, jun., as the said Petition and Representation bears. Which being read, heard and considered by the Magistrates and Council, they hereby RATIFY and APPROVE of the above scheme of erection, and of the proceedings thereon; and hereby interpose their authority thereto, and whole Articles, Rules and Regulations abovementioned in relation thereto, and ERECT and CONSTITUTE them into a LEGAL SOCIETY and CORPORATION, by the name of THE BUCHANAN SOCIETY, with powers as above expressed.

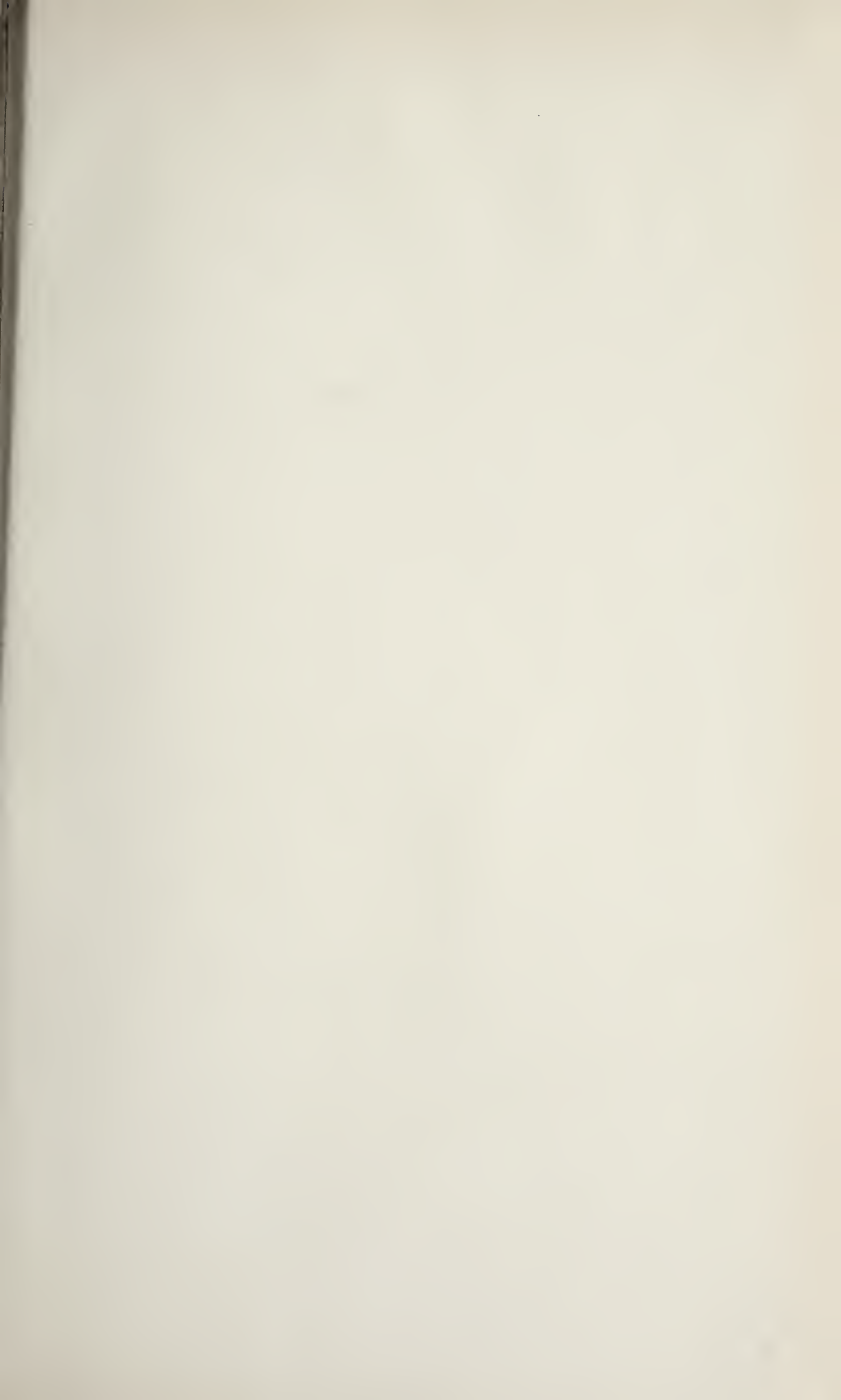

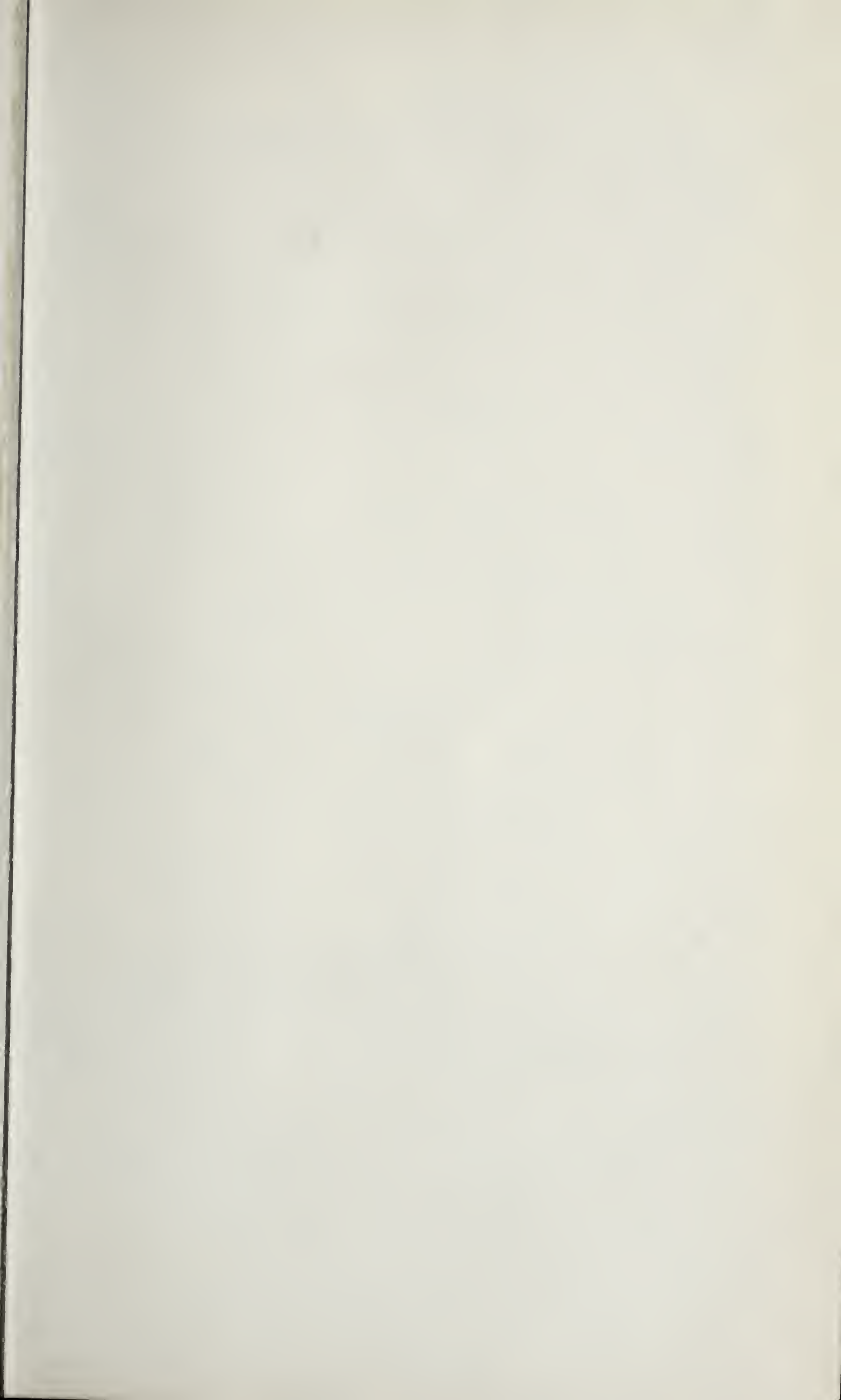

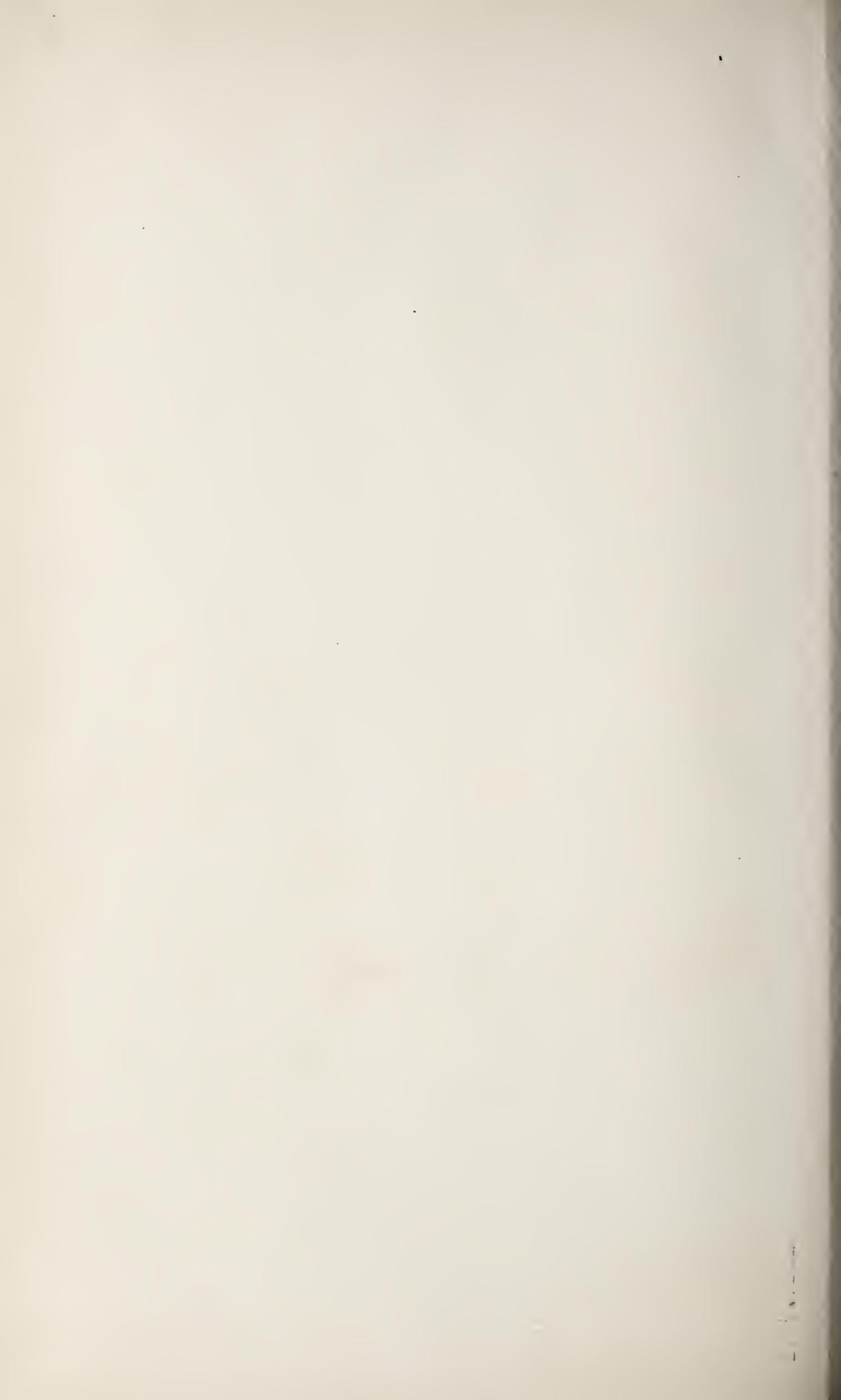
