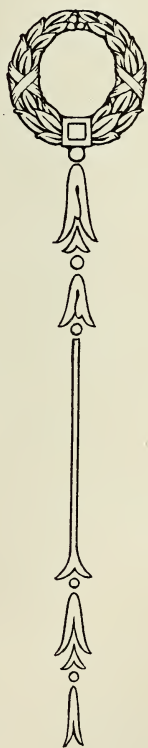

Extracts from private letters regarding  
the great victory at Loos, and the death  
of Captain DONALD GRAHAM, of the Black  
Watch, on the 25th of September, 1915.

---

No. 1.

The 44th Brigade took three lines of German trenches, then Loos, then Hill 70, in four hours—6-30 to 10-30 a.m.—on Saturday, September 25th, and those four Regiments have made an imperishable name for themselves. But at what a cruel cost ! In the attack the 9th Black Watch lost nine officers killed and 11 wounded, only Col. Lloyd and Major Stewart came through untouched—truly by a miracle !

The killed are : Major Henderson, Capts. Bell, D. N. Graham, and Harvey, Lieuts. J. Crichton, J. Henderson-Hamilton, Cameron, Sharp, and J. Millars ; and the wounded Capts. McLeod and Andrew, and Lieuts. A. O. Dennistoun, E. R. Wilson, Glenney, Campbell, R. Stirling, Scott-Pearse, Leslie, Wilson, and Dr. Bearne. The other four (2nd Captains of each Company) by some fortunate chance the General had ordered to be left behind—Capts. Carmichael, Rusk, Norrie-Millar, and

J. L. Wilson; so there are these four, Col. Lloyd and Major Stewart, left.

It has been one of the most glorious things ever done by the British Army.

When the Regiment was gathered after they reached Hill 70, there were only 80 men to come, and six Corporals; not a single Sergeant left; and after, when all were gathered, only 280 of all ranks (officers included). They were under fire, in their trenches—a furious bombardment!—for an hour before the order to charge came (the Germans had got wind of the attack to be made), and when they climbed out of their trenches there was a *hell* of shells and bullets. In the first few yards six officers and 60 men fell, yet nothing stopped them; they dashed straight to the German first line, and the devils kept firing at them all the way; then half the Germans turned and ran, and the rest held up their hands for mercy, but, as Col. Lloyd said, “there was not much mercy left in us by then.”

They chased the remnant through Loos to Hill 70, and their wonderful bravery can never die! The 9th Black Watch and the Seaforths had to take the trenches, and the 9th suffered heavier casualties than any other Regiment, as they were a good way ahead, and into the first-line German trench first. Now the 44th Brigade is back re-organising, and, of course, it is only a glorious remnant; the losses were terrible, practically the whole Regiment. But, never, never did gallant men go to a more glorious death than these.

## No. 2.

Donald was one of those six officers who fell at the outset of that great attack on Loos. He was at the head of his men, and had just led them out of their trench. They had covered about a quarter of the 500 yards which separated their trench from the enemy's, and were lying down to take what cover they could (it seems they always advance like this in short rushes), and he had just turned on his arm to wave his men on, when a bullet struck him in the head. His servant, who was just behind him, ran up, but all was practically over, and he writes that the end was peaceful. The Chaplain, too, has written that his features were calm and peaceful, betokening a painless end. He was buried with five other officers, among them Mr. Henderson-Hamilton and Mr. Crichton, near the place where he fell. He knew the danger of this particular advance so well, but said he felt hard and fit enough to get over the worst wound, and that if he were killed, and it was in doing his duty, it would be well. He did everything he could in his letters to prepare his wife for what might come, but he had no apprehension for himself, and wrote as quietly and calmly as if he had been writing at home, and this is especially the case in his last letter, written the day before he died, and written as it was during that terrific bombardment of French and English guns, which had then lasted for the best part of two days and nights. His letters show that he realized his responsibilities keenly, for he wrote in one of them that as First Captain of A Company he would be over the parapet first, and I believe that he went over just behind Col. Lloyd.

He is gone, the truest, and straightest and bravest; and God grant that the example he has set we may be able to follow.

# Preface.

---

I N compiling the following record of The Firm's contribution to the Great War, we have done all that is in our power to make the record a complete one. We regret, however, that it has not been possible to obtain particulars and photographs in every case; where these have been unobtainable mention has been made of the fact.

No less than 426 members of The Firm answered the call of King and Country, and of these we regret to record that 65 made the Supreme Sacrifice.

In addition to these, 66 others who were either unfit, or unable, to serve actively, joined the Indian Defence Force or some form of part-time service at home.

It has not been possible to include our many Portuguese Operatives who joined the Portuguese Expeditionary Force, as this record is of those who joined the British Forces only. Among the former may be specially mentioned Joaquim Ferreira Da Silva (employed in the Wine Lodge at Oporto), who served in the famous French Foreign Legion throughout the Siege of Verdun.

Of the 10 members of the Graham Family serving, two were killed, one was awarded the Victoria Cross, two others obtained Honours, and three were Mentioned in Despatches.

Among other Partners, two obtained Honours and were Mentioned in Despatches.

Of the Staff, 12 obtained Honours and 9 were Mentioned in Despatches, while of the Glasgow and Manchester Operatives 4 obtained Honours.

A Resumé, showing those who served from Head Office and each Branch, is annexed.

My thanks are particularly due to Mr. H. B. Caw, assisted by Mr. W. Mabon and Mr. W. Dallas in Glasgow, to Mr. Brannigan in Manchester, and Mr. Johnstone in London, all of whom have taken great pains and trouble in assisting me to obtain and compile these records.

I am also indebted to Messrs. Maclure, Macdonald & Co., for the great care and interest displayed in the printing and production of the Book.

# The Hon<sup>ble</sup>. Capt. William L. C. Graham

Capt. W. L. C. Graham was the eldest son of Mr. James N. Graham. He originally joined the 4th (Militia) Battalion Highland Light Infantry in 1896, but on going to India in 1899 he "sent in his papers" and joined the Indian Army Reserve of Officers (Cavalry) in which he rose to the rank of Captain prior to the war.

Captain Graham was mobilised at the outbreak of war, and immediately applied to be sent on active service. His intimate knowledge of shipping, however, made him of such value in Bombay, where the embarkation of most of the Indian troops took place, that the authorities refused to allow him to go and kept him there as D.A.Q.M.G. of Embarkation at Bombay Harbour. His death was due to an accident on board the Hospital Ship "Madras." On 14th July, 1915, Capt. Graham returned from Poona, where he had attended a session of the Legislative Council, and on the same afternoon the Hospital Ship "Madras" arrived with wounded, and as the other officers of the Embarkation Staff were engaged Capt. Graham undertook to go on board and assist in the work of landing the sick and wounded.

As soon as the gangway was lowered he ran up it, tripped at the top, and fell through an open hatchway to the bottom of a coal bunker. As the bunker was empty he fell fully thirty feet before striking the iron floor. His injuries were very serious—a fracture of the left hip and four ribs. Assistance was at once forthcoming, and he was removed to

a vacant berth, but it was soon apparent that there was little chance of his recovery. Hemorrhage set in and he died at a quarter past eight o'clock, Mrs. Graham being with him at the end.

The following message was received by Mrs. Graham from Major Clive Wigram, Assistant Private Secretary to the King-Emperor :—

“ The King and Queen are deeply grieved to hear of the great loss which you and the Army have sustained by the tragic death of your husband in the service of his country. Their Majesties well remember him being in attendance at Delhi as a Scottish Archer, and offer you their true sympathy in your sorrow.”

As Assistant Quarter-master General of the Transport Service Capt. Graham had rendered invaluable aid throughout in organising the embarkation of troops and otherwise for which he had received the thanks of the Government of India.

Prior to the war, in May, 1914, on account of the work and interest he had taken in the Indian Army Reserve of Officers, he was appointed an Honorary Aide-de-camp to H.E. the Viceroy.

He was a member of the King's Bodyguard for Scotland (Scottish Archers), President of the Bank of Bombay, Vice-Chairman of the Bombay Chamber of Commerce, and member of the Legislative Council. When he met his death he was in the fortieth year of his age.

The following “ In Memoriam ” Notice appeared in the Eton College Chronicle of 23rd September, 1915 :—

W. L. C. GRAHAM.

“ Capt. W. L. C. Graham died in Bombay on 14th July, 1915, from an accident on board a ship which he was inspecting as Chief Transport Officer at the Bombay Docks.

William Lochiel Cameron Graham left Miss Evan's in 1895. He never attained the same distinction on the river as other members of his family, largely because he played a great deal of



cricket, not without success, in Second Upper Club; but he was Captain of Aquatics at his Dame's, and rowed in Upper Boats. In the winter of 1894 he was on Field Choices before he got his House Colours, and would probably have got his Field if play had not been interrupted by the great floods; and he was also a member of Sixth Form and Captain of his Dame's.

He showed the same versatility when he joined his family Firm in India in 1899, and in addition to distinguishing himself at polo, pigsticking, and paperchasing, he interested himself wholeheartedly in any public affairs that came within his scope. He was, among other things, Vice-Chairman of the Bombay Chamber of Commerce, Chairman of the Bank of Bombay, and a member of the Legislative Council; but his chief interest was in the Indian Army Reserve of Officers, in the formation of which he exerted himself without much encouragement during the years of peace. When war broke out he offered his services in any capacity, and on account of his long experience of shipping matters he was put in charge of the Bombay Docks, where he met his death. In addition to this work he continued to serve on the Bank and the Council, and was yet able to find time to act as Joint Secretary of the Indian Relief Fund.

In private life Graham more than maintained the tradition of his family for hospitality and generosity, and he has left behind him a notable example of what can be achieved by an Etonian in India."

He went with them to Macedonia in October, 1916, and saw service on that front.

Returning to England in September, 1917, he was stationed at Colchester.

In January, 1918, he joined the Territorial Force Reserve.

## Major C. T. Graham, O.B.E.

1915.—Appointed Captain Indian Army Reserve of Officers and posted to 26th Punjabis Miranshah, Tochi, N.W.P. Proceeded to Mesopotamia with the Regiment and took part in the unsuccessful Kut Relief operations.

1916.—Placed in command of all trans-frontier men withdrawn from Mesopotamia Front. Transferred to East Africa and attached to 40th Pathans as a reinforcement, and served in British East, German East, and Portuguese East Africa.

1917-18.—On return of Indian Troops given a Staff appointment in E.A. and transferred to I.W.T.R.E., and demobilised 24th July, 1919.

Lieut. A. K. Graham joined the Lothians and Border Horse on 26th March, 1915.

He served with them in France from August to December of that year, when his regiment was sent to Salonika.

He left Salonika in January, 1918, to join the Machine Gun Corps (Cavalry) and served in France with the 4th Machine Gun Squadron from August, 1918, to March, 1919.

## Major J. St. J. Graham.

Member of H.M.'s Bodyguard for Scotland (Scottish Archers).

Major J. St. J. Graham, who had previously seen active service in the South African War, rejoined the Lanarkshire Yeomanry in November, 1914, with the rank of Captain.

He was appointed Brigade-Major of the 93rd Infantry Brigade on the 3rd January, 1915. This Brigade subsequently became the 5th Territorial Reserve Brigade, and Major Graham served with it until the 15th February, 1917, when he proceeded to France.

In France he was first attached to the 114th Infantry Brigade, but on the 26th March he was transferred to the Headquarters of the 38th (Welsh) Division.

On the 5th July he was appointed Deputy-Assistant Adjutant General of the 12th Division, and remained with this Division until becoming Deputy-Assistant Adjutant General at General Headquarters on the 29th October, 1918.

He was demobilised on 13th February, 1919.

He was thrice Mentioned in Despatches—in June, 1918; January, 1919; and June, 1919; while in February, 1917, he was brought to the notice of the Secretary of State for War for valuable services rendered in connection with the war.

He was undergoing annual training with his battalion at Tinto, near Lanark, when war broke out, and proceeded in August to Southampton Docks where his company formed part of the Dock Guard during the embarkation of the original Expeditionary Force.

Responding to the War Office request for officers to serve in West Africa he proceeded in June, 1915, to Nigeria, where he served for a year with the 1st Battalion Nigeria Regiment (West African Frontier Force). He returned to the United Kingdom in July, 1916, suffering from malarial fever, and was not passed fit again until the spring of 1917, when he proceeded to France and was attached to the 2nd Highland Light Infantry.

He was wounded in the right thigh on 23rd March, 1918, at Haplincourt, on the Cambrai Front, and was thereafter passed fit for home service only. He was demobilised on 6th February, 1919.

Major Graham joined the 2/9th Argyll and Sutherland Highlanders on the 15th January, 1915, at Dumbarton. He was promoted Lieutenant in October of that year, and was seconded to the Machine Gun Corps on the 22nd June, 1916. After a period of training at Grantham he was posted to the 136th Company, and sailed for Mesopotamia with them on the 18th September, 1916, arriving at Basra on the 14th October. He remained with the 136th Company throughout the advance to Bagdad.

After the fall of Bagdad he was engaged at the battle of Istabulat on the 22nd April, 1917, at which battle he was severely wounded and gained the Victoria Cross.

Lieut. Graham was in command of his section at the time of the engagement, and accompanied his guns across open ground under very heavy rifle and machine gun fire. His men were quickly mown down under the hail of bullets, and in order to keep the guns supplied he personally assisted in carrying the ammunition.

Although twice wounded he continued during the advance to control his guns, and was able with one gun to open an accurate fire on the enemy, who were massing for a counter-attack. This gun was put out of action by the enemy's rifle fire, and he was again wounded. The advancing enemy forced him to retire, but before doing so he further disabled his gun, rendering it useless.

He then brought a Lewis gun into action with excellent effect till all the ammunition was expended, and being again

severely wounded he was forced through loss of blood to retire.

His valour and skilful handling of his guns held up a strong counter-attack which threatened to roll up the left flank of the brigade, and thus averted what might have been a very critical situation. His Captain writes :

"I cannot tell you how proud you should be of Reggie ; he has been braver than words can tell, and when I think of his words some weeks ago—' Harry, I feel I shall be a coward when it comes to the bit '—his actions, I consider, merit the greatest award a soldier can receive. I miss him awfully in the Company as a great friend and a good officer ; but I thank Heaven that he is only wounded, as the Turks gave us ' pure Hell ' while it lasted."

After he recovered sufficiently from his wounds he was sent to India on sick leave, and joined the M.G.C. Depot at Mhow (Central India) in July, 1917.

He was posted to the 256th Company Machine Gun Corps as second in command in September, and was gazetted Captain in the 9th Argyll and Sutherland Highlanders in October, which gazette was subsequently antedated to 13th July, 1916.

He returned to Mesopotamia with the 256th Company in October, 1917, and proceeded with them up to Bagdad and Felinja, where he was ordered to rejoin his old Company (136th) as second in command with the rank of Major. He rejoined the 136th at Basra and sailed with them for Egypt on the 1st January, 1918. He was posted to the Command of the 272nd Company on 27th March, proceeded up to Palestine 29th March, and transferred to the Command of the 136th Company in April.

He obtained leave home in October, and was demobilised on 11th January, 1919.

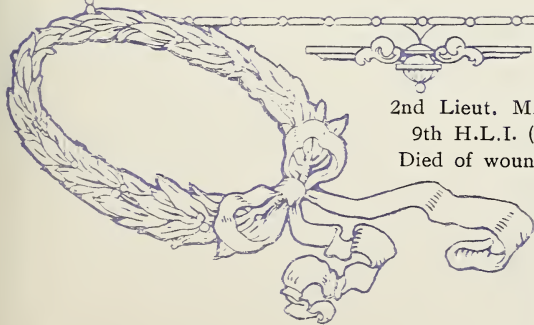

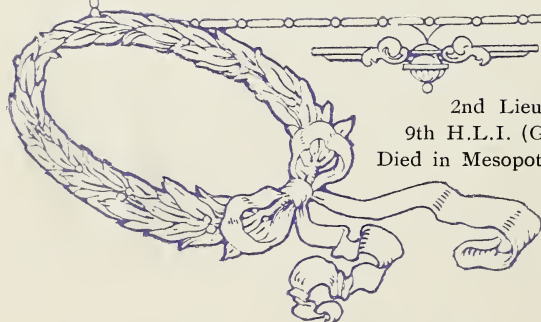

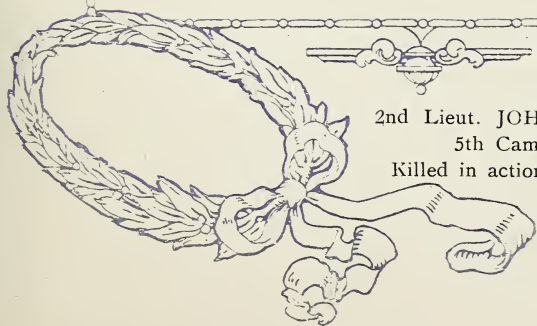
The following appeared in the "Glasgow Herald" in connection therewith:—

When his left flank became exposed and enfiladed from the rear he turned a party about, destroying an enemy machine gun and forcing them to retire. He was the first man to reach the objective, and then moved across a gap to left under heavy fire to gain touch with the next unit. He set a fine example throughout."

The following is an extract from a letter received from Lt.-Col. Hugh B. Spens, commanding his battalion:—

"He was one of my very best officers and had done magnificently ever since he came to us. He began by escaping from the Germans when taken prisoner owing to his coolness and courage. He was wonderfully gallant when he won the Military Cross, and he was always the same. He has done splendidly in all the recent fighting, which has been one long record of success for the battalion. He was, too, such a lovable character and every one was so fond of him. His men worshipped him, and he could not do enough for them."

On recovery he proceeded to Palestine and took part in operations there from August, 1916, to 28th November, 1917, on which latter date he was wounded within sight of Jerusalem. On 2nd October, 1918, he was attached to the Portuguese Expeditionary Force as interpreter, first at Horsham and then at Ambleteuse and Calais.

He gained the Military Cross in the advance from Fricourt to Mametz, July, 1916, and was killed in action at the Battle of the Somme, near Longueval, 8th August, 1916.

## 2nd Lieut. Alfred Chegwin Flower.

4th Battalion Grenadier Guards.

2nd Lieut. Alfred Chegwin Flower, 4th Battalion Grenadier Guards, was the son of the Rev. and Mrs. F. W. Flower of Villa Nova de Gaya, near Oporto, Portugal. Born in Oporto, 1890, he was educated at the Oporto British School, and at Richmond Hill School, Surrey. Returning to England in 1915, he joined the Artists' Rifles O.T.C. on 10th September and obtained a Commission in the Grenadier Guards on 3rd January, 1916. He served with the Expeditionary Force in France from 8th July, 1916, and was killed in action near Ginchy on 25th September of that year, during the Battle of the Somme.

Lieut.-Col. Lord Henry Seymour wrote :—

“Your son was killed leading his men in an attack on a German line of trenches. It was entirely successful”; adding, “He led his men most gallantly.”

Lieut. Burman wrote :—

“Your son was considered by his brother officers and the men (and especially do I say the men, for their opinion always counts for more, and they seldom make a mistake) as a very gallant officer indeed, and I personally miss him more than any of the others, most of whom had been in the battalion for some time. I could not help becoming very fond of him, as did everyone who knew him. He was liked and admired by all.”

The Chaplain also wrote :—

“It was my sad privilege to take the funeral service a short way behind the spot where he fell. The action of the 25th should thrill historians of the future. It was magnificent the way the battalion faced their task and won their way.”

He again went to France in the Spring of 1917 and served with the Machine Gun Battalion of the 9th (Scottish) Division, taking part with it in all the hard fighting which won for that Division special and distinguished mention. Early in 1918 he was made second in command of his battalion, and promoted to the acting rank of Major. For his gallantry and resource on Mount Kemmel on April 25th he was awarded the Military Cross, having, when surrounded, cut his way out with a handful of men, and subsequently organised and successfully defended another position. He was killed by an aeroplane bomb on 13th July, 1918.

Of him his Colonel wrote :—

“ As an officer and a friend he could not be surpassed. He possessed in the highest degree all those qualities which made him loved by everyone both above and below him.”

## 2nd Lieut. F. G. Scott, M.M.

2nd Lieut. William Hope Davison, born at Portobello, Scotland, on November 10th, 1884. Eldest son of Rev. W. Hope and Mrs. Davison. Died at Murree Military Hospital, Punjab, India. Educated at George Watson's College (1894-1901), Edinburgh.

Assistant at Messrs. Wm. Graham & Co., Manchester, from 1902 to 1910, and thereafter at Calcutta.

Joined the Calcutta Light Horse as trooper in 1913. Commissioned, March, 1917, and posted to 2/32nd Sikh Pioneers, after having trained at Amballa and Rawal Pindi. In August of that year he was ordered to proceed with a party to Murree to survey and report on a new road. Marching through Monsoon rain for three days, he caught a severe chill and was conveyed to Murree Military Hospital, suffering from an attack of enteric fever.

He died, after an illness of three weeks, on September 6th, 1917, and was buried the following day in the new Military Cemetery at Murree.

No portrait of him in his officer's uniform is extant. The only available photo, taken in 1914, represents him in the uniform of a trooper of the Calcutta Light Horse.

In the spring of 1916, after a course of instruction in an Artillery School in France, he was attached to a Trench Mortar Battery.

His Colonel testified to his pluckiness and zeal. His Captain reported :—"We have never had a more hard-working and competent Platoon Commander." More than one officer said that he would have been decorated had he lived through his first great battle. On 11th July, 1916, fighting his gun to the last, he had his leg shattered by a shell. Weakened by loss of blood he sank under chloroform in hospital during the night.

## 2nd Lieut. Eric Tomlinson Martin.

Duke of Cornwall's Light Infantry.

2nd Lieut. Martin, Indents Department. Joined one of the battalions of the London Regiment at the outbreak of war. He went through the usual training, and was then granted a Commission in the Duke of Cornwall's Light Infantry. After a further period of training, mainly at Wareham, he was attached for Active Service to the 8th King's Own Yorkshire Light Infantry.

In the attack on Le Sars (south-west of Bapaume), on the morning of October 1st, 1916, he was about to lead his platoon into action when he was killed by a shell. His Colonel wrote that he was very popular in the Battalion, and showed great promise. "You will be glad to know that, had he lived, he would undoubtedly have quickly earned promotion. He was an entirely reliable officer."

Rifleman Owen Geoffrey Newmarch, Typist Department (who before the War was in the ranks of the London Rifle Brigade), joined the Rifle Brigade at the outbreak of war. In October, 1914, he was engaged on coast defence in the Isle of Sheppey, whence he proceeded to France in February, 1915, with the 2nd Battalion of his regiment. From Havre his regiment was despatched to the Front as reinforcements just after the Battle of Neuve Chapelle. At dawn on Sunday, the 9th May, the 2nd Rifle Brigade, together with the Irish Rifles, attacked the German trenches at Fromilles, near Festubert. They captured and went beyond the first enemy position, but could not maintain their ground owing to heavy casualties, and as the Germans had advanced on both flanks, they had to fall back over open ground and under very heavy fire. Only 150 out of 1100 men of the 2nd Rifle Brigade got back to the British lines. The last that was known of Rifleman Newmarch was that he and half-a-dozen others reached, and attempted to fortify, a small building—their objective—but none of these men survived, and nothing was ever ascertained as to the manner of their death. The Corporal who led the men was severely wounded outside the building, and can give no further particulars beyond the above account.
